MEMORANDUM

From: Commanding Officer, Naval Photographic Center
To: Supervisor, White House Photographic Laboratory

Subj: White House photographic work request

1. Recently a photographic work request from the White House Photographic Laboratory was returned uncompleted because of critical shortage of funds and non-availability of the majority of the sensitized material required to complete the job within the deadline specified.
2. Because of a severe curtailment of this command's operating funds for photographic consumables, and the increased work load from Southeast Asia, it has not been possible to maintain appropriate levels of supplies. This command had none of the paper required to print the requested black and white photographs and was at a minimum level on the color paper required for the request; therefore, it was not possible to complete the project within the desired deadline. In returning the request uncompleted, it was presumed that another photographic facility, capable of meeting the delivery date, would be tasked with the project.
3. When the White House Photographic Laboratory was established, funds were no longer requested for the accomplishment of White House still photography, as it was understood from information supplied by the Naval Assistant to White House Military Aide that there would no longer be a requirement for still photographic services. In addition, secure photographic spaces were reassigned, and four photographers were transferred to the White House Laboratory.
4. It is requested that this command be advised if still photographic support of the White House is to be a continuing requirement in order that special photographic space be reestablished and staffed and funds be budgeted in the future.

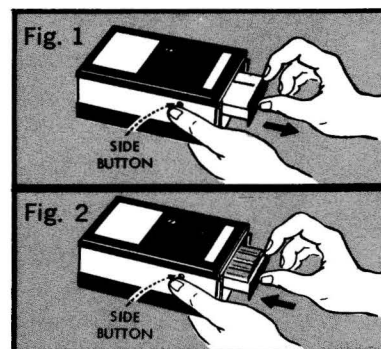

1. Pull out battery case (bottom part of recorder) by depressing the side button (Fig. 1).

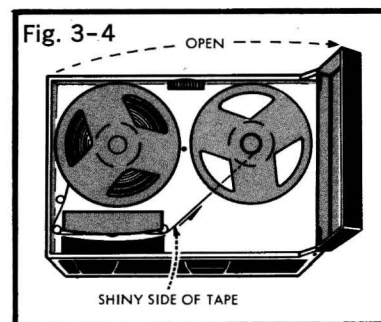

TAPE THREADING

Open the recorder case by lifting the hinged cover (Fig. 3).

Place full reel of tape on left spindle, making sure that the shiny side of the tape is facing towards you. Unwind approximately 12 inches of tape from the full reel and thread the tape through the Erasing Head, Recording Head, and Tape Guide into the slit in the empty reel. (Fig. 4).



TO RECORD

1. Insert Microphone plug into socket marked MIC.

2. Set both Speed knob and Volume Control midway to yellow. Both the Volume and Speed Controls are color-calibrated from low to high with white at L, green at low-medium, yellow at medium, and red at H.
3. Set Play/Record switch to Record, Rewind/Forward Switch to Forward, and On/Stop switch to On. When the reels begin to turn, start recording. Hold the Microphone 6-8 inches from the mouth.
4. When recording is completed, set On/Stop switch to Stop.

TO REWIND

1. Set Play/Record switch to Play, the Rewind/Forward switch to Rewind and On/Stop switch to On.

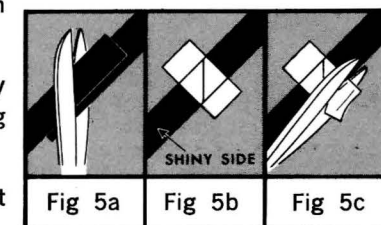

If you desire to erase a tape without recording, follow instructions under "To Record", without connecting the microphone.

TAPE SPLICING

1. Fig 5a—Overlap broken ends with shiny side up and cut diagonally.
2. Fig 5b—Match both ends with shiny side facing up, then apply splicing tape on shiny side.
3. Fig 5c—Trim excess tape. Do not put tape on dull side.



OPERATING HINTS

1. The batteries must be changed when the speed control is regulated with no resulting change in the speed of the tape movement.
2. It is a good practice to clean the tape-heads occasionally with "Tape Head Cleaner" available at your dealer.
3. For private listening, or to monitor the recording, plug the earphone into the socket marked ear. The speaker is automatically disconnected.
