Biographical sketch:

Sherwin J. Markman was a lawyer who was originally from Des Moines, Iowa. He served as director of the Congressional Liaison Office at the Agency for International Development (AID), and as an assistant to President Lyndon B. Johnson where he worked primarily under Marvin Watson as a congressional liaison to the House of Representatives.

Scope and content note:

This collection consists of five series of records created by Sherwin J. Markman in his capacity as a lawyer in Iowa, as the deputy director of the Congressional Liaison Office at the Agency for International Development, and as special assistant to President Lyndon B. Johnson.

The "Telephone Logs" track who Markman spoke with on the telephone, and include some notes.

The "Agency for International Development Files" are materials that document Markman's activities at AID including travel agency organization.

The "Aide to The President Files" contain materials on trips to inner cities to investigate race relations, the presidential primaries of the Election of 1968, and Presidential travel.

The "Personal Files" contain correspondence between Sherwin Markman and his family members and work associates and include materials on Markman's work for organizations outside of the Federal Government.
