The Meaning of Political Murder

Charles Frankel

"We try to make the public world orderly," writes a philosopher in response to the killing of Robert Kennedy, "and then wildness breaks out, sheer, private, dreaming malice, which cuts across everyone's hopes and cuts them down."

KNEW Robert Kennedy, not intimately but well enough to know the fire of life that was inside him. One felt it immediately. It was tamped down and under control, but it was there as palpably as a bed of coals in a fireplace. He wanted to live with a purpose; he expected that others did too. This was why, whether people liked him or disliked him, it was impossible to feel impersonally about him. And it is one of the reasons his murder hurts so: it seems so impersonal, so purposeless.

What are its implications? At the very least we have lost a man who had qualities that we do not have enough of, either in public life or in our culture at large.

Charles Frankel, an SR editor-at-large, served until recently as Assistant Secretary of State for Educational and Cultural Affairs. He is on leave from his position as professor of philosophy at Columbia.

Robert Kennedy had a kind of austere passion, a sense of focus and concentration, that is rare and valuable. There was an impatience in him, despite all his awareness of the slow, foolish realities of politics and human nature. He hated to think that there was misery in the world that didn't have to exist. He disliked inefficiency, pomposity, the fraudulent or the wasteful in talk or thought or action, because he knew the cost of doing things badly. He was disciplined and enduring himself, and he admired disciplined and enduring people. I think this was why he was drawn to athletes, to good writers, to sharp minds, to people who saw what had to be done and did it. He might have made a difference in our national style and the virtues we most admire.


Yet for me these were not his most striking traits. His most remarkable, I thought, were his way of putting his

mind forth toward you when you had something important to say, and his ability to imagine other people's worlds. He was one of a relatively small number of people whom I have met in public life who really listen, and he wanted to hear, and went out of his way to hear, what he hadn't heard before. I think it was this, and not his looks or his youth or his name, that got across to the people in the ghettos and explains their feeling about him. And the deepest political implications of his death, it seems to me, lie not in its effect upon the campaign, but in what it will mean to have this man with his special capacity to listen and to respond removed from the scene.

It has been the special quality of deafness in most of our national leaders—the stilted expression of good intentions with which they have responded to shrieks of pain—which explains the awful sense of frustration that has been eating

away at our national vitals. There has been an institutionalized, self-reinforcing deafness in the workings of our political system for the people who have been left out of our society, Robert Kennedy's death will mean that, after having found someone who apparently could hear, they must return to shouting into deaf ears. Robert Kennedy's campaign, simply his presence on the scene, gave hope that somehow men in this society might find a way to talk to one another again. That hope has received an awful blow.

Those decisions and actions this summer by our political parties which suggest a willingness to turn away from the old political voices and the old, customary political routines can make the outlook a little less somber. But it is going to take qualities in our political leaders and in their constituencies which have not been excessively conspicuous up to this time. Not many political leaders have shown that they realize that this country is in the deepest trouble it has known in a century. Most of them have gone on maneuvering for advantage in an old game whose rules are collapsing.

YET the weightiest implication of this horrible event transcends partisanship. It shakes everyone, supporters or not. Its most important meaning, it seems to me, is that, although it is full of consequences, it has no saving meaning. Thinking about it is hard because there is something irreducibly unthinkable about it. It was an event that didn't have to be; it was gratuitous and, in historical terms, madly accidental. If Kennedy had died of a heart attack, grief would be mixed with resignation. But this was an event that had the idiotic irrelevance of a natural disaster, and yet was a human deed, an intended premeditated act. And the same thing happened to his brother.

It is too much, a storekeeper in my town said to me. He didn't say it wearily, as though he couldn't take any more, but anesthetically, as though it had moved him past caring. This assassination, after all that has preceded it, after all that has happened to the Kennedys, can make us feel not personal helplessness and defeat but the collective helplessness of all of us. In the first moments and days after the news came, it must have made countless people feel that there is nothing to count on, nothing secure enough to make anything difficult worth doing.

If this civilization has had any things to be proud of, any things to lean on and hope that it could live by, they would be, I think, its free universities, its ability to organize voluntary, collective actions, and its electoral process. During the past two months I have seen the university where I have spent most of my life

tremble as though from an earthquake. The leader of an extraordinary popular movement, Martin Luther King, was killed. And along with millions of my fellow citizens, I have lost a Presidential candidate. We lay plans, we hope in some systematic way to deal with our collective problems, we try to make the public world orderly, and then wildness breaks out, sheer, private, dreaming malice, which cuts across everyone's hopes and cuts them down.

It is too much, and so the impulse is to try to make it something that one can absorb. That is the impulse, I think, behind the search for a conspiracy, and behind the lectures we are giving ourselves about our violence. Perhaps there is a conspiracy; it looks unlikely, but I don't know. Certainly it would be consoling if there were. It would give us something to strike back at. It would make the cause fit the effect, it would give us a motive appropriate to the crime.

Blaming what has happened on the violence in America helps in the same way. We do have stupefying violence in this country. It is a routine of daily life. People make money out of it; people make a science out of it; a very large number of people are entertained by it. Violence is glorified on the right and the left as the only honest and efficient political technique, and though our government issues pronunciamentos about the evils of violence, it has undermined its influence by using violence massively in a prolonged war in which a good part of the country does not believe.

HE violence in the air today increases the likelihood that violent people, who are around in the best of times and places, will be still further inflamed. Undoubtedly, too, the murder of John Kennedy increased the likelihood of an attempt against Robert Kennedy; as he himself knew, it was bound to put thoughts into suggestible minds. There are certain kinds of public figures -John Kennedy, Martin Luther King, Robert Kennedy-who are more probable targets than others for murderous feelings. They have a kind of inner invulnerability about them-something, whether it is their bearing or supreme good fortune or special lucidity, that gives the sense that they cannot really be pierced or hurt. Envy reaches out to pull them down. So there are causes, a pattern of explanation, that can be offered for Robert Kennedy's murder, and the violence in America is part of the



story. But it is only a part, and we cannot even say that it was a necessary part. The murder itself might have happened anyway. For in the end, Robert Kennedy was killed, it appears, not by an American but by a Jordanian, and not for what he stood for in this country but for what he stood for, in one man's odd, unaccountable mind, in the Middle East, The murder could have happened in a tranquil America.

LANGUAGE that says too much, indignation that finds no target and spills all over the landscape raise people's tempers and add to the climate of anxiety and violence. Grieved and angered, Arthur Miller has said that we are a violent people and that the violence reflects a great deal more: "It is murderous," he said, "to tell a man he cannot live where he wishes to live." No, it is indecent, unjust, and irrational. But murder is what happened to Robert Kennedy and that is different and deserves a different feeling and invites a different analysis. When words lose their meaning, actions lose their true proportions. If everybody is so wicked, a little murder is only a little bit worse. And if everybody is implicated in a web of collective guilt, the distinction fades between one man's honest effort and another man's malingering.

A simple truth dominates the future, I believe, so far as political murder is concerned: the fewer murders there are, the fewer murders there will be. We can do something to reverse the present process by bringing people's tempers down in this country, by reducing the self-righteousness and intransigence of political controversy, and simply by lowering the level of Overspeak. A great deal could also be done by ending the war in Vietnam. It would be a first useful step in the longer campaign against the tendencies in America that justify or encourage violence. And just possibly the collective helplessness we now feel in the face of what has happened may sharpen our recognition that when madness is abroad in the world temperate men ought to moderate their quarrels.

And yet, in the end, we are just going to have to live with what has happened. No matter how we turn this event around to look at it and extract a moral from it. there remains in it an element of irreducible randomness, of simple, unacceptable terrible bad luck. Our spirits will revive, people will go to work again, we shall start living once more for our hopes. That is the nature of the animal. But the event is there, and no explanation can change the fact that we are faced by the inane, brutish thing that did not have to happen, and did, and is irreversible. We are going to have to live with this frustration for which there is no full relief, and with this grief for which there is no complete solace.

Jim Kirkham and I met yesterday with Mr. Wesley McCune of Group Research, Inc., and Mr. Charles Baker of the Institute for American Democracy. Both institutions are located in Washington, D. C.

Baker and McCune said that they had files on right wing extremist groups, including literature and radio broadcasts of such groups. They also said they had a limited amount of material on left wing groups.

Baker mentioned that the FBI had made a study of right wing groups. Baker said he thought that it would be difficult for us to find right wing groups who would explicitly articulate favorable views toward violence. He said there might be some material put out by right wing groups indicating satisfaction at the death of Robert Kennedy or Martin Luther King. Baker said that he would obtain this material for us and forward it to us.

Wednesday night (July 17) our office was broken into, burglarized and vandalized. Among the items taken - a strange selection - were several hundred political and peace buttons, the contents of two file drawers, over \$100 worth of peace jewelry, about 75 copies of the Surgeon General's Medical Fitness Standards, 33 copies of a book on the draft and stationary and envelopes. (We are very concerned about the stationary, because some people and groups have sent vicious communications to the families of Vietnam War casualties that purport to be from peace groups. Women Strike for Peace has great sympathy and compassion for these families and would never engage in such unforgivable behavior.) Tubes of mimeograph ink were emptied into drawers, desks, file cabinets, equipment, and all over the bathroom. Our adding machine was smashed to the floor. Enough ink was dumped into our mimeograph to render it completely useless.

At about 3 PM yesterday (the day after) a man telephoned our office and said: "How did you like your office this morning?" When asked who he was, he replied: "I'm from the 'Americans for Counter-Revolutionary Action.' I tried to hold the guys back last night, but couldn't. If you keep up your work, we're going to keep coming back." When asked again who he was, he hung up, saying: "I better hang up now because this call could be traced."

Women Strike for Peace is exactly what its name implies - a group made up exclusively of women. We want to know more about these "brave" men who hide behind the "curtain" of violence and death threats and call themselves "Americans for Counter-Revolutionary Action". They are cowards who are afraid to come out into the open. We hope that some citizens who know about these people will come forward and tell us or the proper authorities about this group and name the men who are in it. We believe that these are the people who gained the most from and were possibly responsible for the assassinations of John F. Kennedy, Martin Luther King and Robert F. Kennedy. These are the same people who hate others because of their race, color or religion. This is not the first time that peace or civil rights groups have been violently attacked. It's part of a pattern - and has gone on for years.

We want the "Americans for Counter-Revolutionary Action" and their fellow travelers to know that we will not be silenced by this or any other acts of force and violence in the future. We will not be intimidated. Our record speaks to this. Some of our leaders - Dagmar Wilson, Mary Clarke, Gail Eaby have received letters threatening their lives. A handbill was circulated on July 10, 1968, with Dagmar's and Mary's names included in a list of 100 people selected to be killed. The Yankee Crier, with the slogans "Remember Pearl Harbor" and "Remember the Pueblo" on its three pages, called the 100 the "Benedict Arnold Brigade". It states: "The ultimate penalty for treason is death! The grave is final. To live as a traitor is worse than the grave. A nation may forget her patriots, but never her traitors!! Many of you have been convicted as traitors to your country. None shall escape!" Other names included in the list are Dr. Benjamin Spock, David Schoenbrun, Les Crane, Marlon Brando, Bishop Pike, Dore Schary, Richard Calderon and A.L. Wirin. The Yankee Crier is published by "The Fourth of July Movement" - are these the nameless, faceless, anonymous assassins of our land? We have sent a copy of these death threats to the California Attorney General's office,







Right-wing fights name change for HUAC

A bill to change the status and name of the House Un-American Activities Committee, introduced by one of its members—Richard Ichord (D-Mo.)— has stirred a barrage of protest from the Committee's admirers among the radical right. For instance, the July issue of Robert Welch's Bulletin to Birchers carries a three-page appeal to help kill the bill (H.R. 148), arguing that seniority might be affected and that the new investigative unit might become a mere House Internal Security Subcommittee, giving it the acronym of HISS!

The Birch appeal included a Dallas News article picturing HUAC member Joe Pool, who represented a Dallas district until his recent death, claiming that the name change would knock Pool off the Committee, to the delight of the left wing. Also, Congressman Pool appeared on the radio-tv program of Clarence Manion, a Birch Council member, to oppose the name change only a few days before his death.

Organization notes:

- Minutemen and their trade mark continue to show up in widely scattered places, though Minuteman leader Robert DePugh is still the object of a widespread FBI hunt. One of his members, Robert R. Romero, was arrested recently in Van Nuys, California, after firemen answering a call at his home found a large cache of arms. Romero had previously been arrested for illegal possession of firearms and had been the partner of another Minuteman, Keith D. Gilbert, in an explosives store before the latter was convicted of stealing explosives.
- A secret report on the activities of the Mississippi State Sovereignty Commission, supported by state funds, has been described by the New York Times (July 29) as showing a large amount of active resistance to civil rights movements during the past four years. The alignment was no surprise—the Commission gave large amounts to the lobby against the civil rights bill of 1963—but the extent of its local resistance had not been made public.
- Changes in the Citizens Foreign Aid Committee, the long-time lobby against foreign aid, continue to unfold. (pp. 32, 37 & 47) It has now been disclosed that Theodore M. Cormaney, the YAF leader who came from Wisconsin to operate the youthful take-over of the group, is also Executive Director of the National Federation of Young Republicans.
- Attention has been focused on the little-known Christians and Jews for Law and Morality by a front-page story in twin circle, the conservative Catholic weekly, that the group gave its annual award to Danny Thomas, the entertainer. The article also mentioned that patrons of the organization include Patrick J. Frawley, best known as head of the Schick Razor enterprise and contributor to numerous conservative causes (such as being the parent company of twin circle). The organization was started last year by Marion Miller, an ex-FBI informant who is Executive Secretary; John T. La-Follette, a former Schick executive; and two top officials of Freedoms Foundation at Valley Forge (Jerome Haggerty and Don Belding), one of whom succeeded Schick boss Patrick J. Frawley in that position.
- Youth for Conservative Action, patterned after the John Birch Society, has been organized in the Waterloo-Cedar Falls area of Iowa for 14 to 21 year olds.

Mr. VANIK. Mr. Speaker, the National Committee for Civic Responsibility, a nonpartisan organization actively led by some of the most articulate citizens of Cleveland has prepared a report on a book entitled "None Dare Call It Treason." The National Committee for Civic Responsibility is headed by Mr. Thomas C. Westropp, executive director of the Women's Federal Savings & Loan Association of this city, Mr. Westropp also serves as the first vice commander of the 13th District of Ohio American Legion. By its code of regulations, this organization is prohibited from taking a partisan position on any public issue except in instances where violence is advocated or practiced or where calumnythe malicious use of falsehood-is used to intimidate or discredit. The National Committee for Civic Responsibility has issued several reports and they have received extensive support and encouragement from the newspaper media in the Cleveland community.

Following is the official report of the National Committee for Civic Responsibility on "None Dare Call It Treason," which I recommend and bring to the attention of the distinguished Members of this body:

NONE DARE CALL IT TREASON

- 1. This seems to be the only publication of Liberty Bell Press. Florissant, Mo., listed as the address of Liberty Bell Press, is a suburb of St. Louis, Mo. There is no telephone listed to Liberty Bell Press in Florissant and none in the Greater St. Louis area.
- 2. The listed price of this book is 75 cents, but it is being distributed in Cleveland at prices ranging from \$1 to free by such rightwing organizations and their representatives

as the John Birch Society and the Organization To Fight Communism, Inc. Booksellers in Cleveland receive their copies from Klein News, a large distributing company. Klein News receives its supply from William Shepler, area coordinator of and public spokesman for the John Birch Society in Cleveland. Klein News pays 20 cents a copy with the unlimited right to return all unsold copies. Both the price and the arrangement are much more favorable than normal practice. From an article in the New York Times on July 23, 1964, it would seem that the distribution of this book is a John Birch Society project in other parts of the country as well.

3. Since this book contains 818 references supposedly substantiating the material contained therein, it gives the appearance of being the well-documented study which it claims to be. Nothing could be further from the truth.

Stormer relies heavily for his documentation on the Congressional Record and upon testimony given before committees of the Congress but in most instances he fails to give the name of the person whose testimony he relies upon or the name of the person who inserted the material into the

Since the CONGRESSIONAL RECORD contains material on every conceivable side of every issue along with much extraneous material, and since hearings before congressional committees contain testimony from many unreliable sources, including Communists, it is necessary to know just who is saying what if one is to properly make an evaluation. Stormer seldom provides this information in his documentation.

4. If the reader does not understand the nature of the Congressional Record and if he cannot differentiate between testimony before congressional committees and the findings of those committees and so is led to believe that such "documentation" is in any way official or necessarily factual, the fault is not entirely Stormer's.

5. But the reader has a right to expect that references set forth by Stormer as documentation will at least say what Stormer claims for it. In case after case, the author has subverted those references to give a totally erroneous impression and even to say pre-

cisely the opposite of what his own reference claims.

6. Some examples:

A. Stormer, pages 169 and 170: "This became sharply clear in an article by Arthur Schlesinger, Jr., Assistant to President Kennedy, which set forth the plan for achieving socialism in America" (Congressional Record, February 6, 1962, p. A881). Schlesinger outlines no such plan; in fact, Schlesinger's remarks, inserted in the Record by Representative Charles E. Goodell, of New York, February 6, 1962, pages A881-A884, said precisely the opposite:

Page A881: "The socialist state is thus worse than the capitalist state because it is more inclusive in its coverage and more unlimited in its power. Organization corrupts; total organization corrupts totally. The socialist state justifies itself on the ground that the concentration of power is necessary to do good; but it has never solved the problem of how you insure that power bestowed to do good will not be employed to do harm, especially when you remove all obstacles to its exercise."

Page A882: "The more varieties of ownership the better; liberty gets more fresh air and sunlight through the interstices of a diversified society than through the close-knit grip of collectivism. The recipe for retaining liberty is not nationalization but muddling through."

B. Stormer, page 29, paragraph 2: "In 1943, congressional investigations later revealed, before the United States had itself assembled the first atomic bomb, half of all American uranium and the technical information needed to construct a bomb were sent to Russia. Is it any wonder that the Communists became a nuclear power years ahead of expectations? (Hearings, Shipment of Atomic Material to U.S.S.R. HCUA, 81st Cong., p. 1156.) The testimony referred to was given by Maj. George Racey Jordan who wrote several books making sensational charges but whose accounts varied so much from time to time that his charges have been discredited (see Time magazine, Dec. 12, 1949; Newsweek, Dec. 19, 1949). Nowhere in this reference does Major Jordan or anyone else refer to "technical information needed to construct a bomb" being sent to Russia, nor is any mention even made about

any atomic bomb information. Major Jordan does discuss shipment of radioactive material on pages 1156 and 1157 of the hearings. Quoted from page 1157 is the following response by Major Jordan to a question from Mr. Tavenner, counsel for the Committee on Un-American Activities:

"Mr. Tavenner, I was very embarrassed when I found you only located 45 pounds of uranium when the papers I had called for 500 pounds. So I listened to General Groves' testimony, and I understand that while they asked for 500 pounds they were only able to locate 45. So when I testified in perfectly good faith they got 500 pounds, I thought they did, but it turned out they only filled that particular order to the extent of 45 pounds. I took it from the papers.

"When I talked of heavy water (an alternative method of making nuclear devices), I saw 'heavy water' on the papers. I have since been told there was none in the United States, and that what I thought was heavy water was sulfuric acid. I was being perfectly honest."

It is on the basis of such testimony that Mr. Stormer would have the reader believe that congressional investigations revealed the shipment to Russia of one-half the U.S. stockplie of uranium and the technical assistance to construct an atomic bomb. The congressional investigation revealed nothing of the sort, nor was there even such testimony. What the investigation did reveal was that, at best, Jordan's testimony was unreliable and Stormer's attempt to pass this testimony off as committee findings puts his writing in the same category.

C. Stormer, page 29, paragraph 4: "In actual conduct of the war, military decisions were made, not according to the tactical needs of the day, but for the long range political advantage of the Communist conspiracy (Roosevelt and Hopkins, Sherwood, p. 590)."

Page 590 of Sherwood's book contains nothing whatever to support this charge, nor is any mention made of such a happening. Page 591 says the following:

"It has often been said that Churchill's advocacy of the 'soft underbelly' approach to Europe demonstrated his farsightednessthat he was motivated by the long range purpose of keeping the Red Army out of the Danube Valley and the Balkans. In the opinion of some of the American authorities who were involved in the strategic discussions. this claim gave Churchill credit for too much prescience. He may have had such thoughts in mind in 1944, but certainly not in 1942; and one may ask, in this connection: if Anglo-American strength had been concentrated in southern and southeastern Europe, what would have stopped the Russians from marching into the Ruhr and Saar and even into Normandy? The American Chiefs of Staff believed that Churchill's strategic concepts were much more easily explained: he had an incurable predilection for 'eccentric operations' which had guided him in the First as well as the Second World War; he preferred operations which depended on surprise, deception and speed in terrain (for example, the Balkan valleys) where there was not sufficient room for huge ground forces to be deployed."

Again Stormer's "documentation" does not support his assertion and seems in fact, to be saying quite the reverse of Stormer's allegation.

D. Stormer, page 126, paragraphs 2, 3: "Among his (Dr. Harry F. Ward) closest associates and most devoted pupils in the religious field were such conspirators as Rev. Jack McMichael, Rev. Chas. Webber, Rev. Alanson Smith, Dr. Willard Uphaus and Rev. Lee Ball. The controversial Methodist bishop, G. Bromley Oxnam, was Ward's pupil, secretary, and one-time apologist."

The references to and activities of the several named ministers are in the process of being checked with the proper authorities and will be added to this report immediately upon receipt of the necessary information. But Stormer's references to G. Bromley Oxnam is an excellent example of pulling a reference out of context in order to twist it to the opposite meaning. Stormer is, of course, implying that Oxnam is pro-Communist but the very reference which Stormer gives (hearings, HCUA, July 21, 1952, p. 3725; actually, the correct date is July 21, 1953) makes it quite clear that such a linking of Oxnam to Ward and so to communism is unjustified if not downright dishonest. The testimony cited is as follows:

Question: "Is he (Ward) a good friend of yours?"

Oxnam: "I will have to answer that by telling you when he was and what my relationship is with him now."

Question: "Well, please do that."

Oxnam: "Professor Ward came to the Boston School of Theology, I believe, in 1914. I was a student. He was a brilliant teacher. He was an inspirational personality. He made an extraordinary contribution to the students of that institution. I was very, very fond of him. I took dictation from him as a part-time secretary in the dictation of one of his books. I knew his family. Professor Ward was a leader in the social movement of the Methodist church and over a long period of time rendered, I believe, very valuable service.

"There came a time in my mind when I believed that Professor Ward had shifted his views concerning the whole Communist question. I found myself in fundamental disagreement with Professor Ward as early as 1928.

"In 1932 I had to propose I believe—no it was 1928 that I proposed the message that was drafted by the Methodist church for the resolution on the social question. It was in opposition to Professor Ward's proposal, but what I proposed was carried by the Methodist

"In 1936, I drafted the resolution that put the Methodist Church on record as one of the earliest denominations in opposition to communism and fascism. We were, but nobody had ever said that before, and I wanted it in a clear resolution.

"From 1936—and I'm not sure I saw Professor Ward even then—I've seen Professor Ward once—I know since 1936—I think probably since 1932.

"Now then, he was an inspirational teacher, to whom I owe very, very much. He was a dear personal friend. When he shifted his views, as I believe, I had to break with Professor Ward. He understood it.

"I can bring for the committee, if it wishes, the letters that I wrote to him back at that time indicating a complete break in the matter of what he was standing for and what I believed we should stand for."

E. Stormer, page 58, paragraph 3: "Weapons and ammunition were supplied to the underground in Cuba by the CIA in such a way as to insure that they could never be used." His documentation for this charge is a column written by Edith Roosevelt in the Shreveport Journal, September 15, 1962. If Edith Roosevelt, a frankly partisan rightwing writer had made such a charge, it would not necessarily have been an accurate statement. But the fact is that she said no such thing. Edith Roosevelt writes that CIA dropped caches of weapons and ammunition at random freedom fighter depots in the expectation that the underground would be able to mount a coordinated attack in which ammunition and weapons would be properly distributed. She quarrels with this concept and points out that this resulted in some weaponry not having proper ammunition. At no time does she say or even imply that this was done to "insure that they could never be used."

F. Stormer, page 168, paragraph 1: "Despite exposure of the Communist control of the CIO by congressional investigations in 1938-39, the Communists remained in open control for at least 7 more years." (Ref. 7, ch. 10: Congressional Record, Sept. 22, 1950, p. A6831.)

There is simply no mention whatever in the reference which Stormer cites as to how long the CIO remained under Communist influence subsequent to the congressional investigation, or whether it remained so at all. This is a spurious reference.

G. Stormer, page 32, paragraph 6: "Gen. James Van Fleet, another Korean commander told Congress: 'My own conviction is that there must have been information to the enemy from high diplomatic authorities that we would not attack his home bases across the Yalu'." (Ref. 30, ch. 3: Hearings interlocking subversion in Government departments, SISS, 1954, pp. 1653-1708; 1711-1733; 2019-2046.)

Stormer has lumped this reference in with several previous ones, making it rather difficult to find. But when General Van Fleet's pertinent testimony is discovered on page 2033, we find that Stormer has embroidered a bit although he is purporting to quote General Van Fleet directly. The actual quote, as it appears in the record is, "My own conviction is that there must have been

information to the enemy that we would not attack his home bases." Under questioning, the general affirms that this is a supposition and that he has no evidence to support

The significance of this example is that Stormer added words to an item which he purported to be quoting.

H. Stormer, page 205, paragraph 4: "If U.S. proposals for arms control and disarmament are accepted, U.S. military forces will be transferred to the U.N. peace force, which is directed by the Under Secretary for Political and Security Council Affairs, who has always been a Communist." (No documentation.)

Stormer does not document this statement. although he certainly could have. Dozens of rightwing organizations have circulated this myth, and, by quoting each other, have compiled an extensive file of meaningless documentation. In the Congressional Rec-ORD of May 2, 1963, Senator Thomas Kuchel, Republican, of California, quotes the following paragraphs from the Long Beach, Calif., Independent, a metropolitan daily newspaper, of March 15, 1963, as follows: "The U.S. Government is trying to put all its Armed Forces under the command of a Russian general. John Rousselot told 600 persons in municipal auditorium Thursday night. Rousselot, John Birch Society district governor for six Western States and former Congressman from California's 25th District. spoke on 'Disarmament: Blueprint for Surrender.'"

"This office (referring to Under Secretary for Security Council and Political Affairs) is held by a Russian general," he said, "and if the United States turns over its Armed Forces to the U.N., the Russian general will command them."

After quoting those paragraphs, Senator KUCHEL went on to say, "Those fantastic charges, Mr. President, are false—completely false. But when one, who was honored to be a Member of the Congress for 2 yearsor even one who writes for an undisguised hatesheet, utters such a cry, there are Americans who listen and believe." The Senator then said, "There is no Russian colonel, or general, or military or civilian individual who is 'Secretary of the United Nations' or 'Secretary of the U.N. Security Council.' Let the record be clear that there are 19 Under Secretaries of the Security Council, of which 13 are filled by Americans or representatives of our allies and of which 2 are Soviet bloc nations. None of them has anything to do with the command of any joint U.N. military operations. There is no world police force in the U.N. And, of course, no Soviet national ever gave Gen. Douglas MacArthur any orders." The Senator then said, "I sympathize with some of my constituents who are honestly bewildered and confused by the trash of the rightwing extremists. I even feel sympathetic with those who have been taken in as dupes. But I have nothing but seething contempt for the originators of the hoaxes and swindles, from the ludicrous

leaders of the Birch Society to the equally ludicrous director of the Cinema Educational Guild, including any and all of the several hundred similar self-styled patriotic groups. They are anything but patriotic. Indeed, a good case can be made that they are unpatriotic, and downright un-American. For they are doing a devil's work far better than Communists themselves could do.

7. Documentation:

The front cover of "None Dare Call It Treason" presents the claim that it is "The carefully documented story of America's retreat from victory." The back cover of the book calls it "a careful compilation of facts from hundreds of congressional investigations and dozens of authoritative books."

The research committee of the National Committee for Civic Responsibility finds that it is neither carefully documented nor factual and that the word "authoritative" does not apply to many of Stormer's sources.

In support of these conclusions, the National Committee for Civic Responsibility research committee presents the following examples:

- A. (1) In 32 instances, Stormer uses as his authority "Human Events." This publication is an admittedly biased rightwing publication which the Anti-Defamation League has referred to as "an extremely rightist Washington newsletter." (Cross-Currents, p. 145, Forster and Epstein.) The John Birch Society (p. 81, the Blue Book) says, "Human Events not only feels also that we complement each other well, but for this reason is willing to join us in offering bulk subscriptions to the two periodicals together at a reduced price."
- (2) In 12 instances, Stormer cites as his authority books which comprise the John Birch Society packet "One Dozen Candles."
- (3) In at least 35 other instances Stormer has used as his authority such documentation as the "Dan Smoot Report," the "National Education Program," the bulletin of the John Birch Society, "America's Future," and other biased rightwing publications.

Such publications can, in no sense, be considered "authoritative." They cannot do much more than attest to the fact that someone else in rightwing circles shares Stormer's views.

- B. In 66 instances, Stormer gives as his authority "hearings" before congressional committees, and in most instances gives no indication as to who is testifying. This is no documentation at all since many persons testify with opposing viewpoints and, in fact, this is the purpose of hearings. To cite testimony given at hearings as being somehow "authoritative" or "official" is unjustified.
- C. In 65 instances Stormer cites the Con-GRESSIONAL RECORD as his authority. As is the case with congressional hearings, Stormer often fails to identify the person inserting these things into the RECORD. The Con-GRESSIONAL RECORD contains all views and opinions of all Congressmen and much other material as well. The only thing official about the Congressional Record is that it

is a record of everything that goes on in the Congress and whatever other material Congressmen choose to insert. Certainly no case can be made for using the Congressional Record as an "authority" upon which to document anything, for by doing this, one could "prove" his case on either side of any controversial issue or on both.

- D. Stormer's sometimes vague, incomplete or otherwise faulty citations make research of his material difficult. Some examples:
- (1) References 60 of chapter 3 refers simply to "Consul General for Yugoslavia versus Artukovic," without mention of where, when, or by whom such a hearing was conducted.
- (2) Reference 32 of chapter 2 refers to "House Document 227, page 4." Without any information as to the date or session of Congress in which this document is issued, it is virtually impossible to find.
- (3) Reference 13 of chapter 9 refers to "A Draft Act Covering Hospitalization of the Mentally Ill," and then says that a "majority of States" have mental health laws based on it. He does not identify the source of the "draft act" nor those States which supposedly based their laws upon it.

E. Perhaps the best single example of Stormer's combined use of distortion and faulty documentation to prove his point is contained on page 216. Stormer seeks to show that the United States is deliberately keeping Communist countries from collapsing. To answer the question of why this is allegedly taking place, Stormer says: "The answer was provided by another CFR member, Dr. Lincoln P. Bloomfield, in an official study entitled 'A World Effectively Controlled by the United Nations.' It was prepared on a contract with the State and Defense Departments in 1962. In it. Dr. Bloomfield discloses, perhaps unwittingly, why U.S. planners consistently aid world communism. He says, '* * * if the Communist dynamic was greatly abated, the West might lose whatever incentive it has for world government.' That is the answer. If American aid were stopped, the Communist empire would likely collapse.

Here Stormer first prepares the reader to believe that the views expressed in the report represents the thinking of our Government by terming the report "official" and pointing out that it was written under contract with the State and Defense Departments. The title page of this document, however, bears the following clear disclaimer:

"The judgments expressed in the study memorandum are those of the author and do not necessarily reflect the views of the Institute for Defense Analysis or of any agency of the U.S. Government."

The same disclaimer is contained in the foreword by IDA Associate Director of Research James E. King, Jr.

This document is a highly theoretical 38page study which attempts to envision how and under what conditions the U.N. might be transformed into a world government, and to postulate the type of military and other power such a government would need in order to operate effectively. The author expresses no views regarding the desirability of such a development.

The full statement from which Stormer quotes his sentence is as follows:

"On any count it is unsafe to assume that the ideological and power struggle between communism and the West will not continue indefinitely. This assumption of course throws into question any program requiring that both sides subordinate to a supernational authority themselves, their power and their ambitions. This is the central dilemma of world politics today, and it applies with ultimate force to the proposition of world government. The logical trap is completed with the familiar paradox: Given a continuation unabated of Communist dynamicism, the subordination of states to a true world government appears impossible; but if the Communist dynamic were greatly abated the West might well lose whatever incentive it has for world government." (P. 12.)

And so, Stormer wrenches a single sentence out of context from an unofficial report, intended to explore the possibility, not the desirability of world government and attempts to use it as documentation that communism would collapse without American aid. The full quotation from which the sentence is taken points out that world government is impossible so long as the Communist dynamic remains unabated while, paradoxically, if it were not to so continue, the West might lose its incentive for world government. The issue of American aid to Communist countries is, of course, not even mentioned in this report.

A more flagrant and dishonest misuse of quoted material would be hard to imagine.

8. Chapter 14, entitled "What Can You Do?" urges the reader to join such organizations as the John Birch Society, the Cardinal Mindszenty Foundation, and the Christian Anti-Communist Crusade.

The emphasis of all these organizations is upon the alleged control by Communists of America's political, religious, civic, educational, and judicial institutions as well as of our press, radio, and television. This chapter also urges the reader to subscribe to various rightwing publications, one of which he designates as a "Catholic publication" and another of which is designated as a "Protestant publication." The one designated as a Protestant publication is the "Christian Beacon" whose director is the Reverend Carl McIntyre, founder of the militantly anti-Catholic American Council of Christian Churches. In September 1945, the "Christian Beacon" said that Roman Catholicism is the "greatest enemy of freedom and liberty that the world has to face today" and that "one would be much better off in a Communist society than in a Roman Catholic Fascist setup."

The items contained in this report by no means constitute an exhaustive study or research into the statements or documentation of Stormer's "None Dare Call It Treason." Since the National Committee for Civic Responsibility is prohibited from taking any position on issues and must restrict itself

only to those areas which advocate violence or engage in calumny, only 43 items have been checked by this committee. The discrepancies outlined in this report reflect only those items which were uncovered in the process of checking those 43 documentary references.

9. In dishonestly seeking to undermine the confidence of the American public in our schools, churches, universities, newspapers, TV, and radio as well as in our Government agencies and top officials, Stormer seems to be doing the Devil's work as outlined earlier by Senator Kuchet.

Stormer's pretensions to scholarship and documentation might easily deceive many high-minded and intelligent but largely inexperienced people and undermine their patriotism by creating doubts about our political, social and economic system.

To the average reader, his documentation seems impressive and few will take the time to discover for themselves that it cannot withstand even the most cursory examination

The nature of the Congressional Record and testimony before congressional committees being what they are, surely research would have provided Stormer with accurate references which would tend to concur with whatever assertion he wishes to make. That Stormer did not even bother to do such research and so led any careful reader directly to material which refutes his allegations, would seem to presuppose that he did not write the book for the careful or well-informed reader. For the very nature of some of Stormer's charges would insure that such a reader would check the documentation and, once that is done, Stormer's game is up.

The many and obvious distortions of fact, historical and otherwise, are not within the province of the National Committee for Civic Responsibility's concern, but since this is done to prove a pattern of treason within the United States, some examples would seem to be in order.

A. Stormer states on page 55 that Laotian Prince Boun Oum was the "legal head of the anti-Communist Government of Laos" in 1962 and that he "was ordered (by the United States) to give Communists key positions in his cabinet."

The truth is that Boun Oum was not the legal head of the Laotian Government; that, in fact he attempted to overthrow the legal head of that government—neutralist Prince Souvanna Phouma—and failed. As a result of the attempted coup, Communist forces counterattacked and Phouma joined forces with them. The result was that Oum was badly defeated and the coalition government restored with Phouma at the head and neutralists predominating the cabinet which also included some of Boun Oum's representatives and Communist representatives.

Today, with the Communist seeking to take control, Phouma has joined forces with the rightist elements to preserve his government. Stormer, seeking to make his point, lumps neutralist and Communist cabinet members together when, since they are now

fighting each other, they are obviously not on the same side.

B. Stormer, page 74: "In 9 months an estimated 8 million packages of Communist propaganda material from Russia, Poland, Czechoslovakia, and Red China were imported in the United States. Placed in the U.S. mail, American taxpayers paid the postage for delivering the Red propaganda to schools, churches, homes, and libraries all over the Nation." (Congressional Record, Mar. 1, 1962, p. 2828.)

No such information is contained in the CONGRESSIONAL RECORD of that date. On page 3174, in a report entitled "Report of American Bar Association Special Committee on Communist Tactics, Strategy, and Objectives" (pp. 3170-3176), inserted into the RECORD by Senator DIRKSEN, the statement is made that "Communists are spending \$3 billion a year on propaganda which is reaching every city and hamlet in our Nation. In 1 day Communist propaganda coming through New York City alone fills three large warehouses. This propaganda comes not only from Russia, but also from Red China, from Iron Curtain countries, and from Western Europe. Much additional Red propaganda is published in the United States by Communist publishers."

On page 3108, second column, under title "Subsidizing Soviet Propaganda in the U.S. Mails," Representative Cunningham, of Nebraska, complains of three booklets sent out by the Soviet Embassy in Washington, D.C. He says it was sent at the special subsidized third-class bulk rate and went to Adams Public Library (Adams, Nebr.) for only 7 cents. Amendment to the postal bill would make it first-class mail and make Reds pay 51 cents to send it. He charged that at third-class rates, U.S. taxpayers subsidize it.

These are the only references to this topic in the Congressional Record of that date. Nothing is said about 8 million packages or about sending anything at the U.S. tax-payers' expense other than Representative Cunningham's charge concerning pamphlets that were sent at third-rather than first-class mail.

C. Reference 29 in chapter 8, in which Time magazine is accused of lying about the affiliations of Gustavo Duran in order to discredit Senator Joseph McCarthy, refers to the Congressional Record for November 14, 1951. Congress was not in session on November 14, 1951, consequently, there is no Record for that date.

In summary, the subject book is, at best, an incredibly poor job of research and documentation, and, at worst, a deliberate hoax and a fraud. This conclusion has been reached without giving any consideration whatsoever to those things which Stormer presents as a matter of his own opinion or that of others. Matters of that kind must properly be left to partisan debate.

IV CIVIL RIGHTS

Despite incredibly brazen and profligate bribery by agencies of the Federal Government, with your tax money, to induce the "poor" to engage in this "march(1)" on Washington — by bus and train and plane with all expenses paid — the whole thing is turning out so far to be the biggest flop since Harold Wilson's "economic sanctions" were invoked against Rhodesia. And on this board you can score one — a big one — for the results of the long educational campaign of The John Birch Society.

It is quite true that, with brilliant stage management and overpowering ballyhoo in press, pulpit, and over the air, and at the probable cost of murdering one of their own, the Communist influences in this coun-



try contrived to bring off quite a spectacular nationwide production early in April. They were able to give temporarily - in a great wave of massively promoted and exaggerated emotionalism - the aura of sanctity to a criminal hypocrite who, in our opinion, had already done more damage to his own race than any other man (white or black) who ever lived. We have been telling that truth, with increasing reach and effectiveness, for years. And we urge you to keep on telling it, with pamphlets and books that make the role King played in the Communist program entirely clear. This whole story of the "civil rights" fraud is a very important part of the truth which, if widely enough known, will keep our country free. And we want to mention in passing that our thin reprint on King's career, Less We Forget (ten copies for one dollar), fortunately, contains two concise pages on the Communist affiliations and pro-Communist activities of his successor, the "Reverend" Ralph D. Abernathy.

Communism or Common Sense on Trial?

Borrowing the format of Lord Russell's ludicrous "war trial" in Sweden, Young Americans for Freedom (YAF) and Schick's (Eversharp) new subsidiary company, Twin Circle-National Catholic Press, placed international Communism "on trial" in an auditorium provided on the Georgetown University campus in Washington, D. C., last month.

The 36 witnesses ranged from victims of Communist terror tactics in Hungary to a past Canadian representative on the International Control Commission in Vietnam to bona fide experts on the Far East and political science.

Sandwiched between them was a bevy of professionals from the super-patriotic circuit, including co-host Father Daniel Lyons (Pg. 14); Major Edgar Bundy of the Carl McIntire-backstopping Church League of America (Pg. 16); shirt-shedding Pastor Richard Wurmbrand (Pg. 15), frequent associate of Billy James Hargis; Duane Thorin, now a speaker on the John Birch Society's American Opinion lecture circuit; longtime pro Herbert Philbrick, Constructive Action's former FBI informer; and relative newcomer Phillip Luce, the handlebar mustachioed former member of the Progressive Labor Party. (See HOMEFRONT July-August '67).

WHILE MANY OF THE WITNESSES told heartrending stories, some in broken English, the most dramatic event came in the dawn hours before the final session.

Somebody tossed a bomb into the Russian Embassy about four hours before the final testimony on "Communist terror tactics." The timing may have been pure coincidence, but the Soviet Union is hardly likely to accept that explanation.

What was the purpose of the "trial"? Prosecutor Fred Schlafly (an Eversharp director) cited almost nothing in his summation that hasn't been known for years. While the entire proceedings were recorded for posterity on TV tape and by a Court Recorder, what was developed is hardly likely to account for so much as a chapter of the next book by the prosecutor's wife, right-winger Phyllis Schlafly.

ULTIMATELY THE COURT MAY FIND THE COMMUNISTS GUILTY of terror tactics. Unquestionably terror is the ugly handmaiden of aggression, but was the brutality of Hungary less humane than the retaliatory butchery of an estimated half-million citizens in Indonesia?

Would the trial's promoters have Americans be against all terror, or just Communist terror? All deception, or just Communist deception?

Was the goal to better equip Americans for facing up to the Communist challenge worldwide; or was Communism being used as a whipping boy to keep our attention diverted from other domestic threats?

What was billed as a "trial" of Communism looked to some reporters more like a test of our common sense.

While the Freedoms Foundation did not describe this material, the Berry Farm literature rack usually helps undergird democracy by offering the Birch Society's American Opinion Magazine; H. L. Hunt's Life Lines; Dan Smoot's Reports and various items plugging the repeal of the income tax. Knott helps finance many right-wing causes (Pg. 5); was a sponsor of the 1962 YAF rally (Pg. 2); was on Ronald Reagan's campaign finance committee in '66.

Every editor in the United States, radio or television program director, lecture program chairman, or anyone else who arranges such programs, should be warned about a new, nationwide smear operation. Truth About Civil Turmoil Committee: A Report

On October 4, 1965, the Mayor's Commission on Human Relations received a request from the Fort Wayne Council on Human Relations to make available a "comprehensive report" on the "background and activities of the group, TACT, which has recently been organized within our city."

After observing events that occurred between September 20 and October 9, 1965, and after learning that similarly named committees exist in other parts of the country, the Steering Committee of the Mayor's Commission instructed the staff to compile available information regarding the organization known as the Fort Wayne Truth About Civil Turmoil Committee.

The following report is based upon a survey of literature on the subject. The Commission queried sources locally, statewide and nationally in an attempt to obtain as an objective picture as possible. Discussions were also held with some members of the local citizenry.

CHRONOLOGY OF EVENTS

- September 20, 1965 The local mass media carried news stories announcing the formation of the Truth About Civil Turmoil Committee (TACT).
- September 22, 1965 The local mass media carried news stories which stated that TACT was sponsoring a public meeting on October 1, 1965, at which Mrs.

 Julia Brown would be the guest lecturer. The announced topic of Mrs. Brown's speech was "Communism and Civil Rights."
- September 30, 1965 A private dinner meeting sponsored by TACT was held at the Hotel Van Orman at which Mrs. Brown spoke.
- 1. See appendix for newspaper clippings

- October 1, 1965 A public meeting sponsored by TACT was held at Tokheim Hall where Mrs. Brown was the guest lecturer. The meeting was picketed by representatives from various local human relations groups and private citizens. Both the meeting and picketing were carried out in an orderly fashion.
- October 7, 1965 Beginning on this date and also appearing on October 8 and 9 was a series of statements by local leaders regarding the TACT organization. These statements appeared in one newspaper.

WHAT IS TACT?

The nomenclature "Truth About Civil Turmoil (TACT)" first came to the Commission's attention through a memorandum from the American Jewish Committee in July, 1965. Below the full text of that memorandum can be found.

"The John Birch Society will soon launch a massive drive to repeal the Civil Rights Act of 1964. We call this to your attention not because we believe they will succeed, but so that you may be aware of this development, and take whatever action you deem appropriate.

"The most important facet of this campaign, according to Robert Welch, will be 'the setting up throughout the country of hundreds of local or regional ad hoc committees' to be known as Truth About Civil Turmoil Committee (TACT) 'for the specific purpose of telling the truth about the civil turmoil which is now being made so unusual and unhappy a part of the whole American scene.'

"TACT committees, which it is hoped, will attract many non-Birchers, will be instructed to work 'closely and continuously' with Birch Society coordinators and to turn to Birch Society national headquarters for 'needed guidance.'

"It will be the combined duty of Birch Society members and the TACT committees to pour into the communities 'a veritable flood of material consisting of books, pamphlets, tapes and films explaining the 'civil rights fraud.' The communists, 'declares Welch, 'have laid out their plans for the Negro revolutionary movement so fully, in print, and so continuously right up to the present time that no good American...can fail to be convinced that 'civil rights' is a communist slogan and a communist program for communist purposes.'

"The total Birch propaganda will, in addition to 'exposing the 'civil rights fraud' purport to show that the Civil Rights Act of 1964 'is an extention of Federal power entirely beyond the limits imposed on such power by the Constitution of the U.S.; 'that this 'legislative monstrosity' is being 'leaned on' for support in the physical and economic harassment and persecution of good American citizens, 'that the Civil Rights Act was 'visibly so defined as to supply excuses and openings...for a central government to start inaugurating police state measures against particular individuals and selected private businesses.'

"Finally, Society members are instructed to 'write letters to newspapers, to radio and television commentators, to national and regional office holders in connection with various incidents and developments on the 'civil rights' front.'

"Since founder Welch believes that if the 'civil rights fraud' is exposed and rendered ineffective then the back of the Communist conspiracy will be broken, members are asked to 'work more diligently and concentrate more heavily on this educational task than we have ever requested... on any earlier projects.'

"The foregoing represents a significant and fundamental change in Birch Society tactics. It would appear that in the forseeable future members will be directed to concentrate their activities on one specific target at a time. Heretofore, Birch Society members were simultaneously engaged in such projects as 'Support Your Local Police,' Get U.S. Out of the U.N.,' etc."

The memorandum from the American Jewish Committee points out a number of features that the Commission used in its study to examine whether or not there are any parallels between the Fort Wayne TACT committee, TACT committees in other cities and the TACT committees mentioned in the memorandum.

An enumeration of the salient features of the above quoted memorandum is

(1) the John Birch Society is attempting to launch a massive drive "to repeal the

1964 civil rights act;" (2) "The most important facet of this campaign" is the

setting up of local and regional committees to be known as Truth About Civil Turmoil

Committees; (3) It is hoped that such committees will attract many non-Birchers;

(4) TACT committees will be instructed to work closely and continuously with Birch
Society coordinators and to turn the Society's national headquarters for needed guidance;
(5) that it will be the combined duty of TACT committees and Birch Society members to
flood communities with material consisting of books, pamphlets, tapes and films explaining the "civil rights fraud;" and that (6) the activities discussed in the memorandum
"represents a significant and fundamental change in Birch Society tactics. It would
appear that in the forseeable future members will be directed to concentrate their
activities on one specific target at a time."

In corresponding with other cities as well as national and state agencies, the Commission has learned that there are at least four organizations called Truth About Civil Turmoil (TACT) in existence. Two of these groups are in Pennsylvania. The other two, including Fort Wayne's organization are in Indiana.

In a letter from one municipal agency the statement was made that "....the connection between TACT and the local John Birch Society was...found to be true....with the same leadership appearing in the John Birch Society, 'Let Freedom Ring,' and a group known as the 'Northeast Anti-Communist Forum." A second agency reported that "We are, of course, aware that TACT is one of several action arms of the John Birch Society...."

From the third city queried, we received an article which was sponsored "as a public service by the Madison County TACT Committee (Truth About Civil Turmoil)." Although we have no information about the leadership of that organization, we do know that the article entitled What's Wrong With Gvil Rights?, included a list of some 14 publications, all of which could be purchased at an American Opinion Library located in that city. Practically all of this same literature is recommended by the John Birch Society in its September, 1965 Bulletin.

WHAT DOES JOHN BIRCH SOCIETY LITERATURE SAY?

After compiling the information discussed above, the Commission than began to survey literature published and/or distributed by the John Birch Society to discover whether or not the mention of "Truth About Civil Turmoil Committees" could be found. We also attempted to discover what the Society has to say about civil rights and the Civil Rights Act of 1964.

The John Birch Society Bulletin for September, 1965, entitled Fully Expose the

'Civil Rights' Fraud and You Will Break the Back of the Communist Conspiracy does

give us some insight into the former question. Item IV of the "Agenda for the Month -
Continuing Projects" is entitled "Civil Rights."

The first two paragraphs are as follows:

"But let's put first things first, and concentrate our efforts wherever, and to whatever extent such planned concentration materially improves our chances of slowing down, disrupting, and eventually routing the weaving Communist columns. And right now there is no question in our minds about the Communist 'civil rights' movement having the qualifications for such a target.

"We believe that Communists are more vulnerable on this front than they have ever been on any other. We believe that it is easier to convince our presently uninformed but basically sound fellow citizens of the truth about the 'civil rights' movement, as a Communist program designed to serve Communist purposes, than it is with regard to any other part of their huge advancing front of cruelty and deception. We believe that our strategy of education, of simply bringing out the truth and creating sufficient understanding, is more obviously and more completely the answer to this problem than it is for any other sector of the struggle in which we are engaged. And we believe that every appreciable exposure which we accomplish, of any part of the whole 'civil rights' fraud, is a serious setback to overall Communist plans and purposes. So let's take full advantage of the opportunity."

The Bulletin then continues by describing ways and means of achieving the objectives of its "educational" program. One way as recorded in the Bulletin is through the formation of ad hoc committees. The Bulletin states that "While there have been some other early TACT committees which have also received favorable publicity, however, and while

we certainly do not object to the actions which bring such publicity provided those actions which bring such publicity provided those actions are carefully considered, constructive, appropriate, and in good taste, we should like to emphasize again that the primary purpose of all of these Truth About Civil Turmoil committees is simply to spread that truth. And this means in the main, of course, to achieve wider distribution and readership of books and pamphlets and other printed materials which will inform, awaken, and alarm our fellow citizens with the real truth about "civil rights."

In discussing the formation of TACT committees, the article suggests that members of "the Society in any area" attempt to get "non-members, all of whom are people of good standing and good character, to join them in a TACT committee."

The Bulletin points out that if ten Society members in any given area could successfully get minety non-members to join their efforts then "obviously our ten members can multiply by ten the total results of their own efforts, through stimulating all of their associates in their TACT committee to go to work with the same determination on the same educational tasks." It is also pointed out in this document that Society members who are interested in setting up ad hoc committees will, upon request receive all that can be given by the "Belmont office, the San Marino office, andlocal Coordinator."

In closing its discussion on "The TACT Committees," the Bulletin states the following:

In addition to advice about procedures, however, in the manual or elsewhere, let me add a few comments here of a more substantive nature-even though they are repeated from earlier bulletins. (1) The John Birch Society takes absolutely no position with regard to integration or segregation. It feels that the se are matters which should be decided by and for local or regional areas, and never for any area larger than a state, nor by any political unit higher than a state government. (2) The Society is unalterably opposed to the direct or indirect use of power by the central federal government, to enforce either segregation or integration in any state or any

part of any state. (3) The Society believes that, with rare exceptions, even after so much agitation and propaganda, the average Negro American is a good American, as fully entitled to the protection of the law and the good will of his neighbors as the most patriotic white citizen. The Society will not allow so-called "racist" views, activities, or agitators among its efforts nor within its ranks. (4) The purpose of the Society, with regard to racial turmoil and racial questions, as with regard to everything else, is purely educational. We seek to offset Communist lies and collectivist propaganda by bringing out the truth. "Education is our only strategy, and truth is our only weapon." (5) And, especially where so much hatred is being deliberately fomented, we are at all times missionaries seeking to restore good will, to create understanding, and to bring about an even better environment for the lives of both races than we had before the Communists began to tear to pieces the wonderful country our generation inherited.

Let's make sure that all TACT committees, and the management and individual leaders of all TACT committees, thoroughly understand, agree with, and abide by these principles, before our members commit the Society or themselves to the support of any group in any way. For if, but only if, these basic beliefs and purposes are kept always carefully in mind, a hundred or a thousand or even five thousand TACT committees throughout our country can become a very powerful influence towards exposing Communist efforts, through their fraud called "civil rights," to destroy and subjugate our nation."

FORT WAYNE TRUTH ABOUT CIVIL TURMOIL COMMITTEE (TACT)

Are there any parallels between the Fort Wayne TACT committee and TACT committees and TACT committees described on the preceding pages? The most obvious parallel is the name.

Secondly, although the Commission has no information as to who conceived the idea of a Fort Wayne TACT committee, there are similarities in regard to membership. In a television interview on September 20, 1965, the chairman of the local TACT committee was asked whether or not TACT was affiliated with the American Opinion Library, and whether or not it was affiliated with the John Birch Society. To the former question the reply was no. To the latter question, the chairman stated that he is a member of the John Birch Society as are some of the other members of TACT. He also pointed out, however, that not all members of TACT are members of the John Birch Society. This mixed membership of Birch Society and non-Birch Society members also appears to parallel the techniques as described in the September issue of the Birch Society's Bulletin.

Thirdly, the Commission has no information as to how closely the Fort Wayne TACT committee is working with the national office of the John Birch Society, if al all. However, it should be pointed out that at the first public meeting sponsored by TACT, the guest speaker was Mrs. Julia Brown, a member of the American Opinion Speakers Bureau. In a television interview Mrs. Brown also acknowledged that she is a member of the John Birch Society.

Whether the Fort Wayne TACT committee is encouraging local citizens to read all the materials described in the John Birch Society Bulletin cannot be fully determined by the Commission at this time. We do know that one of the books which the Society encourages its members to read has been promoted by the local TACT group. We know that in addition to this one book, Mrs. Julia Brown who was invited to speak in Fort Wayne at the request of TACT, encouraged her audience to read two additional books, both of which are frequently mentioned in the John Birch Society Bulletins and the American Opinion.

One of the books recommended by Mrs. Brown entitled None Dare Call It Treason has been severely criticized by many reputable organizations and individuals. One organization states that "None Dare Call It Treason, a paper-back volume by John A. Stormer suggests subversion and treason; however, it is written in such careless fashion as to make its material suspect at almost every point."

It is also interesting to note that of the many informational materials which have been recommended by federal, state and local governmental intergroup agencies on the subject of civil rights, none appear in the literature we have reviewed. Yet according to the announced purposes of the TACT committee, that group has been organized "to provide information about past instances of civil turmoil in order to prevent recurrences of violence."

It is also interesting to note that upon reviewing some civil rights bibliographies promoted by reputable governmental and private intergroup agencies, none of the literature promoted in the John Birch Society Bulletin, the American Opinion magazine or by the local TACT committee or Mrs. Brown are included.

The information as recorded here in addition to the materials included in the appendix gives you some ideas as to what the Commission has found out about TACT.

Ex-worker for FBI Tells How Reds Use Negroes in 'Rioting'

The main target of Communists this year in the United States is disorder by using the "police brutality" slogan, a former Negro FBI

undercover agent said upon arrival here.

Mrs. Julia C. Brown, Cleveland, will give an address today at 8 p.m. in Tokheim Hall. A one-time member of the Communist Party, she quit when she found the Communists using Negroes for their own purposes and later infiltrated the Party as an operative for the FBI. Her talk here is spensored by TACT (Truth About Civil Turmoil Committee).

> "Communists are going to continue their 'police brutality' campaign in the United States until more Negroes become informed they are being used," she said in an interview.

> Everyone should have civil rights and everyone should be able to vote and have the other freedoms, but the Communists are using the civil rights movement for propaganda, she said. "They are picking it to pieces."

Mrs. Brown explained that Communists have been planning their "police brutality" gimmick for years. She recalled a time at a Communist cell meeting in Cleveland when someone showed a news item indicating police brutality against a white person. It was explained at the time that Communist policy had no interest in police brutality against whites, whether it existed or not, but only in police brutality news dealing with Negroes since they later intended to use the Negroes in campaigns of violence and dis-

"Criminals are encouraged to resist arrest," she said. "Naturally, the criminal does not want to be arrested. Next, the Communist campaign encourages others to interfere with the arrest and try to cause violence. Whenever one Negro is arrested, others are encouraged to shout 'Gestapo' or 'police brutality' and stimulate a riot situation.'

Mrs. Brown said the people the Communists normally encourage are the people who have grievance - the under-privileged and the uninformed. "They are using the Negroes more than anyone (Turn to Page 6B, Column 5)

"Protest and differences of opinion have always been an integral part of the American way of life, but the right and privilege to protest carries with it certain duties not the least important of which is to tell the truth and not attempt, by inference and innuendoes, to tear down those who think and act differently.

"Admittedly. demonstrations may not be necessary when legal processes are available to remedy wrongs that exist, but peaceful demonstrations often serve to call attention to situations which, without them, would not be corrected.

"When a speaker has the audacity to brand, directly and by inference, everyone who has ever participated in a demonstration as a Communist, and this includes nuns and priests, rabbies and protestant clergymen, then those responsible for sponsoring such a speaker must be called to task by their com-munity."

"Such irresponsibility dares not go unchallenged!

"Unfortunately, what is happening in Fort Wayne is not an isolated situation, as there is evidence that the same thing is taking place in other cities in Indiana. This leads one to the conclusion that there is a wellorganized effort to create discord and ill will in our communities, regardless of how this divisiveness is accomplished."

Federation Appalled

TACT's Charges Of Communism Bring Sharp Protests From Local Clergy

(Second in a series of three) By WESLEY BASHORE

Two more religious leaders have added their voices to others in countering charges of "communism" and "Communist infiltration" of the civil rights movement

These leaders have taken issue with the charges of a speaker for the "Truth About Civil Turmoil Committee" (TACT) that the Communists have so infiltrated the civil rights movement that they have "picked it to pieces." The speaker, a Mrs. Julia Brown of Los Angeles, attacked civil rights demonstrations as "Communist inspired" and only held to create turmoil. She spoke last Friday night under the sponsorship of the local TACT group.

TACT committees are closely related to the John Birch Society and are being set up throughout the country to oppose the civil

rights movement and disparage the Civil Rights Act of 1964.

Statements below are those of Dr. John Meister, pastor of the First Presbyterian Church, and Msgr. Stanley L. Manoski, director of lay activities for the Fort Wayne-South Bend Diocese and pastor of St. John the Baptist Catholic Church.

Msgr. Manoski stated:

"In the present turmoil and confusion on local problems and national issues, it is absolutely necessary that we display a firm intellectual honesty.

"People who make statements of generalities are not facing an issue squarely. I feel they lack the intellectual honesty and integrity so sorely needed to help us understand. Let us not be so quick to jump to conclusions lest we jump into a fire that may

be difficult to extinguish.
"A good rule for all of us is that we look at matters squarely,

soberly, justly and without malice. And, it is well for all of us to keep in mind the words of the Irish statesman, Burke, who said, 'Evil triumphs because good men do nothing'.

Dr. Meister stated:

"Our Fort Wayne community seems to be more divided, fearful, and full of mistrust than at any other time in recent years. We cannot advance on any front -educational progress, fair and open housing, city-county building, securing or producing electric power -- without stirring up discord, dissent, and division.

"One can only regret, therefore, the arrival in Fort Wayne of an'organization which uses the good word "tact" to camouflage an organized attempt to sow seeds of distrust, to spread suspicion and falsehood, and to set neighbor against neighbor. A dictionary meaning of 'tact' reads:

'a keen sense of what to do or say in order to maintain good relations with others.'

"No useful purpose can be served by deliberately seeking to confuse 'non-violent civil rights demonstrations' with 'violent civil turmoil.' That is like saying there was no difference between the parade of Jesus and His disciples on Palm Sunday and the blood-hungry mobs roaming the same streets on Good Friday.

"The civil rights movement has by-and-large been comprised of well-disciplined individuals with above-average intelligence who come from middle and upper-middle economic groups. It is essentially a political move-

"To seek to confuse the two in the minds of people is to ask for trouble. If such confusion were successful it could easily

turn the non-violent civil rights movement into a violent battle. Negro Americans have shown infinitely more patience than the honored revolutionaries of 1776but their patience cannot be expected to last forever.

"No useful purpose can be served by seeking to confuse the menace of communism with either civil turmoil or the civil rights movement. There is little doubt that Communists and other subversives have sought and will seek to infiltrate civil rights organizations. There is no doubt that the voice of Communists is heard in our urban pockets of poverty. Such Communist efforts are to be expected. Communists will take over and use any organization or any colony of discontents they can capture.

"The answer to such Communist efforts is not to seek to discredit civil rights organizations. The answer is to obtain and guarantee the civil rights of every citizen. Then organizations to secure civil rights will go out of existence - and there will be none left for Communists to infiltrate.

such Communist efforts to explain away or to hide from the root causes of riots in our urban centers of poverty. If Communists are there and heard we can be quite certain that enforced grinding poverty was there first. Anyone who suggests that a victim of such poverty can escape it by determination and an act of will betrays by the suggestion that he has not lived in such a neighborhood.

"Far better than creating suspicion is the habit of encouraging men - however imperfect who spend themselves to achieve for all men the civil rights and pursuit of happiness to which all men are entitled - as we say through our Constitution and Declaration of Independence.

"Our greatest local need is to establish and then maintain good relations among our townspeople. If we have confidence in our way of life and if we believe in the American Constitution we shall work to secure civil rights and economic opportunity for every person. That way lies good relations. That is true tact.'

Smear Tactics Deplored

The Rev. Mr. Fairchild stated: "Thoughtful, responsible persons recognize the right of all citizens to be heard on any issue. This is part of our great | American heritage.

"But freedom of speech is abused whenever individuals resort to indiscriminate name-calling and the hurling of unsub-stantiated charges of disloyalty at public officials, private citi-

zens, religious leaders and institutions dedicated to establishing and strengthening good will and justice among all men.

"Individuals and organizations engaged in smear tactics of this nature, and those who sponsor such techniques, should be exposed for what they are - distorters of truth, disseminators of suspicion, disrupters of peace.

"The Journal-Gazette is to be commended for its efforts to help set the record straight. There is a constant, continuing need for enlightenment about Communism and all the other evils within our society. But this must be factual and accurate rather than tailcred to echo personal prejudices and idiosyncra-

"J, Edgar Hoover has warned that-emotional outbursts, extravagant name calling, and gross exaggeration hinder our efforts.

"To understand and to handle the great tasks before us, each responsible citizen must first of all be a person of integrity. Then we must do our part, individually and with our neighbors, to help provide and maintain the highest moral standards for our community.'

'Heard It All, Now'

Rabbi Doppelt expressed his feelings with strong emotion after reading newspaper accounts and after hearing a recording of the speech:

"I have heard it all now and I've had it. I thought it could happen only in Soviet Russia or Nazi Germany. But now I have heard the John Birch Society speaker throwing a bar-Continued On Page 16B.

"Use the smear technique -the more the better. Hurl all kinds of epithets at those you don't like --- the more indiscriminate and the uglier the better. Don't appeal to reason; that's for mentality. Just use labels, slogans, can't words - the more unscrupulous, the better."

"Repeat over and over again: They are infiltrated, they are Communist inspired. Don't worry about proofs and evidence. Just continue stigmatizing. Do a good job of spreading suspicion and dissension. That's a good way to undermine and undercut the American way of

"Yes, I have heard it all now. It was in all a glorious event for all sinister forces who would destroy every human right and every liberty which makes our a blessed country — And it was all done in the name of superduper patriotism. What a clever trick! But what an ugly travesty of the American way of life!"

Fat Lucitus Jour and Gozitt Wilkerson stated:

"Fort Wayne is one of the few cities in this nation that moved smoothly along lowering its barriers and working for the enjoyment of community resources for all on an equal basis. The Urban League is partially responsible for this. It is interesting to note that we find people today volunteering to tell what civil rights are, but who have never worked or offered to do anything to bring about a change of equality for all.

"The facts are that there is a strong element, north of the Mason-Dixon Line, that moves in high circles even in the power structure of the communities and Fort Wayne that would hold the line on total equality for all, just as much as the mentally sick public officials of Hayneville or Selma, Alabama.

"Therefore, we should not be surprised at having a similar element in Fort Wayne. Negro citizens are determined that nothing shall hinder them in their forward march for civil rights.

Any Negro leader, any organization, or any movement that has for its objectives that of equal opportunities finds cloak of communism quie to hung upon him. Every Negro leader in America, at one time or another, has been called a Communist.

"Communists have tried time and time again to infiltrate the Urban League movement, but unsuccessfully. The path for continued progress in the area of inter-racial relations in Fort Wayne is for all of us to work diligently for that day when this community will become a free community for all people. Destiny writes this as a record."

Brawley stated:
"The NAACP has not deviated from the course of action that it initiated in 1910, Groups of Negroes and whites have been working together for 55 years and Fort Wayne is no exception.

"The local NAACP branch is proud of its membership, which includes the Mayor of the city. the chief of police, and many members of the Police Department.

"Our goal is to improve relationships in this community by exercising a sense of cooperation and consultation. We are opposed to the actions of any hate groups,

Recently there appeared in Fort Wayne a speaker for an offshoot group of the John Birch Society. Her name: Mrs. Julia Brown, a Negro, a former member of the Communist Party, and later an FBI undercover agent when she became diagrantled with the Party. During interviews with local news media, including WANE, and in news reports of her talk, Mrs. Brown was quoted as saying, "There are no good Negro organizations because all were infiltrated with Communista". She listed the NAACP, National Urban League, CORE, and also The National Council of Churches. Mrs. Brown further was reported as saying the "Selma, Alabama March was Communist inspired"; "police brutality is a propaganda tool of the Communist Party"; and "the Watts riot in Los Angeles was Communist inspired".

While we can agree that charges of "police brutality" have often been indiscriminately and inaccurately hurled, and have maligned a lot of good policemen, this is where our agreement with Mrs. Brown ends.

Newsmen who covered the Selma March in detail, including our own CBS reporters, found little evidence of Communist infiltration. We doubt the Watts riot was Communist inspired, since it grew out of a street brawl following the great of a drunken Negro driver. Mrs. Grown professes to see the hands of the Reds in this, saying the "police arrest charge was phony". We think this view runs counter to the facts.

Of course, the Communists have tried to infiltrate Negro and Civil Rights organizations. (They have also tried to infiltrate the American Legion.)

The management of WANE-AM-TV welcomes requests from responsible spokesmen for the presentation of views contrasting with those expressed in its editorials on controversial issues of public importance. Requests should be made within five days after the date of broadcast of the editorial and, if more than one such request is received, the station reserves the right to select the spokesman to present such views.



But to say "There are no good Negro organizations" is an indiscriminate, scattershot type of charge, as destructive in its own way, and as deviaus as the methods of the very Communists Mrs. Brown so passionately opposes. J. Edgar Hodger has warned that smotional outbursts, extravagant name calling and gross exaggerations hinder our national effort to understand Communism and other evils within our society. We think Mrs. Brown is guilty of such an outburst and exaggeration. We agree with a statement of the Reverend Dr. John Meister of the First Presbyterian Church, quoted in a recent series in the Fort Wayne Journal Gazette: "The answer to such Communist efforts (to inditeress the Civil Rights Movement) is not to seek to discredit Civil Rights organizations. ("None Dare Call It Patriotism: Some May Call It Treason")

The John Birch Society is launching a major propaganda assault to convince the American people that the Eisenhower, Kennedy and Johnson Administrations have been siding with the Communists against the best interests of the American people and that "BI-PARTISAN TREASON IS RAMPANT EVERYWHERE".

The Birchers have an established strategy of attempting to convince their fellow citizens that U.S. policy for Vietnam is deliberately contrived to help the Communists achieve their long range goals of world domination. Birch Leader Robert Welch sets the tone for the campaign by boldly implying (through rhetorical question) that the deaths of American GIs constitutes "deliberate, conscious, coldblooded murder on the part of the Johnson Administration". This is done in the opening paragraphs of a 1967 copyrighted position paper by Robert Welch ironically entitled, "The Truth about Vietnam".

In the March, 1967 John Birch Society <u>Bulletin</u>, he calls upon members of the estimated 4,000 Birch cells to intensify their efforts to (a) get circulation for "<u>The Tuuth about Vietnam</u>", (b) circulate a companion Welch position paper called, "<u>The Truth in Time</u>", and (c) launch a petition campaign to Congress.

The March JBS <u>Bulletin</u> carries the notation "Approved by the Executive Committee", so this is clearly a policy matter. The Birch Society calls upon "<u>all</u> of our members, and all other patriotic Americans" to circulate the petition. Presumably this means setting up front committees like the "Support Your Local Police" committees used to disguise Birch attacks on the Civil Rights movement.

This petition implies that "traitors" are forming U.S. policies influencing the course of the Vietnamese war and calls upon Congress to stop giving "aid and comfort" to the Soviet Union. There is no indication on the petition or either of the "Truth" books that they are sponsored by the John Birch Society. Unquestionably, many anxious citizens can be taken in.

Already the "Truth" booklets are cropping up in many areas, and both they and the petitions are available from Birch headquarters in Belmont, Massachusetts and the 350 JBS American Opinion bookstores.

THE PROMOTIONAL EFFORT behind this campaign appears to be the equivalent of that which the John Birch Society placed behind the 1964 John Stormer book "None Dare Call It Treason". The Birchers and their allies secured a circulation of several million for this horrendous document. It is not yet clear how much cooperation other groups will give the Birch Society in their current efforts despite the appeal to "all patriotic Americans".

Here are the major elements of the campaign:

1) "The Truth in Time", a 30-page position paper signed by Robert Welch and distributed with the November, 1966 JBS Bulletin. Copies are available (at four for a dollar) from "American Opinion - Belmont, Massachusetts, 02178." That is Birch Society headquarters, but no mention of this or of Welch's connection with the Society appears in the booklet.

Welch's thesis is that there is a worldwide conspiracy of "INSIDERS", a secret conspiracy handed down from father-to-son for nearly 200 years, which is now in control of both Washington and Moscow. (Sample quotes on following pages.)

- 2) "The Truth about Vietnam", a 20-page booklet copyrighted by Robert Welch, 1967, which was distributed with the February, 1967 JBS Bulletin. Copies are available (at five the March, 1967 JBS Bulletin, 225,000 copies already have been distributed.
- 3) "A Petition to the Congress of the United States" with no sponsoring organization listed but available (at 5¢ each) from "Review of the News, Belmont, Massachusetts, 02178."
- 4) Supporting elements of the campaign are: "Background to Betrayal," by Hilaire du Barrier, contributing editor to American Opinion magazine, the slick paper publication by Robert Welch, Inc., Belmont, Massachusetts, 02178, and printed by Western Islands, one of the two JBS printing houses. (This costs a dollar and like all of the above is

about all of the strange and disturbing actions of this Administration.

Consequently, we are asking all of our members, and all other patriotic Americans whom we can persuade to join us in this effort, to go to work now, by the one legitimate and effective means guaranteed to us by the Constitution, to compel an end to this giving of aid and comfort to our enemies, in a war which is already costing us very heavy casualties. You will find the petition to implement this purpose, and the arguments to support that petition, reproduced as a center-spread to this bulletin.

A quantity of these petitions is being forwarded by us at once to every American Opinion bookstore unit, and to every member of our field staff, for resale at 5¢ each or at 50 copies for \$1.00. Or, as stated on the petition itself, they may be ordered by mail, postage paid at 50 copies for \$1.00 (minimum mail shipment), from The Review Of The News, Belmont, Massachusetts 02178. And of course in the meantime one copy may be carefully

lifted right out of the senter of this bulletin, in order to "get the ball rolling" at once.

This is one subject and one project about which we believe you will find most of your neighbors and friends quite receptive and even enthusiastic. We suggest that you sell, rather than give, a copy of The Truth About Vietnam and of The Truth In Time to each one, where practicable, as sources of greater knowledge and understanding of what is behind the Vietnam war. But in any event we urge that you get as many petitions signed as you can, as promptly as you can and persuade others to do the same. This should become the most massive plea by petition ever directed at the American Congress. We are the only Conservative organization in America with the national reach to make it so; and a sufficiently sizable campaign to stop this aid and trade with our deadly enemies may be of vital importance to the future of our country. This is a responsibility and an opportunity which we must not fail.



Right-wing lobbyists testify against East-West trade

Hearings before a subcommittee of the Senate Committee on Banking and Currency, convened to hear arguments on a resolution to increase trade between the U. S. and Eastern Europe, received sharp opposition from at least three right-wing organizations. One was the Committee to End Aid to the Soviet Enemy (CEASE), represented by former Connecticut Governor and Ambassador to Spain John Davis Lodge. Another was Liberty Lobby, and the third was Young Americans for Freedom (YAF), which has been in the forefront of demonstrations against U. S. tobacco companies, rubber companies and the IBM to protest trade with iron curtain countries.

MISCELLANY: Governor Ronald Reagan has added his name to the list of those who have refused to proclaim United Nations Day, a favorite target of the radical right. . . . Dr. Bella Dodd, the anti-Communist ex-Communist, is running for Congress from New York's 19th District against Leonard Farbstein. . . . Liberty Lobby has released its attractive 24-page tabloid, "The Great Tax Fraud," a mishmash of attacks on Federal spending, big tax loopholes and liberal foundations. . . . The August Bulletin to Birchers reminds them of the approaching season for booths at local fairs and boasts of a Birch parade two blocks long at Huntington Beach, Calif. . . . Another current Birch instruction asks that "Impeach Earl Warren" billboards be redone with the message: "Let's win this war in Vietnam—and then bring our boys home." . . . Columnists Paul Scott and Robert S. Allen have split and gone separate ways. . . . The parole process has released John Harrell, one of the most exotic of the conservatives who operated a sort of preserve at Louisville, Illinois, until he fled authorities and was caught near Strawberry, Arkansas (pp. 64 & 70, 1964). . . . Another enterprise in behalf of Congressman John Rarick (p. 53) has been started from a Washington postal box, this time with a candid name—Friends of John Rarick. . . . The American Security Council has a "comic book" version of the hawkish book, Design for Survival, by General Thomas Power, who recently retired as head of the Strategic Air Command (SAC) and is Vice Chairman of Patrick Frawley's Eversharp, one of the biggest supporters of the Council.



EDITOR'S NOTE: Many have written asking us for some sort of article concerning the Robert Kennedy assassination.

We now print what we consider to be the primary cause in the death of not only RFK, but JFK and MLK as well. The following is not an oversimplification, any more than it is oversimplification to state than an overdose of poison will cause death. THE TRUTH ABOUT VIETNAM

The lead editorial of *The Boston Herald*, on Saturday, January 21, 1967, began as follows: "Last week in Vietnam 144 Americans were killed, 1,004 were wounded and six were reported missing."

It is the sad purpose of this article to raise the question: Did the death of those hundred and forty-four Americans constitute deliberate, conscious, and coldblooded murder on the part of the Johnson Administration?

This is a somber and solemn thought. We do not plant it without being fully aware of the significance of what we are saying. Nor do we mean the question to be metaphorical or hyperbolic. It is not intended as simply a sensational means of supporting or emphasizing some criticism of the way the war is being conducted. Our inquiry goes much deeper than that, and comes out with the question above when every word is used in its more literal sense.

Let us go back now and begin our approach to this ultimate demand, which will end our essay as it has begun it, by asking a whole series of more immediate and more specific questions. The Greeks said that to know the right questions to ask about any subject was to be half way, already, towards knowing the answers. We do not claim to know the answers about Vietnam, nor even all of the valid questions. But we certainly do know quite a number of questions which the American people should be asking.

II

First, let's gradually become immersed in our subject matter by considering the more obvious puzzles, which float right

The serious questions that can be raised about the conduct of the war in Vietnam would fill a hundred printed pages. In fact we ourselves raised enough to fill twenty pages, in our pamphlet, The Truth About Vietnam.


Of all these questions, however, there is one for which any American citizen has the right to demand a satisfactory and unequivocal answer. So this pamphlet will be devoted to that specific issue. It can be stated, in plain language: "Why fight 'em in Vietnam and help 'em everywhere else?" Let's look at some of the facts and circumstances which make that question so inevitable and so important.

First, we must realize that we are at war. Our President himself has said "this is war." In actual fact, when measured as to costs, as to the number of our men engaged in the combat area, and as to the current rate of casualties, it is already the third largest war in American history — and is steadily getting larger.

Second, our enemy is the total Communist bloc of nations. Our Congress has not declared war against any nation. No nation has declared war on us. But the fighting is taking place between the United States and North Vietnam. And the officials of Soviet Russia, and of one Communist regime after another, have repeatedly declared their complete solidarity with North Vietnam. So that, for all practical purposes, we are at war in Southeast Asia with Soviet Russia and its satellites all over the world.

Third, at least eighty percent of the sinews of war are


