## BRITISH POLARIS

WASHINGTON (AP)-THE BRITISH WILL LAUNCH POLARIS MISSILES OFF THE U.S. EAST COAST SOON IN THEIR FIRST TEST FIRINGS OF THE ROYAL NAVY'S NEW POLARIS SUBMARINE, THE PENTAGON ANNOUNCED TODAY.

THE DEFENSE DEPARTMENT SAID THE ROYAL NAVY'S FIRST POLARIS SUB, HMS RESOLUTION, WILL ARRIVE IN THE UNITED STATES LATER THIS MONTH FOR FINAL "SHAKEDOWN" TESTS OF HER TWO CREWS AND THE MISSILE SYSTEM.

THREE OTHER BRITISH POLARIS SUBS ARE UNDER CONSTRUCTION AND WILL COME TO THE UNITED STATES UPON COMPLETION.

THE RESOLUTION WILL PICK UP TEST MODELS OF POLARIS A3 MISSILES--CAPABLE OF CARRYING A NUCLEAR WARHEAD 2,800 MILES--AT THE U.S. NAVY BASE IN CHARLESTON, SOUTH CAROLINA.

THE MISSILES, MINUS THE NUCLEAR PAYLOAD, WILL BE LAUNCHED DOWN THE EASTERN RANGE OFF FLORIDA.

## WASHINGTON--ADD BRITISH POLARIS (97)

THE PENTAGON SAID THE BRITISH SUB WOULD BE BERTHED FOR ABOUT A MONTH AT PORT CANAVERAL, FLORIDA, PART OF THE CAPE KENNEDY COMPLEX.

A DEFENSE SPOKESMAN INDICATED THE RESOLUTION WOULD FIRE ONE POLARIS MISSILE FOR EACH OF ITS TWO CREWS.

AFTER THE LAUNCHES THE RESOLUTION WILL RETURN TO FASLANE, SCOTLAND, TO BEGIN ITS FIRST OPERATIONAL PATROL IN JUNE.

BRITAIN'S THREE OTHER UPCOMING POLARIS SUBS ALSO WILL EVENTUALLY OPERATE OUT OF FASLANE.

THE U.S. HAS 41 POLARIS SUBMARINES, THE LAST OF WHICH WAS COMPLETED ONLY LAST YEAR. THE ATOMIC-POWERED SUBS CARRY 16 LONG-RANGE MISSILES WHICH CAN BE LAUNCHED WHILE THE VESSEL IS SUBMERGED.

Subject: Public Affairs Planning for visit to U. S. of  
HMS RESOLUTION (C)

(C) In accordance with your request the joint U.S. Navy-Royal Navy public affairs plan for the forthcoming visit to the United States of the British nuclear powered Polaris submarine HMS RESOLUTION is enclosed. This plan was prepared with the assistance of United Kingdom representatives. At the last minute the British asked that the press release scheduled for 5 January 1968 be delayed due to electrical difficulties on board the ship which could cause a slip in the scheduled arrival date.

(C) The British desire to hold publicity to a reasonable minimum so as not to reopen the political issue of the British nuclear deterrent in the United Kingdom or offend the press. Accordingly, it is not recommended that the President send a message of welcome to the RESOLUTION because of the attention that it could attract. It is intended that a suitable message be sent by the Chief of Naval Operations to the ship upon her arrival in the United States.

MEMORANDUM FOR THE PRESIDENT

Subject: Visit to U. S. Ports by British Nuclear Powered  
Polaris Submarines

Arrangements have been made for the British nuclear powered Polaris submarine HMS RESOLUTION to visit Charleston, South Carolina, and Port Canaveral, Florida, during the period 24 January through 6 March 1968. The purpose of these visits is to conduct Polaris missile shakedown and firing operations. It is intended that each follow-on British Polaris submarine make similar visits for the same purpose. The visits scheduled for the RESOLUTION, and the follow-on visits, are necessary to carry out the United States and United Kingdom Polaris Sales Agreement of 6 April 1963.

The procedure for obtaining clearances of foreign nuclear powered warships into suitable U. S. ports, concurred in by you on 4 June 1964, has been followed. This procedure calls for acceptance of British nuclear powered warships into suitable U. S. ports under the same conditions as U. S. nuclear powered warships seek entry into British and other foreign ports - on the basis of a unilateral safety certification by the commissioning government and a demonstrated record of safety operation. These requirements have been met for the scheduled visits of HMS RESOLUTION. The British government has provided the necessary safety certification, and there is no information available which would bring into doubt the adequacy of the British assurances or the presumption of the ship's safe operating history. The required consultations between the Navy and the Atomic Energy Commission have been satisfactorily completed, and diplomatic clearance for the visits is being provided to the British government. Berthing and navigational requirements and port safety standards not covered by the assurances of the British government will be the same as those applied to U. S. nuclear powered warships.

The Atomic Energy Commission is advising the Joint Committee on Atomic Energy on this matter. A copy of this memorandum has been furnished to the Chairman, U. S. Atomic Energy Commission.

1. Clearance has been granted for a visit by DREADNOUGHT to Norfolk from 19 to 24 June. No other US port visits scheduled. Since this first visit foreign-owned nuclear-powered warship to United States, it is important that press questions dealing with nuclear safety and liability be handled in a manner which will not prejudice US policy as set forth in reference A. Any implication that we accepted DREADNOUGHT visit as safe only because we built her reactor plant should be avoided.

June. She will be berthed at the Naval Base.

The DREADNOUGHT is 244 feet long with a beam of 32 feet and a draft of 24 feet. She has a speed in excess of 20 knots and can dive to a depth greater than 400 feet. She displaces approximately 3,500 tons on the surface and 4000 submerged.

The DREADNOUGHT's armament consists of six torpedo tubes, capable of firing modern British and American torpedoes. Her sonar is of a completely new British design, comparable to the new sonars used in American submarines. She is fitted with British inertial navigation equipment. The DREADNOUGHT was laid down on 12 June 1959, launched on 21 October 1960 by Her Majesty Queen Elizabeth, and commissioned upon successful completion of sea trials on 17 April 1963. Since that time the ship has steamed over 20,000 trouble-free miles submerged -- a tribute to her builders as well as her crew.

The Captain of HMS DREADNOUGHT is Commander B.F.P. (Peter) Samberne, Royal Navy, already a veteran of three submarine commands. He heads up a roster of 10 officers and 77 men.

The last British ship to bear the name DREADNOUGHT was the battleship built in 1906 at the instigation of Admiral Lord Fisher to found a new concept in fighting ships. At that time she was the most powerful warship in the Royal Navy. UNQUOTE

3. In the event that press questions are received, addressees are authorized to draw on the following, the substance of which has also been provided to the British Government. Responses to questions on nuclear safety and liability should use the exact language given below and no further amplification should be provided.

Q: Upon what basis did the US Government permit entry of this ship, the first nuclear-powered ship of another nation to visit the United States?

A: The United States has accepted the DREADNOUGHT on the same basis that port visits of US Navy nuclear-powered ships are accepted in other nations: on the basis of a record of safe operation as well as safety certification, in this case, from the British Government.

Q: Has the British Government given assurance of financial liability in the event of a nuclear accident?

A: The two Governments have independently stated that any claims arising in such cases shall be dealt with through diplomatic channels.

Q: How much did the DREADNOUGHT cost?

A: About sixty million dollars.

Q: Does the Royal Navy intend to build more nuclear-powered submarines?

A: Two more attack submarines have been laid down and there are plans to construct others at a later date. In addition five POLARIS submarines have been ordered.

Q: If a Labor Government is elected in October, will this change the plans?

A: We have no information on which to base any statement.

MEMORANDUM FOR THE PRESIDENT

The nuclear-powered submarine H. M. S. DREADNOUGHT will visit Norfolk sometime during the week of June 19 - 25. In anticipation of the visit and the implementation of the Holy Loch Memorandum of Understanding, the Atomic Energy Commission and the Department of Navy have developed a procedure described in the attached letter from Chairman Seaborg to Secretary Nitze covering the clearance of foreign nuclear-powered warships for entry to U. S. ports. The procedure has been reviewed as appropriate by the Departments of State and Justice and the office of the Secretary of Defense as well as the Secretary of the Navy.

In my opinion, the procedure proposed for your approval is workable and consistent with the traditional Presidential prerogative to admit foreign warships to U. S. ports.

The Joint Committee was informed at the time of the execution of the Holy Loch Agreement that we intended to follow this approach with the UK in clearing their nuclear-powered warships and at that time the Committee made no objection.

If you approve, I will send the attached memorandum to the Department of Navy and the Atomic Energy Commission.
