MEMORANDUM FOR

MR. CHARLES JOHNSON

On second thought, I den't think we want to go back to Vance with a formal memorandum telling him to have one of his subordinates look the problem over. I think instead we ought to study the names and numbers of this program ourselves and perhaps have a talk with McNamara. I think either you or Spurgeon Keeny should do this.

ASW weapons do not give me as much concern as some others, and if this is essentially a continuation rather than a large-scale expansion, I would not wish to make and kind of issue of it.
