SUBJECT: Central American Export Program

Since your meetings with the Central American Presidents in early July, we have been working hard on AID and key US business groups to assist more energetically Central America's export diversification efforts.

AID sent a team of experts to meet with key Central American officials, following up talks that I had during your visit. The AID team included Mr. Amicus Most, ex-businessman who achieved outstanding success in Korea for AID in organizing an export promotion drive. Most is joining Covey Oliver's staff permanently to work on this problem and will be operating out of the Regional AID Mission in Central America. He has already been instrumental in getting a large group of US business concerns to work closely with AID to identify products which Central America can export successfully to the US or third country markets. David Rockefeller's Council for Latin America is deeply involved with us in this effort.

Although this is obviously a long-term program, the response from key Central American officials to your initiative has been enthusiastic. If we can keep up the momentum generated out of your trip, I think some real results can begin to appear in the near future. Central America is one region where the principle of economic integration is already well established. This export drive can help to guarantee its success.

Covey Oliver and his staff have cooperated fully on this effort and share our conviction about its importance. Nonetheless, to make sure no momentum is lost, I think it important formally to record your continuing interest and endorsement for this program. The attached NSAM, which has been cleared with both Bill Gaud and Covey Oliver, would achieve this objective. I recommend that you sign it.
