Creator: Capital Legal Foundation

Biographical sketch:

Capital Legal Foundation was a business-oriented public policy law firm funded primarily by industry and conservative foundations. Dan Burt was the president of the foundation and chief legal counsel.

Scope and content note:

This collection consists of video tapes and trial documentation describing the 1984 libel suit filed by General William C. Westmoreland. Westmoreland hired the Capital Legal Foundation, with Dan Burt as principal attorney, as representation to sue the Columbia Broadcasting System (CBS) concerning the network's production of the documentary, "The Uncounted Enemy - A Vietnam Deception." The trial resulted in an out-of-court settlement on February 18, 1985.

This collection consists of 212 video tapes and 116 linear feet of trial documentation, including transcripts, affidavits, depositions, and plaintiff and defense exhibits of U.S. government documents as well as books, newspapers, and magazine articles related to the trial or to the Vietnam War.

Only the boxes listed on this inventory have been fully processed; however, other boxes in collection--as listed in the original eighty-three pages accession record--can be made available to researchers after an archivist has reviewed them for declassification markings.
