## **SENATE PAPERS: Appointments and Nominations**

### **Scope and content note:**

The series contains correspondence, including letters and telegrams; memorandums; notes; briefs and statements in support of candidates; biographic information; summaries of testimony; published hearings; clippings; and other material.

It is arranged in four subseries. The first subseries includes material from 1949 through 1953 and is arranged alphabetically by the name of the nominee. The second subseries is also from 1949 through 1953, but is arranged first by the position in Texas, such as Federal Judges for various districts in Texas, U. S. Marshals, and other positions, with files arranged alphabetically thereunder by the name of the candidate. The third subseries includes folders pertaining to federal positions in Texas, 1953 and 1954, arranged alphabetically by the name of the position followed by folders arranged alphabetically for candidates for national as well as Texas positions. The fourth and last subseries is arranged alphabetically by the name of the candidates for appointment to various positions in 1955 and 1956.

### **About the subseries:**

#### **“APPOINTMENT FILES” I, 1949-53. Boxes 313-24.**

One of the functions assigned to the Senate by the Constitution deals with nominations. According to the Constitution, the President nominates and “by and with the advice and consent to the Senate” appoints certain officials of the Executive and Judicial branches of the federal government. Nominations to top level positions are usually referred to appropriate Senate committees and subcommittees; more routine nominations, such as those relating to

military appointments and promotions, postmasterships, and minor field positions are often confirmed in a group and without hearings.

It appears that about 1955, material dealing with nominations was no longer filed separately, but was placed in the "General Files" and the "Case and Project" Files. Some of this material was brought together to form a "Confirmations File" containing "General Files," "Case and Project" Files, and "Legislation – Nominations" Files. The "Confirmations File" appeared to have been a part of the LBJA Subject File, and during processing at the Johnson Library, it was returned to the LBJA Subject File, "Confirmations." After the files reorganization in 1958, correspondence concerning nominations was filed in the "Subject Files" under "Confirmations" and in the Case Files.

These files contain correspondence relating to Presidential nominees to federal and diplomatic positions, to appointees to federal and state positions in Texas, to a few applicants for appointment to patronage and other federal positions, and to applicants to other vacant positions. The files are arranged alphabetically by the name of the person or the title of the position. There are two or more envelopes relating to persons for whom there is a lot of correspondence and those who were considered for more than one position. Although envelope and folder labels frequently show only the name of the appointee, position titles have been added to the folder title list.

**"APPOINTMENT FILES" II, 1949-53. Boxes 325-33.**

The files contain correspondence about certain federal positions in Texas. The correspondence is in about 235 envelopes and folders arranged by title of position (Federal Judge, U.S. Marshal, Assistant Marshal, U.S. Attorney, Assistant Attorney, and Collector of Customs); thereunder by district (Eastern, Northern, Southern, and Western); and thereunder alphabetically by the name of the applicant or appointee. There are two or more envelopes or folders relating to people for whom there is a lot of correspondence and those considered for more than one position.

**"NOMINATIONS FILES," 1953-54. Boxes 334-35.**

The correspondence is similar to that filed in the "Appointment Files" I and II, 1949-53. Most of the letters bear the file designations "Legislation – Nominations" or "Legislation – Misc – Nominations." The folders pertaining to the nominations of District Attorneys and to U.S. Marshals were originally filed in the "General Files."

Folders pertaining generally to District Attorney, Judgeship, and U.S. Marshal Appointments are filed at the front of the collection, followed by alphabetically arranged folders for individual nominations.

**FORM LETTERS PERTAINING TO NOMINATIONS, 1955-56. Box 335.**

The six folders contain incoming correspondence and sample copies of outgoing form letters. These do not bear any file designation other than form letter numbers, and they may have been filed originally in a form letter file. The folders are arranged alphabetically by the name of the nominee.
