About the subseries:

OFFICE FILES OF GEORGE REEDY, 1951-55. 2 feet. Boxes 412-17.

The files include statements and releases, memoranda, Johnson speeches and speech drafts, speeches of others, a biographical sketch, Library of Congress research reports, brochures, clippings, publications, interviews of senators other that Senator Johnson, correspondence, and TV placards. The file contains very little correspondence, chiefly letters of transmittal. The material is in folders arranged alphabetically by subject or record type.

The series includes "George Reedy's Confidential Memo File," which is primarily memoranda to Senator Johnson. Mr. Reedy's memoranda covered a broad range of legislative, committee, and political subjects. Many pertain to Senator Johnson's role as Chairman of the Armed Services Preparedness Subcommittee. The memoranda were prepared in multiple copies and appear in several series of Mr. Johnson's papers. Some of the memoranda were drafted as speeches or as news releases. Those in this series include carbon copies of Reedy memoranda, some ribbon copies annotated by Senator Johnson, and memoranda from Willie Day Taylor to Mr. Reedy.

OFFICE FILES OF GEORGE REEDY, 1956-57. 3 feet. Boxes 417-25.

Mr. Reedy's files contain memoranda, speeches of Senator Johnson and others, speech drafts, press releases, clippings, agenda, publications, and correspondence. There is very little correspondence, chiefly letters of transmittal, but the collection does include correspondence

on the Mid-East with John Foster Dulles. Folders in the collection are arranged alphabetically by subject or record type.

A major portion of the file consists of "George Reedy's Confidential Memo File." These memoranda concern a wide range of topics including the 1956 campaign, civil rights legislation, the Sputnik hearings, the United States Information Agency, and the Mid-East. Many of the carbon copies of memos which are filed in folders by month can be found in folders for two or more months. No effort has been made to try to verify the accuracy of the dates memos were written or filed. Most memos have no date recorded; the only date is on the folder title.

OFFICE FILES OF GEORGE REEDY, 1958-60. 3 ½ feet. Boxes 425-35.

The series contains correspondence, memoranda, Senator Johnson's speeches and speech drafts and other people's speeches, radio and TV interviews, press releases, clippings, agenda, and publications. Material is in folders arranged alphabetically by subject and record type.

A large portion of the file consists of memoranda and statements filed chronologically. The memoranda concern a wide variety of topics including foreign affairs, labor, the 1960 presidential campaign, and civil rights. Multiple copies of many memoranda exist. Frequently, the same memo is filed in the chronological memo file and in subject folders. The same memo may also appear in folders for more than one month in the chron file. For additional 1960 material see "Office Files of George Reedy" in President Johnson's papers.

PERSONAL FILES OF GEORGE REEDY, 1955-60. 3 inches. Box 435.

The first folder in the personal file included correspondence, memoranda, statements, press releases, speech material from the Democratic Senate Campaign Committee, speech drafts, publications, biographies of several Senators, and Senate Joint Resolution 39, the Equal Rights Amendment. Although a few of the letters are personal, most of the material in the envelope concerns the 1956 campaign and other topics.

The second and third folders are primarily correspondence of George Reedy and concern personal matters.

At the end of the series is a folder of undated handwritten Reedy notes. These were found loose and unidentified among his files. They have been placed here.


