Daily log of Vice President Lyndon B. Johnson
Trip to Southeast Asia. -- Far East

May 9, 1961

8 a.m. EDT - Departed from Andrews AFB, Washington, D. C. Ambassador Sevilla-Saccasa; Ambassador from Viet-Nam; Ambassador Yeh of China; and others were present to see V.P. off. Made short statement.

For most of the trip Vice President and Mrs. Johnson stayed in their cabin with Mr. and Mrs. Stephen Smith (Mrs. Smith is sister of President Kennedy) and at various times visited with Senator & Mrs. Fong, Senator and Mrs. Long (Hawaii), and Congressman and Mrs. Inouye. Also visited at length with Ambassador Young, the newly appointed Ambassador to Thailand.

Stopover at Travis AFB, California for refueling. Toured base and had coffee with official party.

2:45 P.M. - Arrived Hickam AFB - Officially greeted, reviewed troops, and made short statement.

3:25 p.m. Arrived Iolani Palace to address Joint Session of the legislature.

4:25 p.m. - Ground-breaking ceremonies of East-West Center. Made short statement and participated in groundbreaking.

5:05 p.m. - Received Honorary Doctorate of Laws at University of Hawaii and made major address.

6:20 p.m. - Press Conference and reception at Royal Hawaiian Hotel. This was an informal conference and Mr. Johnson visited with the Press.

8:15 p.m. - Vice President and Mrs. Johnson attended the cocktail party in the garden of the Royal Hawaiian given by Mr. Jack Burns and Cong. Inouye. There were about 3,500 there and they informally visited in the garden with the guests.

8:45 - Dinner in Carousel Room of Hawaiian Village Hotel.
There were about 30 present with ~~Mr.~~ John Burns as host.
This was a rather informal party with groupings of 8
and the entertainment was provided by Art Lyman and
orchestra, Hawaiian dancers, etc.

10:45 - Mr. and Mrs. Johnson returned to the hotel and retired.

May 10, 1961

7:15 a.m. - Vice President and Mrs. Johnson and party
departed the Royal Hawaiian hotel and drove
to the Punchbowl Cemetery where the Vice President
laid a lei at the flag. Then the party drove
around the cemetery and back to Hickam Field.

8:00 a.m. - Vice President Johnson made a few remarks to the
press and then boarded the plane for the flight to
Saigon.
