Dear Mr. Hughes:

In response to your telegram of 27 September and my reply to you on 28 September, concerning the rehabilitation of oil drums damaged during hurricane "Carla," I forward the following information.

The Department of the Navy, Bureau of Supplies and Accounts, which has jurisdiction in this situation, reports that approximately 450,000 Government-owned 55-gallon drums were scattered throughout the Texas City area, blocking business and residential properties as well as roads. So this condition could be remedied, and the drums repositioned to meet emergency military demands, the drums were collected, rehabilitated, and replaced in their original storage area as expeditiously as possible. To accomplish this it was necessary to use every resource available in and around Texas City to collect and rehabilitate the drums.

I am informed that differences between the Local Painters' Union #585, and the Government contractor, were resolved on 30 September 1961, and work was resumed on 2 October 1961. It is my understanding that everything possible is being done to employ local labor on this project. I trust the work goes smoothly, and that future arrangements are handled favorably and to the advantage of everyone concerned.



Dear Mr. Hughes:

May I extend to the National Employment Association my warmest welcome to Fort Worth and to Texas.

The Annual Convention of the National Employment Association comes at a time when the manpower needs of our country are being subjected to the most rigorous appraisal in light of our national needs for the decade of the 1960's.

Careful studies show that the best employment outlook during the decade ahead will be in the technical and professional occupations, which will probably account for more than 13 percent of total jobs in the labor force by 1970, compared with about 10 percent in 1959. Within this area the National Employment Association can make a significant contribution by supplying the increased numbers of highly trained people needed to maintain our position of world leadership in science and the arts.

May I direct your attention to certain areas of weakness in our utilization of American manpower.

Many older workers -- some as young as 40 -- are experiencing difficulty in finding jobs despite high levels of experience and satisfactory performance. Automation is replacing many highly skilled workers prematurely. This invaluable source must be used fully during the decade ahead if we are to meet the needs of industry for ever increasing numbers of trained personnel.

During the 1960's the number of young people in the labor force will increase nearly 50 percent. By the late 1960's, 3,000,000 new young workers will enter the labor force each year, as compared

with 2,000,000 a year now starting their work careers. Altogether 26,000,000 new young workers will enter the labor force during the 1960's -- almost 40 percent more than during the 1950's. Here is a great challenge for the National Employment Association in fitting young people into useful occupations.

As Chairman of the President's Committee on Equal Employment Opportunity I want to stress particularly the great need to expand employment opportunities for Negroes. Unfortunately, many of our fellow citizens are denied employment opportunities not because of their lack of education or professional training, but simply because of their color. Many professionally trained Negroes are working far below their level of skill simply because of an arbitrary deprival of full job rights. Negroes with training as physicists, chemists, biologists, engineers and physicians must be brought into our work force at the full level of their skills if we are to meet the increasing demand for technically trained personnel that our country will experience during the 1960's.

The National Employment Association has made great contributions to our national well-being in establishing an orderly movement of workers into positions for which they are qualified. Our very national existence may depend upon the efficiency with which we utilize our great natural resource of workers during the decade ahead. I am confident the National Employment Association will respond to the challenge and turn in an outstanding performance.







You may be interested in knowing that I recently delivered to Chiang Kai-shek President Kennedy's assurances that the United States does not intend to recognize Communist China. The assurances were clear and unequivocal.

The question of continuation of the self-imposed ban of nuclear tests is under careful study. This ban, however, is not based upon the assumption that the Soviet Union recognizes principles of conduct similar to those to which we adhere, but on practical questions of whether it would help to mobilize world opinion in such a way as to place pressure on the Soviet Union. I am confident that this question will be resolved practically and in the best interests of the United States.


