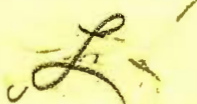

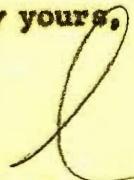

Thank you for writing to me and letting me know of your interest in legislation to provide medical care for our older citizens under the social security program.

This is a matter of top priority concern to our Administration and it is certainly good to know of your support. We tried without success to persuade the last session of Congress to approve such a bill.
