Biographical sketch:

Newton Weldon Edwards (b. April 5, 1916, Flemington, Georgia-d. July 16, 1985, Northern Virginia), rhododendron enthusiast, served in the Department of the Interior from 1950 until 1974. From 1953 onward he was the Staff Assistant to the Assistant Secretary of the Interior for Public Land Management. In this position, he had supervision over the Bureau of Indian affairs.

Scope and content note:

The Papers of Newton W. Edwards are arranged in their original order and contain 3 series.

Native-American Tribal Files Series

This series contains materials collected by Newton Edwards and includes correspondence, memorandums, reports, legislation, court documents, clippings, published materials, and notes. The subjects of this series pertain to Newton Edwards' primary responsibilities with the Department of the Interior handling Native-American affairs and working with the Bureau of Indian Affairs. These include Native-American rights, tribal organization, land rights, natural resources and resource rights, land management, resource management, social movements, civil rights, social protest, agriculture, and irrigation. This series directly relates to various Native-American tribes within the United States including tribes of Alaska, tribes of the Colorado River Region, Crow, Menominee, Navajo, and tribes of the Palm Springs region.
