So the Judge, Mariallen, Mr. Kellam, VM, MF departed in the big boat -- with MMV and Jack Valenti catching up and transferring boats to big boat in the middle of the lake later. So the big boat driven by Judge Moursund, and carrying everyone but the President and First Lady cruised up and down the lake followed by two secret service boats and about 20 family boats and two press boats. Word was received from the Secret Service that the President and the First Lady had decided to take a nap at the Haywood Place, and we were to do what we wanted to do. At the end of the boat ride the Judge pulled the boat into the dock, and invited all see-ers to come up and meet him. This was on the President's instruction that at the last minute we were to all show ourselves and let the press and onlookers see that the President and First Lady were not on the boat, and never had been on it.
