Photogs were gathered outside of the church for pics of the President and First Lady -they posed for pics and waved, then proceeded to their car, 11:53 President decided to go by and visit with the Melvin Winters' at their home just outside of Johnson City. On the way, they passed the family of A. W. Moursund and all joined at the Winters' residence for a cup of coffee. Mrs. Winters' was there and the ladies fixed a pot of coffee for the President, Mrs. Johnson, Judge A. W. Moursund, Mrs. Moursund, Mary Moursund, Will Moursund, Mary Rather, JV, vm -- (Mr. Winters' was at the office) JV checked in with WH operator at Ranch and asked for any troubles or phone dalls for President and then reported to the President that Mc George Bundy had called. He then decided that they had better return to the Ranch because -- "Oh, oh.... Mac Bundy is calling and he never has any good news." He asked vm to call WH at ranch to see if her parents and sister, Dunya, had arrived for lunch.... vm reported yes.... and the patty departed.
