	2:05				The President and guests returned to the main ranch house.	
	2:15	3:05			Lunch w/ Attorney General Katzenbach, Mr. Marshall, Mr. and Mrs. Charles Thompson, Congressman and Mrs. Geo. Mahon, Mr. and Mr. Charles Guy, Mr. and Mrs. Robert Whipkey, Horace Busby, Mr. J. E. Kellam, mf, vm	
	3:10				The President took all of the guests into the office where he handed out medallions 2 (small) and gold pens. Mrs. Mahon asked for the President's autograph for their 2 ch grandchildren and the President complied. He then asked mf to show the ladies around the house and that he would take the men. The gentlemen all followed the President and he led them to the hangar where the new firetruck was parked and took them all on a ride up and down the airstrip.	
	3:30				The President returned to the office w/ the gentlemen to watch a rerun of his morning press conf.	
	3:50				All of the gentlemen met w/ the President into the living room where the viewing was better. (Mrs. Johnson had arrived back meanwhile -- and the ladies were in the living room w/ her.)	
	4:15				The President took the gentlemen outside to sign blocks. (Mr. Kellam, mf, vm also signed them.)	
	4:30				The President, Attorney General Katzenbach, Mr. Marshall, Mr. Guy, Mr. Thompson, Congr. Mahon, Mr. Whipkey all went in one helicopter and the ladies in another w/ Mrs. Johnson over to the West Ranch for deer hunting. arriving at 4:38 pm	
	5:44				The Presidential party departed the West Ranch enroute to the Haywood Ranch at 5:51 pm There, the party went to the boats (Judge Moursund accompanied the party from the West for ranch for the remainder of the day) and went riding on the river.	
	6:52				The Presidential departed via chopper for the Moursund ranch arriving at 7:03 and dropped off the the Judge. and departed for the LBJ Ranch.
