The President began his day at (Place). Telephone Time Expendif or t Entry Activity (include visited by) ture No. Code LD In Out Lo Secv. and Mrs. Robert McNamara --8:12 Departed the Main House w/ and rode on the rancharea -- mainly around the Malachek home -- then returned to the Main House. To the Main House for a brief time -- and joined w/ Mrs. Johnson -- looked at the 8:48 red Ford car (about a 19); found that it was dirty needed charging of the battery and generally just did not run -- advised Sgt. Gaddis and Sgt. Glynn to wash it and have it operating satisfactorily. Departed the Main House area again and motored on the ranch -- then to the birthplace 8:51 arriving at9:26 am . The President and Mrs. Johnsonxsox showed the reconstructed home to the McNamaras and then departed at 9:34 am. Motored on the Ranch Road 1320 and Ranch Road #1--past the Scharnhorst Ranch still w/ the McNamaras. During this period, the President was in contact w/ MW over the radio telephone -RE: Visit of PM of Pakistan -- advised that GER should hold up press briefing -- and changed wording of message to the PM of Pakistan that was suggested by McG Bundy -- rE: postpo nement visit fr. spring of summe to next fall; then told MW to advised GER that the President and Secy. McNamata had had briefings, talked to Washington a couple of times and was now driving on the ranch areas. Was also in coimunication w/ Foreman Malachek over the radio telephone RE: working someof the ranch scrub instead of devoting all attention to the sheep Ten also advised Mr. Malachek on the working of the red car -- and that he coul not drive it.
