(Dinner was made informal for two reasons--Burmese national costume for the male appears to be a dress, hence the Chairman did not want to wear the national garb to the White House; and he also did not want to wear his military uniform--hence his request for informal dinner) The room was elegant, candlelight--chandelier turned low. An immediate spark of conviviality came from all three tables. The President gave a very warm toast to the Chairman and Madame Ne Win underlining the cause of Burmese independence and freedom respecting their neutrality in position.
