The White House

back to the White House from Church, the President asked Mrs. Johnson if she would like to take a ride over there to the Pentagon and see what they were doing. At the Lincoln Memorial, it looked like there were about 150 people sitting on the steps -- just scattered around the area. We drove around the Memorial one and one-half times -- looked at the Mall area and the reflecting pool area. Mrs. Johnson particularly noticed the litter and refuse left by those gathered at the Memorial yesterday. The President was highly interested in what a ~~happy~~ hippie looked like, their dress, age groups, and items they carried...some were carrying flags, bed rolls, blankets, flight bags, flowers...We then drove across Memorial Bridge and turned down Shirley highway--the road was blocked, but we told the Park Policemen we were secret service, and they let us through. We went around the blockade and up the highway, ~~look~~ looking to the right and left -- right up to the line of soldiers guarding the highway. We drove slowly, and looked carefully at the Mall Entrance of the Pentagon -- we circled around, crossed the median strip, and then drove back to the White House.
