2/3	Majority of Texas delegation in the House followed Eugene Worley's lead in test vote on federal ballot for absentee servicemen. 12 members, LBJ, supported Worley's federal bill when they voted force an on-the-record roll call; vote fails, 233-160.
2/7	Congress passes \$2 billion tax bill, 8 [billion?] short of the amount requested by the administration.
	Rumors in Texas that LBJ won't run for re-election.
2/13	Becky Alexander is born in Fort Worth.

2/14	Jimmie Allred writes LBJ letter of thanks for treatment LBJ gave him in
	Washington when he was there and for "wonderful gathering out at your home."

- 2/16 Banquet of New Dealers in Austin, attended by Texas federal, state and county officials, and members of the Texas bar sympathetic to the fourth-term campaign. Speakers included Dan Moody, Jimmie Allred, Tom Miller, LBJ, Alvin Wirtz.
- 2/17 Death of Rep. Schuetz (D-III.) elevates LBJ to fourth-ranking member of Naval Affairs Committee.

Early 1944 (maybe Late 1943)

LBJ worked with Gus Mauerman, mayor of San Antonio, trying to get a West Texas airline linking Houston, Austin, San Antonio and El Paso. Their efforts were unsuccessful.

- 2/18 FDR vetoes anti-subsidy bill, then wins enough support in the House to sustain the veto. LBJ, in Texas, was paired to vote to sustain the veto.
- 2/22 FDR vetoes tax bill.
- 2/24 House overrides FDR's veto of tax bill. Senator Alben Barkley resigns as majority leader in break with FDR over veto, is immediately re-elected. Senate votes to override the veto the next day.
- 2/26 Democrats meet Saturday night at Hotel Adolphus, call for continuation of national Democratic leadership, lash out at Republicans. Headline speaker: Robert E. Hannegan, chairman of Democratic National Committee. Other speakers included: Harry Truman, Coke Stevenson, Ed Pauley, Myron Blalock, W.A. Brooks, Hatton Sumners and LBJ. The dinner climaxed a month-long fundraising drive for the DNC.

Early March

Pat Adelman chosen as general manager of KTBC; Harfield Weedin enters service.

- 3/4 LBJ "just returned from a brief jaunt in Texas."
- 3/9 Wirtz writes LBJ that he has heard bad reports about the situation in Sam Rayburn's district. Herman Jones reports to Wirtz that if the election were held now Rayburn would lose. Oil men are putting on a terrific drive to defeat Rayburn.

3/15 3/19	House passes the "states-rights" soldier vote bill and sends it to FDR. Lynda Bird Johnson born at Garfield Hospital, 7 lbs 7 oz. CTJ and Lynda will be in hospital a week. Aunt Effie and Mrs. Sam E. Johnson are visiting.
	John Connally is recovering from emergency appendectomy.
3/26	After conference with War Food Administrator Marvin Jones, LBJ announces that WFA will begin an emergency egg buying program throughout Texas on Monday to insure producers a return of 26 cents/dozen. LBJ says price would fall to 20 cents/dozen without relief.

4/5	LBJ helps Gene Autry get transferred to Air Transport Command.
4/8	LBJ to Raymond Brooks: LBJ reports that CTJ is not feeling well, the baby does not know the difference between night and day, LBJ got food poisoning and Zephyr Wright has appendicitis; LBJ her to the hospital. LBJ is on his way home to nurse and cook.
4/12	After conference with Marvin Jones, Fred Vinson and OPA officials, LBJ announces that federal price authorities have tentatively agreed to a 2 cents/lb. ceiling increase on the price of poultry.
4/13	LBJ has just been appointed as a member of a special committee, Post-War Military Policy Committee, and "we have our first meeting tomorrow." He expects "this to be the most important committee in Congress for many years."
	Congress had a short Easter recess, but LBJ did not go home because CTJ and Lynda had not yet left the hospital and he did not want to leave them.
4/15	LBJ writes Herman Brown: "After spending last month at Army and Navy I think we are going to get good news for Regs Robbins probably next week; Don't notify your Fort Worth New Deal friend yet but don't let him get his check back."

5/17	Senate confirms nomination of James Forrestal as secretary of the navy.
5/20	LBJ in Dallas, en route to Austin, where he is met by Ed Clark, one of the leaders of the group seeking an instructed delegation for FDR. LBJ will spend 2 or 3 weeks in his district.
5/23-5/24	Texas holds two rival, irreconcilable Democratic conventions after party splits sharply on whether or not to send a delegation to the national convention instructed for the re-nomination of FDR. LBJ leaves regular Texas convention and joins FDR supporters, was making plans to attend the national convention.

7/20	LBJ in Elgin. Both Texas delegations are seated at the National Convention. Texas' 48 votes are split between them. Later Texas cast 36 votes for FDR and 12 for Harry Byrd.
	Democratic National Convention adopts platform and re-nominates FDR, who accepts in a radio speech from a naval base on the Pacific Coast.
7/21	Democratic National Convention nominates Senator Harry S. Truman of Missouri for vice president.

Gromyko, the Russian ambassador, and Sir Alex Cadogan, British Permanent Under Secretary for Foreign Affairs.

11/3	American Association of University Professors scores UT regents action, plans intervention. Students continue protest. Faculty reaffirms confidence in Rainey.
