Late January – Early February

Over the opposition of Austin City Councilwoman Emma Long [and?] organized labor, Herman Brown gets a \$68,900 contract for the city power plant in Austin.

Admiral Forrest P. Sherman is confirmed as Chief of Naval Operations, after his nomination was at first blocked by Senator Joseph McCarthy. Senator Millard Tydings declared the opposition a "sham battle" raised by Republicans to make political capital.

1/25 The Senate passes a resolution for a proposed constitutional amendment guaranteeing equal rights for women, but no action is taken on the measure in the House.

Alger Hiss is convicted of perjury and sentenced to five years in a federal penitentiary. Secretary of State Dean Acheson, when asked about the Hiss conviction in a news conference, tells reporters "I do not intend to turn my back on Alger Hiss."

6/30	The Senate unanimously approves LBJ's bill providing for a five-year extension of the government tin smelting program at Texas City.

7/2	Marion Storm dies after a car wreck in Temple.

7/10	Senate confirms Pike's nomination 55 to 24; LBJ votes to confirm Pike.
7/12	LBJ makes speech on Senate floor underlining the gravity of the Korean situation and suggesting a program of action.

7/27	Senator Tydings appoints a watchdog subcommittee of the Armed Services Committee and names LBJ as chairman. Other members include Senators Saltonstall, Morse, Bridges, Kefauver, Virgil Chapman and Lester Hunt.
7/29	LBJ writes Sam Houston Johnson in Mexico City that CTJ is going to Texas next week. He also writes: "Nobody knows when we will recess here I am chairman of a new Watchdog Committee of Armed Services, and we have our first meeting on Monday." Josefa and Rodney are living in Washington, and Josefa is working in the Senate office.
7/31	First meeting of the Senate Preparedness Investigating Subcommittee. Donald Cook, vice chairman of the SEC, is serving without pay as the subcommittee's chief counsel and brain-truster on a part-time basis.

8/25	Faced with an impending railroad strike, Truman issues an executive order seizing the nation's railroads. The U.S. Army operates the railroads until 5/23/52.
8/29	LBJ issues a statement calling for reduction of non-defense costs. He says that he has long championed rural roads, yet voted for the Byrd amendment to reduce appropriations for primary and secondary roads. He also voted to reduce non-defense items in the Omnibus Appropriations Bill by 10 per cent and supported the order to the Bureau of the Budget to trim \$550 million from non-defense funds.

Truman addresses the American people on the grave danger facing the nation because of the events in Korea. The next day he declares a state of national emergency, and on 12/18 he asks Congress for emergency legislation.

12/21 Senate, in a voice vote, confirms Anna Rosenberg as assistant secretary of defense, after the Armed Services Committee dismisses as wholly unfounded the charges that Rosenberg attended Communist Party meetings in 1935.

Late December

There is speculation in the press that LBJ will be elected Democratic whip to replace Francis Myers, who was defeated in the November elections.

The Johnsons spend Christmas in Washington. LBJ later writes a constituent that "Lady Bird, the girls and I enjoyed a quiet Christmas here in Washington. The work kept moving right along with a meeting of Congress, as you likely noticed, on New Year's Day. Walter brought his family back from Texas last weekend, and they are all well and doing fine."
