1951 Chronology

January 1/2 **LBJ (Lyndon Johnson)** is elected Democratic whip, and Ernest McFarland is elected Democratic majority leader. 1/3 Congress convenes. 1/5 Senator Taft delivers a speech attacking the Truman Administration's foreign and military policies, saying that the U.S. should not become involved in a European or Asian land war, and charging Truman with usurping the power of Congress to declare war by involving U.S. troops in Europe and Asia. 1/6 At Truman's request, LBJ, McFarland, J. Percy Priest and John McCormack meet with Truman at 10:45 a.m. Truman had just held a meeting with General Eisenhower, who is leaving today for Europe. Luci and Lynda host a birthday party for Speaker Rayburn during the afternoon. That evening the Speaker and Miss Lou Rayburn attend a reception in his honor at the Women's National Democratic Club. They also attend the traditional birthday dinner in his honor given by long-time friend and recent widow, Mrs. J.L. Aston. In the late evening, Rayburn and LBJ attend the annual stag awards dinner of the Touchdown Club. 1/8 Truman delivers his State of the Union message to Congress. 1/10 Charles I. Francis is in Washington. Senate Armed Services subcommittee chaired by LBJ opens hearings on the draft. General Marshall testifies, accompanied by Assistant Secretary of Defense Anna Rosenberg. Hearings are held both morning and afternoon, when Senate business permits it, until 1/27/51. 1/12 Alvin Wirtz is in Washington, and the Johnsons have dinner at the Carlton Hotel with Wirtz and George Brown. 1/13 CTJ attends a meeting of the Business and Professional Women's Club. 1/16 LBJ and Truman attend a party at Clark Clifford's home. Truman asks LBJ to come see him soon. 1/18 The Air Force calls up 150,000 reserves and National Guard forces to active duty, and gives Congress the choice of drafting 18-year-olds or fathers and non-veterans ages 19-25. Defense Department favors draft of 18-year olds.

1/19	CTJ (Lady Bird Johnson) attends a luncheon given by Mrs. Fritz Lanham in honor
	of Miss Lou Rayburn.

LBJ attends stag dinner in honor of the President, hosted by George H. Baker of Business Magazine Editors Association.

- 1/23 LBJ is scheduled to meet with Truman, but cancels. Later that day LBJ hosts dinner for John Connally, Cameron McElroy and Ray Roberts.
- 1/26 The Economic Stabilization Agency orders a wage price freeze.
- 1/27 LBJ and other members of the Senate Democratic Policy Committee meet with Truman at Blair House. Also present were Leslie Biffle, secretary of state, Felton Johnston, secretary to the majority, and David Stowe, administrative assistant to the President.

LBJ issues a statement listing recommendations that the Preparedness Subcommittee will make on the draft bill: 1) lower standards to draft a larger number of men that are now classified 4-F; 2) require non-veteran, non- fathers ages 19-26 to be eligible for military service; 3) require definite provisions that when and if 18-year olds must be drafted, older ones go first.

Senator Wayne Morse demands an investigation by the Senate Armed Services Committee of training conditions at Lackland A.F.B. in Texas. The next day Eugene Zuckert, John Connally, Horace Bushy, Mark Galusha and Lyon Tyler are sent to Lackland by the Preparedness Subcommittee to investigate the allegations.

- 1/28 CTJ and LBJ attend a Texas State Society reception honoring the Texas delegation at the Women's National Democratic Club.
- 1/29 CTJ attends a luncheon at the Women's National Democratic Club where Joe Alsop is the guest speaker.
- 1/30 Speaker Rayburn sets an all-time record for his term of service as speaker of the House. Truman honors him at a special ceremony at his White House office, and LBJ, Miss Lou Rayburn, Tom Connally, Alben Barkley and Fred Vinson attend. Later that day Rayburn hosts a dinner at the Carlton Hotel in honor of Miss Lou.

February

2/1 Truman telephones LBJ concerning the wildcat railroad strike.

Eisenhower addresses an informal joint session of Congress in the Library of Congress and emphasizes the need for U.S. assistance for Europe. The next day

he testifies before the Senate Preparedness Subcommittee and House Armed Services Committee, lunches with LBJ, and makes a TV and radio address in support of the NATO alliance and insists American troops are needed in Europe.

Johnsons attend party hosted by Jacqueline Cochrane at The Statler.

- 2/2 LBJ writes his mother that his health is improved, but nearly everybody in the family has been sick and Zephyr has been in and out of the hospital. Josefa has started business college.
- James Rowe and Tommy Corcoran advise LBJ of an attempt by George Brown and Charles Francis to have Mr. Hargrove appointed head of the Natural Gas Section of the Department of Interior, where he would have control of allocations. They have blocked the appointment and ask LBJ not to get involved on either side.
- 2/11 The Dallas Morning News reports that LBJ says a survey will be made soon to see how many combat-qualified men in the Armed Services can be moved into field forces by giving jobs to women.
- 2/14 After hearing 100 witnesses in 37 sessions, LBJ reports the draft bill (S. 1) to the Armed Services Committee.
- 2/15 The Senate Armed Services and Foreign Relations Committees begin public hearings on the plan to send four divisions to Europe (in addition to the two divisions already there). Secretary Marshall and the Joint Chiefs of Staff object to Congress placing any troop limitations on U.S. forces.
- 2/18 The Senate Preparedness Subcommittee issues a report criticizing the Air Force for a "total breakdown" in basic training at Lackland Air Force Base. The breakdown was a result of overcrowding due to the attempt by the Air Force to "hoard" manpower.
- 2/20 Former Senator Tydings and Senator Butler testify before the Senate Committee on Privileges and Elections, which is conducting an investigation into charges that Butler supporters circulated false and misleading statements and a composite photo of Tydings with Community Party leader Earl Browder. In August the Committee reports that Butler was guilty of running a "back street campaign" and that Senator McCarthy was a leading force in the campaign against Tydings.
- 2/27 LBJ makes a speech on the Senate floor in support of the draft bill.

	The Senate Armed Services and Foreign Relations Committees report out two resolutionsneither having the force of lawapproving Ike as NATO commander and a "fair share" contribution of American forces to Europe. The Senate passes the resolutions on April 4. Truman calls it a "clear endorsement" of his troop plans.
3/19	Lynda's birthday party [at S402?].
3/23	LBJ is in Bethesda Naval Hospital with a heavy cold and bronchial condition.
3/24	After being advised that Truman plans to invite Korean truce talks, General MacArthur issues his own offer to "confer in the field." This in effect torpedoes Truman's plan.
3/26-3/28	Betty Ann West is visiting in Washington.
3/30	The Johnsons have dinner with John Connally, then later attend a reception at 10:30 p.m. at the French Embassy for President Auriol of France.

- 4/23 Pickle writes LBJ that E.H. Perry has had a minor stroke and is in poor health.
- 4/25 Anna Rosenberg speaks at the 81st Club luncheon.
- 4/26 CTJ takes Bess Beaman, Mrs. Rowe, and Mrs. Ed Kilman to the Texas Ladies luncheon.

LBJ writes H.L. Hunt that he has been receiving as many as 4000 letters a day on MacArthur's removal. The Armed Services Committee will begin hearings on the incident on May 3 with MacArthur as the principal witness.

4/30 Iran nationalizes the oil industry and expropriates property of the Anglo-Iranian Oil Company.

The "Big Four" (Rayburn, McCormack, McFarland, and LBJ) meet with Truman at the White House.

May

- Joint committee hearings open on MacArthur firing with MacArthur as the first witness, testifying from May 3-5. He states that the war would have been "100% different" if Chinese Nationalist troops had been used, and that Red China would have sued for peace if his plan for all-out air attacks would have been accepted. He denied charges that the attacks would have brought Russia into the war. Two days later General Marshall challenges MacArthur's assertion. LBJ issues a statement on May 6 praising the bipartisan spirit of the hearings.
- 5/5 Mrs. Sam Johnson and Diana Taylor are visiting in Washington.

Children's party at the Congressional Club.

- General Omar Bradley testifies before the Senate committee investigating the firing of General MacArthur, and says that MacArthur's plans would have put the U.S. "in the wrong war, at the wrong time and with the wrong enemy." After hearing numerous witnesses, the committee votes on August 17 not to make a formal report on its investigation.
- 5/16 LBJ, Lister Hill, O'Mahoney, Blair Moody, Percy Priest, Mansfield, Sidney Yates, William Dawson, John Shelley, Richard Bolling, David Stowe, and John Carroll attend an off-the-record meeting with Truman at Blair House.

Senate passes a conference report on the Tidelands bill. The bill would give the states title to undersea lands out to the 3-mile limit, or in the case of Texas and Florida, the 10 1/2-mile limit with which those states claimed to have entered the union. Truman vetoes the bill on 5/29, saying that it "makes a free gift of

immensely valuable resources which belong to the entire nation to the states which happen to be located nearest them." No attempt is made to override the veto.

Late May

The Saturday Evening Post publishes an article about LBJ as a possible vice presidential nominee in 1952.

June

- 6/7 LBJ and Tom Connally meet to discuss appointments for the federal district attorney position for the Western District of Texas. Connally agrees to support LBJ's nomination of Charlie Herring for the post.
- 6/9 CTJ's calendar notes: "Mrs. Johnson and Lynda may leave."
- 6/10 LBJ issues the twenty-sixth report of the Preparedness Subcommittee, criticizing the use of able-bodied men for desk jobs in the armed services.
- General MacArthur is scheduled to visit Austin and will address the Texas legislature. He is also scheduled to visit Houston, San Antonio, Dallas and Fort Worth on the following days. Pickle wrote LBJ on June 4: "There is no enthusiasm here for the General's visit....do not believe he will have any of the Eastern seaboard hysteria."
- 6/19 LBJ and other congressional leaders are present at the White House when Truman signs S.1, the draft and Universal Military Training bill. At Anna Rosenberg's suggestion, Telenews films the event and a copy of the film is given to LBJ.
- 6/23 LBJ speaks at a luncheon honoring Judge Joe Sheehy in Tyler.
- 6/25 LBJ makes a speech welcoming the 27th Fighter Wing to Austin.
- The Senate rejects an amendment to its pending price control bill, which would have limited the administration's power to roll back the price of live beef and other commodities. LBJ and Tom Connally vote against the amendment. The Senate therefore ratifies a provision declaring that the price must not be reduced below prevailing levels in January and February of 1951.

(In early July Jake Pickle writes LBJ about rumors circulating in Texas that Sam Houston is buying up cattle in Mexico to sell in Texas when rollbacks or stricter controls are established: "I realize that your vote last week in itself ought to be sufficient proof against such absurd rumors." LBJ asks Pickle to find out who started the rumors and is spreading them.)

Walter Jenkins resigns as LBJ's administrative assistant in order to enter the 13th Congressional District race. A special election will be held September 8 to fill the vacancy created when Ed Gossett resigned to accept a position with Bell Telephone Company. Frank Ikard, Wayne Wagonseller and Doug Crouch have also entered the race. Ikard wins the election on September 8.

6/28 LBJ and Senator Connally agree on nominations for district attorneyships in Northern and Southern Districts of Texas. Connally nominates Frank Potter for the Northern District, and LBJ nominates Brian Odem for the Southern District of Texas.

Summer The Johnsons purchase the Ranch sometime during this summer.

July

- Mid-July Jake Pickle and Bess Beaman are scheduled to start a letter-writing campaign to key women workers in order to keep up a working organization for LBJ.
- 7/10 LBJ cables JBC that Senator Russell will complete hearings on Friday and LBJ may then go to Bracketville.
- 7/12 LBJ, other congressional leaders meet with Truman in Cabinet Room at 10 a.m.
