Cohen was a legislative attorney in the Office of Chief Counsel for the Internal Revenue Service (IRS) and served as Chief Counsel and Commissioner of Internal Revenue for the IRS und Lyndon B. Johnson. Mr. Cohen has been a lecturer for Howard and George Washington Universities and has served with numerous boards, committees, and non-profit organizations.
