# Biographical sketch:

E. Ernest Goldstein (b. 1918) was with the War Claims Commission from 1947 to 1950, was associate counsel to the Special Crime Committee in the U.S. Senate from 1950 to 1951, general counsel to the Antitrust Subcommittee in the U.S. House of Representatives from 1951 to 1952, and worked as a restrictive trade practices specialist for the Foreign Operations Administration in Paris, France, 1952 to 1953. Goldstein was Special Assistant to President Lyndon B. Johnson from 1967 to 1969, and served as counsel (1966-1967) and partner (1969-1979) for the firm of Coudert Freres in Paris, France.

#### Scope and content note:

This collection pertains to Ernest Goldstein's personal and professional life as an educator and attorney. This collection includes material related to his positions as Special Assistant to President Lyndon B. Johnson, as an attorney in Paris, France, Chair of the advisory board for the Business Alliance for Vietnamese Education (BAVE), and his friendship with the Johnson family. The collection includes correspondence, letters, and memorandums; statements and speeches; clippings, journals, articles, and publications; diaries and photographs; notes, agendas, invitations, and itineraries; reports; meeting minutes and meeting material; drafts; and finance and budget information. There is a small amount of correspondence with Lady Bird Johnson.
