



NAB COLONEL IN MORALS CASE

Washington, D. C.

An Army Lieutenant Colonel with some White House liaison functions has been hospitalized after arrest here on a morals charge similar to that involved in the Walter Jenkins affair.

It was learned Wednesday that the 42-year old officer was assigned to the personal staff of Secretary of the Army Stephen Ailes.

October 6 Arrest

Records at the District of Columbia Metropolitan Police Department show that the officer was arrested on October 6 at 9:10 P.M. -- less than 24 hours before the arrest of Jenkins. The man was charged with disorderly conduct (loitering) and posted a \$25.00 bond, which he forfeited.

The Police Department records state that he was in the YMCA at 1736 - G - Street, N. W., where he engaged in conversation with a Morals Squad detective, L. P. Drouillard, and suggested that they go for a ride. Later, Morals Squad Lt. Louis A. Fochett drove up where the Army Lt. and Drouillard were parked on a side street near the Lincoln Memorial and two Morals Squad detectives made the arrest.
