#### Biographical sketch:

Everett Hutchinson (1915-1994) was Assistant Attorney General for Texas from 1949 to 1951, Commissioner for the Interstate Commerce Commission (ICC) from 1955 to 1965, and Chairman of the ICC in 1961. He was President of the American Business Association from 1965 to 1967, and Under Secretary of Transportation from 1967 to 1968.

#### Scope and content note:

This collection contains both personal and office files, as well as books and publications collected by Everett Hutchinson. The bulk of the material consists of correspondence, memorandums, invitations, articles, speeches, financial records, meeting minutes, personnel and administrative records, studies, reports, and legal records reflecting Hutchinson's responsibilities as Commissioner and Chairman of the Interstate Commerce Commission and Under Secretary of Transportation. The collection contains two series (Personal and Office Files & Books and Publications).

Personal and Office Files Series: This series contains the personal and office files collected by Everett Hutchinson. Most of the material reflects Hutchinson's responsibilities as a Commissioner and the Chairman of the Interstate Commerce Commission and as Under Secretary of Transportation. The series includes correspondence, articles, photographs, invitations, personal financial records, speeches, meeting minutes, memorandums, studies, reports, legal records, and personnel records. The bulk of the series relates to transportation, business, and law practice, but also includes material on travel, personal finances, office administration, personnel management, committee meetings, government operations, and regulatory processes. There is also material concerning the American Bar Association, the Railroad Commission of Texas, and the Administrative Conference of the United States.
