Biographical sketch:

Alan Stephenson Boyd (b. 1922) was a member and Chairman of the Civil Aeronautics Board, from 1961 to 1965, Under Secretary of Commerce for Transportation from 1965 to 1967, and Secretary of the Department of Transportation from 1967 to 1969. After leaving the Federal government, he served as an executive in the transportation industry.

Scope and content note:

The Personal Papers of Alan S. Boyd reflect his service as a member of the Civil Aeronautics Board, as Under Secretary of Commerce for Transportation and as Secretary of Transportation. They contain material on such subjects as airline safety, commercial airline scheduling, rates and routes, highway construction, the development of the SST, urban mass transit, and high speed ground transportation. This Boyd papers are composed of two series (Correspondence Files and Personal/Office Files).

The Correspondence Files series includes Boyd's letters, invitations, clippings, and articles. It contains both professional and personal matters including invitations to public speaking engagements, acceptance and regrets for these invitations, and congratulatory letters to Boyd on his appointment as Secretary of the Department of Transportation.

The Personal and Office Files series contains materials collected by Alan S. Boyd during the course of his time as a member of the Civil Aeronautics Board, as Under Secretary of Commerce for Transportation, and as Secretary of Transportation. The material includes schedules, calendars, correspondence, reports, speeches, articles, statements, and press releases reflecting Boyd's various responsibilities in these positions. Some of the subjects represented in this series are transportation, transportation safety, airline safety, commercial airlines and commercial airline scheduling, transportation rates, transportation routes, research and development, environmental issues, budget, aviation, highway construction, urban mass
