Biographical sketch:

Bertrand M. Harding was born in Fort Worth, Texas, on February 19, 1919. He received an A.B. Degree from Antioch College in 1941 and studied Public Administration at the University of Minnesota from 1941 to 1942. He graduated from the National Institute of Public Affairs in 1942.

Harding was an analyst for atomic weapons program at the Atomic Energy Commission from 1950 to 1953, assistant to the Deputy Commissioner at the Internal Revenue Service (IRS) from 1953 to 1954, Assistant Director of the Collection Division at IRS from 1955 to 1958, Assistant Commissioner for Planning and Research at IRS from 1958 to 1961, and Deputy Commissioner at IRS from 1961 to 1966. Harding served as Deputy Director of the Office of Economic Opportunity from 1966 to 1968 and Acting Director from 1968 to 1969. He was associate administrator of the Federal Aviation Administration from 1970 to 1973.

Scope and content note:

This collection reflects Bertrand M. Harding's government service at the Internal Revenue Service and at the Office of Economic Opportunity. This collection contains reading or spindle files, conference materials pertaining to conferences held in Washington, D.C. and nationally, notes and other research material, diaries, appointment calendars, publications, as well as office materials including correspondence, memorandums, and reports. This material pertains to budget, planning and research, property depreciation, automatic data processing, and personnel administration.
