Biographical sketch:

Alfred Bradley Fitt (was Deputy Secretary of the Army for Manpower from 1961 to 1963, Deputy Assistant Secretary of Defense for Civil Rights from 1963 to 1964, general counsel for the Department of the Army from 1964 to 1967, and Assistant Secretary of Defense for Manpower and Reserve Affairs from 1967 to 1969. Fitt served as special advisor to the President of Yale University from 1969 to 1975, and was general counsel for the U.S. Congress Budget Office from 1975 to 1992.

Scope and content note:

This collection consists of papers collected by Alfred B. Fitt related to his duties as Assistant Secretary of Defense for Manpower and Reserve Affairs during the Lyndon B. Johnson administration. The correspondence files contain information on various manpower and reserve activities, including the Selective Service, Project Transition, Project 100,000, Project Volunteer, ROTC programs, recruiting, and military open housing. Personal files include speech materials, travel files, public appearances, and notes. There are also subject files pertaining to Fitt's involvement with the John F. Kennedy gravesite and the internment of Robert F. Kennedy at Arlington National Cemetery.
