Biographical sketch:

Warren Christopher served as Deputy Attorney General during the Lyndon Johnson administration and as Deputy Secretary of State during the Carter administration. As Deputy Secretary of State, he handled the negotiations for release of the Americans held hostage in Iran. He also served as Secretary of State during through the first years of the Clinton administration.

Scope and content note:

This collection consists of correspondence, memorandums, reports, and drafts collected by Warren Christopher during his service as Deputy Attorney General of the United States. The correspondence portion primarily contains copies of memorandums from Attorney General Ramsey Clark to the President and memorandums from the White House received by Warren Christopher. In addition to this correspondence, there is material concerning crime; crime prevention, the Vietnam War; civil rights demonstrations; peace demonstrations and movements; and riots in Los Angeles, Washington, D.C., and Detroit. There is also information on various commissions including the National Advisory Committee on Civil Disorders and the National Commission on the Causes and Prevention of Violence; task forces; and legislation dealing with crime and civil disorders. The series also includes a small amount of material concerning the Democratic National Convention in Chicago in 1968 and information on the nominations of Abe Fortas and Homer Thornberry to the Supreme Court and the subsequent Senate hearings.
