Scope and content note:

This collection consists of primarily of correspondence and memorandums reflecting Henry Hall Wilson, Jr.'s role as an Administrative Assistant to the President in the White House Office of Legislative Liaison. Wilson acted as a liaison between the President and members of the United States House of Representatives until leaving the staff in 1967. The collection concerns administration efforts to lobby for legislation, congressional requests for action on public works projects, endorsements from Congressmen for people they recommend be appointed to positions within the administration, Congressional requests for messages, autographs, and photographs from the President, and communications from Congressmen which were intended for the President. In addition to correspondence and memorandums, the collection includes clippings, reports, a few copies of legislative bills, lists, agenda, speeches, fact sheets, press releases, publications, and biographic information.
