#### **Biographical sketch:**

Ray Roberts (b. Herbert Ray Roberts), served on the staff of Speaker Sam Rayburn of the U.S. House of Representatives, and was a member of the Texas State Senate. On January 30, 1962, he was elected to the U.S. House of Representatives by special election, to fill the vacancy caused by the death of Sam Rayburn. Roberts was reelected nine times, serving until January 3, 1981.

#### **Scope and content note:**

This collection consists of invitations, correspondence, letters, memorandums, lists, press releases, clippings, and reports collected by Ray Roberts during his career in the Texas State Senate. The materials relate to a wide variety of state-related business including land, labor, water, education, and health. In addition, there is some information related to Roberts' service as Governor for a day, President Pro Tempore, and Chairman of the Cost of State Government Committee.
