Scope and content note:

The collection consists of material collected by Harry McPherson while serving in the White House as a Special Assistant to the President, from 1965 and 1966, and as Special Counsel to the President from 1966 to the end of the Johnson administration. The documents relate to his responsibilities, including speechwriting; legal review of executive orders, proclamations pardons, requests for clemency and Civil Aeronautics Board decisions involving international air routes; review of legislation submitted to the President by Congress for signature; advising on matters of policy and law raised by executive departments and agencies; assisting in the preparation of domestic legislation; and advising on the handling of civil rights issues.

The collection is divided into 5 series. The Subject Files are a variety of materials organized by topic. Correspondence Files include between letters and memoranda between McPherson and the President, Vice President, First Lady, White House Aides, and other officials. The Statements and Speech Files include drafts, transcripts, and backup materials related to remarks written for the President. The Briefing Materials and Reports File contains published and unpublished materials intended to provide information to the President and his Cabinet. The collection also includes Backup Material for Presidential Speeches on Vietnam files.
