Scope and content note:

This collection consists of materials collected by W. Marvin Watson during his time as Special Assistant to President Lyndon B. Johnson, in his role as White House Chief of Staff, and later, Postmaster General. The materials reflect Watson's knowledge of and work in Democratic Party politics and his involvement in campaigns across the country. Included are political files on individual states and regions that cover presidential, senatorial, gubernatorial, and local elections.

The State Files contains political material from states and regions, with an emphasis on the 1968 presidential campaign. There are Subject Files on politicians of note, Johnson staffers, and key issues facing the electorate. The Chronological Files contain outgoing memorandums and letters from Watson's time as Special Assistant to President Johnson and in his role as White House Chief of Staff. The Campaign Helpers Files consist of responses to people from across the United States offering assistance on political campaigns along with campaign publications and Massachusetts election statistics for 1960 and 1964. Department of Defense forms contain Department of Defense Forms 214 (discharge papers). Security Classified Documents from the Office of the Postmaster General are not available for research.
