Ross DeWitt Netherton, Jr. was a lawyer who served with the Commission on Highway Beautification, the Federal Highway Administration, and the Department of Transportation.

Scope and content note:

This collection consists of papers collected by Ross D. Netherton related to his service as a legal expert for the Highway Beautification Commission and the Federal Highway Administration. The papers contain publications, correspondence, reports, and hearing transcripts that mainly cover roadway signage and highway beautification. They include materials on traffic and informational signs, outdoor advertising, electronic signals, standards for signage, licensing, and permits. There are also materials on junkyards, recycling, disposition of abandoned vehicles, roadside easements, landscaping, environmental issues, and the financing of highway beautification.
