### **Biographical sketch:**

John Tylor Middleton was the Director of the Statewide Air Pollution Research Center, Director of the National Center for Air Pollution Control, Commissioner with the National Air Pollution Control Administration at the Environmental Protection, and Deputy Assistant Administrator for air programs at the Environmental Protection Agency. Beginning in 1970, was also the Director of the World Health Organization's International Reference Center for Air Pollution Control.

### **Scope and content note:**

This collection consists of papers created by John T. Middleton while he served as Director of the National Center for Air Pollution Control; Commissioner, National Air Pollution Administration; and Deputy Assistant Administrator for the U. S. Environmental Protection Agency. The papers contain correspondence, publications, reports, statements, and transcripts including materials from meetings, hearings, conferences and associated background materials. The papers include materials on the causes of pollution; the effects of pollution on wildlife and the environment; the health effects of pollution; as well the prevention, abatement and regulation of pollution.
