Biographical sketch:

Robert Ash Wallace, Jr. was a public administrator, originally from Oklahoma, who served as a special assistant to the Secretary of the Treasury, Assistant Secretary of the Treasury for Economic Affairs, and as an executive at several banks.

Scope and content note:

This collection consists of papers of Robert A. Wallace related to his work as an assistant to Senator Paul H. Douglas, as Staff Director of the U.S. Senate Committee on Banking and Urban Affairs, and as Assistant Secretary of the Treasury. The papers contain correspondence, reports, publications, speeches, newspaper clippings, and press releases focusing mainly on the Treasury Department, however, some items reflect Wallace's work for the Senate, including copies of speeches by Senator Douglas. The State Department materials contain documents on banking, mining, savings bonds, international economics, and legislation. The papers also contain materials on the Treasury Department, its organization, and personnel.
