Biographical sketch:

R. Max Brooks was an architect from Austin, Texas who worked on several prominent government projects including the Federal Building in Austin, Texas and the U.S. Embassy in Mexico City.

Scope and content note:

This collection consists of architectural drawings, correspondence, reports, certificates scrapbooks, newspaper clippings, and publications collected by Austin, Texas architect R. Max Brooks. The "Desk Files" series covers Brooks' professional, political, and social activities and contains materials on Brooks' projects, achievements, and associates. This series contains a large body of materials on the design and construction of the Lyndon B. Johnson Presidential Library and Museum. The "Architectural Files" series contains blueprints of properties in Austin, Texas that were projects that Brooks worked on for Lyndon B. and Lady Bird Johnson.
