Re: Breakthrough

The information hereinafter set forth was secured from records of the Detroit Police Department, Detroit, Michigan, public sources, and sources of the Detroit Division, who have furnished reliable information in the past.

ORIGIN

Records of the Wayne County Clerks Office, City-County Building, Detroit, Michigan, indicated that on April 8, 1963, Mr. Donald Lobsinger, 5918 Drexel, Detroit, Michigan, filed a certificate for doing business under an assumed name. The business name was shown as Breakthrough.

Lieutenant George Rollins, Special Investigations Bureau, Detroit Police Department, on December 1, 1966, advised that prior to using the name of Breakthrough, Donald Lobsinger, the head of Breakthrough, and his associates had used the names of Catholic Layman's League and Protestant Layman's League and that they had on occasions picketed churches in Detroit where they believed that the minister or priest was wittingly or unwittingly espousing the Communist Party (CP) line or were being made the dupes of some Communist front group.

Breakthrough first gained prominence about May 1, 1965, on which date Breakthrough formed a "Victory Over Communism Motorcade" and marched down Detroit's main street, Woodward Avenue, to the Veterans Memorial Building. Two hundred and eight vehicles and four floats made up the motorcade and about 2000 individuals participated. The program at the Veterans Memorial Building consisted of the raising of the American Flag, a short ceremony of parading a coffin draped with a Soviet flag before the speaker's stand and speeches made by Donald Lobsinger, Albert Smith, Medal of Honor winner, and former Wayne State University Professor Stuart R. Crane, who gave a strong anti-Communist speech.

Re: Breakthrough

Lieutenant Rollins stated that Donald Lobsinger and many of his followers were former members of the John Birch Society. Since May of 1965, according to Lieutenant Rollins, Breakthrough has been very active in supporting the stand of the United States Government in Vietnam and are continually active as counter-demonstrators at any demonstration put on by the Detroit Committee to End the War in Vietnam (DCEWV) and make every effort to expose Communist front groups. As a result of the counter-demonstrations put on by Breakthrough, there have been many arrests for disturbing the peace, but there have been no convictions.

PURPOSES

In an article appearing in the "Detroit News", a newspaper published daily at Detroit, Michigan, on November 28, 1965, written by Mr. Allan Blanchard, entitled "He Wants U.S. To Think 'Right'", Donald J. Lobsinger was described as the chairman of a group called Breakthrough. Breakthrough was described as an organization which had risen up as a result of protests against U. S. involvement in Vietnam. Lobsinger described Breakthrough as an action and information group against Communism which haunts and heckles those who, in the organization's view, are "Communist Fronters" or unwittingly fronters of the Communist line. Lobsinger stated that the main effort of Breakthrough is to set the people to thinking right as to who is behind the Vietnam war protests. Main activities of Breakthrough have been heckling, parades and rallies sponsored by the Women for Peace and the DCEWV and meetings of what Breakthrough considers to be Communist front organizations.

On May 26, 1965, an article appeared in the "Daily Student", a publication of the Wayne State University (WSU), which article reported on a speech made by Donald Lobsinger, Chairman of Breakthrough, and Edward Kelley, Director of Breakthrough, in State Hall. Edward Kelley is reported to have stated that the goal of Breakthrough is "The Victory of the American Way of Life over Communism and the International Communist Conspiracy". Donald Lobsinger stated that the goal of Breakthrough is "a contribution to the demise of Communism and a break through the propaganda and the curtain of silence of Communism in this country."

MEMBERSHIP

A letterhead of Breakthrough showing the address of Post Office Box 3061, Detroit, Michigan 48231, carries the following names:

Mr. Lobsinger on September 8, 1966, advised that his organization has approximately 150 members, that they have no physical headquarters and that they are supported by contributions made by members and sympathizers.

BACKGROUND ON DONALD LOBSINGER

An article appearing in the "Detroit News" on November 28, 1965, describes Donald Lobsinger as being 31 years of age and a graduate in Sociology from the University of Detroit. He is employed as a Senior Clerk in the Department of Parks and Recreation, City of Detroit, is unmarried, and lives with his parents at 5918 Drexel Avenue, Detroit, Michigan. Lobsinger became an avowed, active anti-Communist while serving with the United States Army in Germany in the late 1950's. Lobsinger states that he attended as an observer the Communist Youth Festival in Vienna in 1959 and was "impressed at how the Communists were masters of propaganda and at how the Austrian youth resisted it." Lobsinger is a Republican Delegate in Michigan's 14th Congressional District.

ACTIVITIES

Lieutenant George Rollins, Supra, stated that the following are some of the activities engaged in by Breakthrough:

On October 16, 1965, the DCEWV conducted a picket-line demonstration at the draft induction center, Fort Wayne Military Post, 6301 W. Jefferson, Detroit, Michigan. Breakthrough on the same date and at the same location staged a counter-demonstration carrying placards reading "Free Asia" and

"Support Our Boys In Vietnam". Breakthrough had a public address system mounted on a passenger car playing loud patriotic music and comments were made over the address system to heckle the demonstrators of the DCEWV.

On November 12, 1965, Breakthrough staged a protest demonstration in front of the Masonic Temple where a program was being given by the Moscow Philharmonic Orchestra. The protestors claimed that the money being spent by the patrons would benefit the Viet Cong. One of the demonstrators was dressed as a clergyman and four others were wearing uniforms of the four branches of the armed services, they were carrying a coffin draped with an American flag and attempted to gain admittance to the auditorium. Two of the demonstrators were arrested for disturbing the peace.

In early February, 1966, a national figure of the Communist Party appeared at the WSU on a speaking engagement and also appeared at the Central Methodist Church in Detroit, Michigan. Breakthrough demonstrated at both locations, distributing leaflets and described the speaker as "an avowed enemy of this nation totally committed to its destruction and completely loyal to Soviet Russia."

On March 2, 1966, members of Breakthrough picketed in front of the Detroit Bank and Trust Building, West Fort and Washington Boulevard, Detroit, Michigan, in which building the British Consulate is located. The demonstrators protested British trade with the Viet Cong and Cuba.

On March 26, 1966, the DCEWV held a march protesting the war in Vietnam. There were about 700 in the peace demonstration. Marching parallel to them were about 70 members of Breakthrough, marching to support the U. S. involvement in Vietnam. The Breakthrough demonstrators were carrying black balloons and sprays of flowers which they said were signs of mourning of U. S. troops who had died in Vietnam. The two groups became involved in an altercation and three members of Breakthrough were arrested and charged with disturbing the peace.

Re: Breakthrough

On April 30, 1966, Breakthrough conducted a parade to promote victory in Vietnam. Fifty automobiles, six homemade floats and approximately 1000 people took part in this parade. Donald Lobsinger spoke supporting a win policy in Vietnam and others led in the singing of patriotic and folk songs.

On May 6, 1966, Breakthrough demonstrated in front of the Cobo Hall at Detroit, Michigan, protesting the appearance of a national figure of the CP in Detroit. Breakthrough objected to the use of a tax supported building by members of the CP. The demonstrators carried placards such as "Gus Hall Agent of Cancer", "Red Get Out Of Town" and "Victory Over Communism". Six of the demonstrators were arrested and charged with disturbing the peace.

On September 5, 1966, members of Breakthrough conducted a demonstration at Cobo Hall welcoming the presence of President Lyndon B. Johnson. This was a demonstration countering one being put on by members of the DCEWV.

On October 21, 1966, a demonstration was conducted by Breakthrough at the Detroit Institute of Arts, 5200 Woodward Avenue, Detroit, protesting the presence of the Russian Symphony Orchestra. Two arrests were made for disturbing the peace.

Reaction From Vietnam

Marine Tells Americans To "Shake The Lead Out"

First Lt. Ward S. Johnson, a U. S. Marine lieutenant fighting in Vietnam, wrote an angry letter for publication in his hometown newspaper, the *Moline Daily Dispatch*.

The Illinois newspaper published the letter last Friday.

Lieutenant Johnson began his open letter by saying he has "begun to develop a hatred for some of you" anti-war demonstrators.

"I am speaking to those of you who carry idiotic placards denouncing our stand in Vietnam and march in circles that closely resemble your pattern of thinking."

"And I am speaking to you 'intellectuals,' college students and professors, who undermine our efforts with your teach-ins. And I am speaking to those of you who have called the Marines in Vietnam animals, butchers and killers of women and children."

The lieutenant suggested that "you do not offer your remarks about butchers and killers of women and children" directly to a Marine who has returned home from Vietnam.

"I'm sure that he will have a broad grin of satisfaction on his face when he appears in court to answer to charges of assault and battery."

He said a "feeling inside of me has nearly reached the boiling point for another group of you — the ever-increasing group of American youths that practices the art of draft dodging."

Johnson blasted hurry-up marriages to beat draft deadlines, adding, "I'll bet you're real proud of yourselves."

He described conditions in Vietnam as filthy and said the "countryside is teeming with rats every bit as large as our corn-fed Midwest variety."

His platoon "of war babies and high-school drop-outs" fighting in the Chu Lai area since May has been tremendous.

A University of Illinois graduate who enlisted in the Marine Corps, Johnson directed another portion of his letter to "the rest of you Americans" who are only observers of the anti-war demonstrations.

"Will it always take a 'sinking of the Maine,' or a 'Sunday morning attack on Pearl Harbor' to make you pull your heads out of the clouds?"

"Doesn't that group of babbling nitwits that denounces our stand in Vietnam arouse your anger?"

"How in the hell can you permit the voices of a few thousand to be heard above your millions?"

"When are your demonstrations and teach-ins being held?"

"... Have you ever stopped to think that your complacency may render our Nation impotent?"

He closed with "my deepest appreciation and gratitude" for the efforts of Americans who have supported our effort, but "for you others: all I can say is what I would say to my men — shake the lead out and turn to."

"Make yourselves heard."

Let's Win in Vietnam!!

Our PURPOSE for being here today is two-fold.

FIRST, we are concerned about reports from the fighting front in Vietnam that the Demonstrations protesting our armed assistance to the Vietnamese people in their struggle against COMMUNIST AGGRESSION and TERROR are having a demoralizing effect on our troops there. Thus we hope that our activity today will serve as an emphatic illustration to our fighting men overseas - particularly in Vietnam - that they have our full backing, moral support and sincerest appreciation and gratitude for placing their bodies and lives between us and the Communists. We want our boys who are giving of their sweat and their blood in defense of Liberty to know that the "Protest the War" Demonstrations are in no way representative of the sentiments of the vast majority of the American people but rather they are the acts of a misguided vocal minority under the influence and direction in most instances of Leftist and Communist leadership.

Now we wish to make emphatically clear that our support of our fighting men overseas does NOT in any way imply support for our present foreign policy. For to support our PRESENT policy is to support a NO-WIN Policy which mildly rebukes the Enemy with the one hand and seeks to soothe or coddle him with the other. The PRESENT Policy is one which requires American soldiers to fight and die against Communists in Vietnam while at one and the same time we conduct business as usual with the SOVIET UNION even though it is the SOVIET UNION which is spearheading the worldwide propaganda offensive against our assistance to the people of South Vietnam - even though it is the SOVIET UNION which is supplying the weapons and other equipment to the VIET CONG who are killing our American troops.

Thus the SECOND purpose for today's activity. We call upon our Fellow-Americans to demand a WIN POLICY. Anything less is insufficient if Liberty is to be preserved where it still lives and restored where it has been crushed by COMMUNIST CHAINS. Anything less than a WIN POLICY is unworthy of a God-fearing people! Are we no longer the Land of the Free and the Home of the Brave?

Consider the Second World War. It was America's finest hour. We were a united people. Patriotism was the Order of the Day. And God help the man who even breathed pro-Nazi sentiments while our American boys were shedding their blood on the battlefields of Europe and in the jungles of the South Pacific. There was no thought of co-existence or the seeking of normal and friendly relations with the Nazi Gang in Berlin! Can you imagine Hitler being invited to our shores?

Today we are threatened by an International Apparatus, namely, ANTI-GOD WORLD COMMUNISM, which has the blood of over FIFTY MILLION murdered victims on its hands - ANTI-GOD WORLD COMMUNISM which holds many millions more in chains - ANTI-GOD WORLD COMMUNISM which has declared war on those still free. We are in WORLD WAR III right NOW and talk of Co-existence with the AGGRESSOR - ANTI-GOD COMMUNISM - is MORALLY WRONG, DEFEATIST, and UNWORTHY of AMERICANS.

As we fought to WIN against Nazi Tyranny WE MUST fight to WIN against ANTI-GOD COMMUNISM - an ENEMY which by comparison is even more diabolical, more treacherous, more bent on world domination and WORST OF ALL far closer to its goal than Hitler ever was. We therefore demand a WIN POLICY which will be realistic and deal with the ENTIRE International Communist Apparatus as our ENEMY - a WIN POLICY which will recognize ALL COMMUNISM as EVIL - a WIN POLICY which will be directed at the reduction of Communist Power to relative nothingness as was our Policy toward Nazism - a WIN POLICY wherein we will not limit ourselves to a mere defense of Free Territory but rather will embark NOW upon carrying the FIGHT to COMMUNIST-HELD Territory and using every moral means to bring about the overthrow and collapse of COMMUNIST REGIMES - a WIN POLICY aimed at the very HEART of WORLD COMMUNISM and MAJOR SOURCE of Trouble and Conflict, namely, SOVIET RUSSIA.

So long as we delay in declaring and embarking upon such a Policy of TOTAL VICTORY valuable time is being lost and precious lives are being wasted. There can be NO co-existence with the COMMUNIST ENEMY! It is either VICTORY or Defeat. It is time we made the choice for VICTORY. Let's get on with it then - VICTORY OVER ANTI-GOD COMMUNISM the world over and MAY GOD BE WITH US!

Victory in Vietnam Key To Peace

Korean Strategy Repeated In Vietnam

WASHINGTON, D. C. — After a week of intense review of the Vietnam war, President Johnson has disclosed his complete subjection to the political and strategic pressures which paralyzed President Truman in Korea.

He is for war as usual. He will soothe the American people with



prosperity and profits while the lives of their young men are being wasted in protracted warfare. That was the choice President Truman made in

Thomas A. Lane Korea.

He will build up American forces in the theater of operations but will cripple those forces with restriction to a passive defense. The initiative will be surrendered to the enemy, who will take it eagerly to demonstrate to the world the impotence of American power. That was the Truman decision in Korea.

Like President Truman, he will appeal to the United Nations to restrain the Communist aggression, as though to imply that the United Nations shares his responsibility as Commander-in-Chief for the lives of young Americans. As then, the appeal will be futile because the United Nations can do only what the Soviet Union permits it to do.

Like President Truman, he is paralyzed by an entirely fanciful and unrealistic apprehension of World War III. The proposition that the Soviet Union or Communist China could be drawn into war with the United States rather than desist from aggression in South Vietnam deserves the scorn of reasonable men. Yet, this is the proposition which deters President Johnson from winning the war and ending the slaughter in Vietnam.

Like President Truman, he is haunted by the specter of "land war in Asia." But this is a specter conjured up by men who think of land war as indecisive struggle like the Truman war in Korea. Douglas MacArthur, who is reputed to have cautioned against American involvement in a land war on the Asian mainland, wanted to destroy the Chinese Communist armies which attacked our forces in Korea in 1950. When the enemy has attacked you, there can be no alternative to his destruction or withdrawal.

War is war, and concepts of winning in the air, or on the ground, or at sea are illusions to deceive the ill-informed. The best combination of power to achieve quick victory will vary from case to case. The object of strategy must be to employ our forces in the best combination to win early victory and end our losses.

Like President Truman, President Johnson avers that "restraint" in the use of U. S. power serves the cause of peace. He is obviously wrong. He and President Kennedy have exercised "restraint" in Vietnam for four years, and the clear consequence has been the escalation of disaster, increasing casualties, protracted warfare which serves the Communist strategy. The Presidential responsibility is to END WAR, not to prolong it.

In a few months, the President has changed from confident defiance of Communist aggression to plaintive appeal for Communist cooperation. Whoever told him that bravado and a show of force would deter the Communist aggression? The Communist leaders are indeed fearful of American power, but not of men who are afraid to use it.

While they cultivate in American leadership the illusion that Soviet Communism is mellowing, Soviet strategists are in fact pursuing a relentless program of destroying the resistance of the United States. They have imposed upon President Johnson in Vietnam the same strategy of protracted warfare they employed so successfully against President Truman in Korea.

U. S. Commander In Vietnam Urges Blockade

A RECENT report from General William C. Westmoreland, commander of all U. S. forces in Vietnam, recommends that a naval blockade be authorized to cut off the flow of Russian-made weapons into North Vietnam by sea as part of a plan to increase the security of U. S. forces in South Vietnam. The report warns of the North Vietnamese capability to shoot down U. S. planes at high and low altitudes.

The recommendation makes clear that each Soviet weapon that reaches North Vietnam, whether it is an anti-aircraft gun or a sniper's rifle, will be used to kill U. S. or South Vietnamese soldiers.

The Westmoreland report carries a blunt reminder that the denial of these arms to the North Vietnamese at their port of entry will not only save American and South Vietnamese lives but might well turn the tide of battle.

It is hoped that this report, from the top military commander in Vietnam, will help convince President Johnson that the present half-way measures now in effect only prolong the war and increase the toll of U. S. and Vietnamese casualties.

General LeMay Calls For More Effective Bombing Of North Vietnam

GENERAL Curtis E. LeMay, former U. S. Air Force Chief of Staff, says that present U. S. bombing strategy in North Vietnam is all wrong.

General LeMay believes that, despite about one thousand bombing sorties a month, the North Vietnamese "are not getting the message."

"That should be enough to knock the hell out of them," he said in a speech on October 21st. "We must be hitting the wrong targets."

The retired General then advocated U. S. bombing of North Vietnamese industrial targets, ports, power plants "and other resources that they are proud of."

As he sees it, fighting in Vietnam then could be stopped, because "they would realize we are hurting them." The result, he believes, would be fewer casualties on both sides.

General LeMay agreed that it would be wrong to hit population centers in North Vietnam at this stage, and he specifically excluded Hanoi as a recommended target for American bombers.

ON TO VICTORY IN VIETNAM

Finally the President of the United States has given the order to bomb the oil depots in Communist North Vietnam. And the only wailing that is heard comes from that small minority who, cowering in fear, continue to sound the call for Retreat, Appeasement and Surrender. But the vast majority of AMERICANS who still take pride in their heritage as the Land of the Free and the Home of the Brave applaud the President's decision even though recognizing it was a long time in coming. However if Peace is ever to be realized in Asia these raids should be made the beginning of a new strategy aimed at the unconditional surrender of the Aggressor Regime of Communist North Vietnam.

FOR TOO LONG NOW

we have been waging a strictly defensive war in Vietnam. For too long we have spent the lives and blood of our American boys and many more South Vietnamese while restricting the fighting to the free territory of South Vietnam exclusively. For too long we have deluded ourselves by entertaining the idea that we can negotiate Peace with the Communists - an idea which has no basis in reality since the Communists are bent on our destruction and world domination. For too long we have tolerated the existence of the major threat to Peace in all of Asia, namely, the Communist Regime on the mainland of China. And so long as Communism rules China there can be no hope for Peace either in Asia or the world.

The bombing of the fuel depots at Hanoi and Haiphong was carried out with only minor resistance from the Enemy - thus revealing anew a very important reality, namely, that all their threats to the contrary Asian Communism is nothing but a paper tiger which is in absolutely no position to wage a winning war against U. S. military power. Why continue, then, to waste the lives of our American youth by forcing them to fight a needless limited war?

Mere containment of Communist Aggression is NOT Victory - it is stalemate! And by restricting ourselves to the limited objective of bringing a mere halt to Communist Aggression in South Vietnam we will achieve AT VERY BEST only a temporary truce. This truce would last only until such time as the Communists

were prepared to strike again after having further consolidated their power and strengthened their war potential.

VICTORY MUST BE OUR GOAL AND THE TIME IS NOW

Therefore let us, the American people, wake up to reality and use the power we have not only to preserve our own freedom but to restore and extend it to those now enslaved. Let us insist upon a strategy of VICTORY in Asia aimed at the Enemy's unconditional SURRENDER. Let us allow the Government of South Vietnam to carry the war north on an all-out scale for the sole purpose of bringing down the North Viet Communist Regime and restoring unity to their long-suffering people in Freedom. Let us abandon all thought of any coexistence with the oppressive regime of Communist China. Let us take advantage of the hatred that the Chinese People themselves have for this Regime and work to achieve its overthrow and replacement by the Forces of Freedom. In this connection let us give Chiang-kai-shek's forces - which are the best trained in all Asia - the go-ahead and all the assistance necessary to accomplish this objective.

FELLOW-AMERICANS

NOW is the time of Decision while we are strong and the Enemy is weak. WE CAN WIN! All that is needed to Win is the WILL to Win. For the sake of our country and the future of our children we MUST WIN and settle for nothing less. And with the help of God WE WILL WIN.

TO RECORDERS' COURT

(Following are facts about GEORGE CROCKETT'S background which you are not likely to read either in his campaign literature or the daily newspapers.)

1) GEORGE CROCKETT is VICE-PRESIDENT of the NATIONAL LAWYERS GUILD which has been cited as a COMMUNIST-front by two U. S. congressional committees charged with investigating Communist subversion. The U. S. House Comm. on Un-American Activities reported that the GUILD "has gone far afield to oppose the foreign policies of the United States in line with the current line of the Soviet Union."

2) The Communist publication THE WORKER reported that on July 2, 1965 GEORGE CROCKETT was the EMCEE at a fund-raising party for the PRO-VIET CONG Detroit Committee to End the War in Vietnam. Since its formation in early 1965 this COMMITTEE has consistently promoted the COMMUNIST PROPAGANDA LIE that the Viet Cong (the Communists) are liberators and that our boys in Vietnam are both aggressors and murderers. Detroit Comm. to End the War in Vietnam propaganda places all responsibility for the Vietnam War upon the United States and parrots the same demands for ending it as are made by the Viet Cong, North Vietnam, Red China and Soviet Russia. 4) On Dec. 9, 1960 GEORGE CROCKETT was GUEST SPEAKER of the GLOBAL BOOKS FORUM, another pro-COMMUNIST propaganda agency then headed by avowed COMMUNIST Helen Winter. During his speech which was entitled "My Visit to the Soviet Union" CROCKETT described in glowing terms the SOVIET COMMUNIST SYSTEM OF "JUSTICE." Soviet "Justice" has the blood of some twenty million murdered victims on its hands and a record of atrocities, terror, murder and oppression unparalleled in human history.
