Biographical sketch:

James Francis Kelly was a university official and Federal government administrator. He worked for the Public Housing Administration and its predecessor agencies, and the Department of Health, Education, and Welfare (HEW), and served with HEW becoming Deputy Assistant Secretary, and Assistant Secretary and Comptroller. After leaving the Federal government, Kelly served as executive vice president of administrative affairs at Georgetown University, executive vice chancellor at the State University of New York (SUNY), and acting chancellor of SUNY.

Scope and content note:

This collection consists of speeches, reports, and publications collected by James F. Kelly which are related to his work at the Department of Health Education and Welfare (HEW). The papers cover HEW's budget, programs, expenditures, and organization and contain materials on federal insurance programs, education, housing, health care, and cost reductions in government.
