Re: Immigration Bill

Dear Mike:

T enclose a clipping from The Washington Post reporting that Emmanuel Celler will propose amendments to the Immigration Act to correct the alleged injustices.

Recalling the great contribution of your friend, the Honorable Sam J. Ervin, Jr., of North Carolina, to the enactment of the last Bill, I wish to the to your attention the following:

The provision of the present Bill requiring advance clearance through the Department of Labor for jobs to be filled by prospective immigrants is a most burdensome, unworkable and unjust piece of legislation. ITEM: An American family stationed in Greece for a number of years desired to bring to the United States a young Greek girl to look after their children and at the same time have the benefit of talking Greek to the children. The complications encountered were absolutely unimaginable. When the Labor people saw that the attraction was the teaching of Greek, they immediately consulted their books about governesses and tutors and indicated that the terms of employment should provide that this young girl should be paid hundreds of dollars per month. To be brought in as a maid, she was under age and the current salary payable to maids (at the rate of \$3.00 per hour or so) were terms demanded to be inserted under the contract of employment. In addition, any application -- even meeting all standards -- would require weeks and months to clear through the bureaucracy of the Labor Department and from there to the State Department, and back to the Immigration Department.

It is a well-known fact that America suffers from lack of domestic servants. Nobody in the United States wants to be a domestic. Why should there be any restriction on domestic servants since no one here wants to work? The old Immigration Act of 1917 and the previous ones exempted domestic servants from all the restrictions of the Immigration Act. Isn't it about time that we should reinstate those provisions in the Act?

It is the consummate opinion of this writer that the recent changes of the Act, which come into full operation in July, 1968, will be greatly thwarted if the labor provisions are not repealed.

Mr. President:

I understand that Congressman Celler may want to talk to you about the New York Judgeships, among other things.

The FBI and ABA investigations on both Travia and Judd have been completed. The nomination papers will be over here from Justice very shortly.

Ramsey points out that the New York Times has criticized the Travia appointment as being soley political. He said that unless the President thinks this appointment is a plus, he might not want to go ahead and make it at this time.

However, Warren Christopher notes that the FBI report and the ABA report show Travia to be far better qualified than people give him credit for. In addition, Warren says that Albert Jenner, the head of the ABA Committee volunteered to call the New York Times and tell the Times this.

Ramsey also notes that Congressman John Rooney has indicated disapproval of the Judd appointment on the grounds that he is a Republican. Rooney says that things seem to be going better in Brooklyn and that this will be harmful. At the very minimum, Ramsey hopes he can have his notice to call Rooney before the appointment is announced since Rooney heads up his appropriation sub-committee.

I have been after the Speaker and Carl all week to set this Bill if House Judiciary reported it. After House Judiciary reported it, I asked Celler to obtain -- and he did obtain -- permission to file the report over the weekend so that the Bill would be ripe for Rules Committee in its Tuesday meeting.

We are now getting calls about the Brooklyn Shipyard from Congressman Celler and Mayor Lindsay's office here in Washington. As you probably know, the property has already been declared excess, and GSA has had since June the final package reflecting the terms and conditions of the sale, which becomes final if the Congressional Committee does not act within 30 days.

Thus far, GSA has maintained the position that the matter is under study and that there has been a delay because the deal is complicated and somewhat unprecedented.

After three months, the GSA answer is becoming very difficult to maintain. At this point, the delay for the purpose of studying it is unreasonable, and both Congressman Celler and Mayor Lindsay's people know it.

If we are going to put off the sale any further, I would recommend that we get GSA (Joe Moody) to raise some objections to the terms and conditions of the sale so that negotiations can be reopened. While this would cause some problems with the New Yorkers, we have the legal right to reopen the negotiations. Throughout the previous negotiations, GSA made it clear that they could not commit the Government and that the final decision would have to be made by higher authority and then cleared through the Congress. In addition, Joe Moody feels that we can make a very legitimate argument that the deal is not as satisfactory from the Government's point of view as it should be, particularly in terms of the lease agreement which the City recently negotiated with the redevelopment group in New York.

It would also be possible to lease the property now so that New York can proceed with redevelopment, and then renegotiate the terms and conditions of the ultimate sale of the property. This course of action would, of course, commit the Government to the ultimate sale of the property.

Dear Mr. Chairman:

Your recent letter to President Johnson concerning the regional organization of the Bureau of Federal Credit Unions has been referred to me for reply.

Since this reorganization plan involves more than New York, enclosed for your information is a copy of the letter of explanation which was sent to all Federal credit unions on November 26, 1968.

This action was taken to reduce costs and to improve the administration of the Federal Credit Union Program. This is especially important since this program does not receive appropriated funds and is financed through the fees assessed against the Federal credit unions. Accordingly the Federal credit unions in New York will be the beneficiaries of the cost reduction and administrative improvements realized.

The level of services which the Eureau provides Federal credit unions will not be affected. The number and location of the field examiners who have the direct contact with the credit unions in New York remains unchanged. To our knowledge only two employees of the New York office will be moved as a result of this consolidation.

I am also enclosing copy of a telegram from Bill Richards, President of the rational Association of Federal Credit Unions, saying that as far as that association is aware the reorganization has not met any complaint.
