

Dear Congressman:

When Larry O'Brien received your letter of January 9 enclosing a resolution of the Cotillion Club of Detroit, Michigan, with regard to the Hill-Burton Hospital Construction Program, he referred it to me. I asked the Department of Health, Education, and Welfare to comment and have just received their views.

As you know, this Administration has been closely involved with the case of Simkins vs. Moses H. Cone Memorial Hospital, and in fact, the United States is a plaintiff intervenor in the case. We are, of course, fully aware of its possible implications for the Hill-Burton Program and have followed the matter closely.

The defendants have filed a petition for writ of certiorari with the Supreme Court. For this reason, no final policy actions have been taken based upon the decision of the Court of Appeals. However, the Secretary of Health, Education, and Welfare has directed the Public Health Service not to process applications for assistance under the so-called "separate but equal" provisions of the Hill-Burton Act, on the assumption that the provision is unconstitutional until the Supreme Court's decision is available.

This Administration will continue to do whatever it can within its authority to assure that Hill-Burton aided hospitals are available without regard to race, creed or color.



Larry O'Brien has relayed to me your letter of June 17 reiterating your deep interest in the work of the President's Committee on Equal Opportunity in the Armed Forces.



FBI Agents at Philadelphia, on charges of depriving local Negro citizens of rights guaranteed them while acting under color of law; and

Eleven men have been arrested in the McComb, Mississippi, area in connection with a series of bombings of Negro homes. These arrests led to the seizure of a large quantity of explosives-type material, including dynamite, hand grenades, fire bombs, gunpowder, and bombs constructed of metal pipe and gunpowder, as well as two boxes of rifle ammunition.

The President met personally with members of the families of the three civil rights workers who were killed near Philadelphia last summer, and with three McComb women whose homes had been bombed. Additionally, he has instructed the Department of Justice to take immediate action in all civil rights matters, including voter registration cases, which are within the purview of the Federal Government.

Obviously the situation warrants continued close attention, and the specific recommendations contained in your letter have been brought to the attention of the Justice Department, the Civil Rights Commission, and the Community Relations Service for evaluation and appropriate action.

Your own deep personal interest in the matter is fully appreciated.

Dear Congressman:

The President has read with deep interest the letter in which you were joined by a number of other Congressmen in furnishing specific observations and suggestions with regard to action that the Federal Government might take in connection with the recent series of bombings in Mississippi.

I am sure you are aware of the continuing concern which the President has shown toward acts of terrorism and violence anywhere in the United States. Early last July, at the direction of the President, 50 additional FBI Agents were sent to Mississippi; and on July 10th, Director J. Edgar Hoover personally arrived in the capital city of Jackson to confer with state and local officials and to open a new FBI field office there.

The FBI and the Civil Rights Division of the Department of Justice have given thorough, prompt attention to all civil rights matters involving possible violations of Federal laws in Mississippi, as in all other states. The President has personally remained abreast of all major developments in these cases, and he has noted with great interest the progress which has been made. For example since July, 1964:

A formidable roadblock in the investigation of the disappearance of the three civil rights workers was overcome when FBI Agents succeeded in locating the bodies of the three men near Philadelphia, Mississippi;

Three residents of Greenwood, Mississippi, have been arrested by the FBI on charges of conspiring to violate the Civil Rights Act of 1964 by allegedly beating a Negro who had attended a local theater;

Four local and county officers and a former Sheriff of Neshoba County have been indicted by the Federal Grand Jury at Biloxi, Mississippi, and placed under arrest by

Dear Congressman:

The President has asked me to reply to the telegram urging legislation to ensure the voting rights of all citizens which you and the other Congressmen who recently visited Selma, Alabama sent to him.

As you know, the President has made it abundantly clear in his State of the Union Address, in his Inaugural Address, and in his televised statement to the Nation last week that he believes additional steps must be taken to assure the right to register and vote to all American citizens. The Justice Department is currently considering the subject in detail and is examining the entire range of specific proposals in this field in order to recommend to the President the course of action most likely to achieve the goal of universal suffrage.

It would appear therefore that the most effective procedure would be for those people in the Justice Department who are working on this matter to meet with you and those who joined with you in the telegram. In addition, the Vice President, because of his role in connection with last year's Civil Rights Bill and his assignment as coordinator of the Government's civil rights programs, will be involved in the preparation of any Administration proposals. The President has suggested therefore that I try to arrange for the Vice President, the Attorney General and myself to meet with you and your colleagues at the earliest opportunity.

We shall be in touch with you shortly to work out the necessary arrangements and look forward to meeting with you.



This is in reply to your letter of 1 July 1965 stating that my reply to your inquiry concerning the Clampitt-Locklear incident was entirely unsatisfactory and invited further comments on the incident.

The Commanding Officer, Naval Air Station, Alameda, appointed an officer of his command to conduct an informal investigation into the circumstances of the incident to determine if action under the Uniform Code of Military Justice was indicated. The investigation included interviews with such witnesses as could be identified, including the teller at the Credit Union window, and obtaining written statements from the two principals. After a thorough review of the investigative report, the Commanding Officer considered that formal charges against either Petty Officer Clampitt or Miss Locklear were not warranted. Petty Officer Clampitt was given a private reprimand and the case was dismissed at Executive Officer's Investigation. Petty Officer Clampitt's actions in this incident may be reflected in the marks assigned on her next performance evaluation report. This periodic evaluation is a permanent part of each individual's service record.

The Chief of Naval Personnel considers that the action taken by the Commanding Officer, Naval Air Station, Alameda, was adequate in consonance with the facts of the case. No further action against Petty Officer Clampitt or Miss Locklear is considered necessary or warranted.

Gentlemen:

On June 5, Attorney Henry Arrington of Miami, Florida, addressed a communication to the President relative to the Legal Services of that community. His central complaint is that the neighborhood Legal Services in Miami is not utilizing a means test within the guidelines established by your agency. As a result, many people are obtaining such services who can afford to hire a private practitioner. If this is true, of course, it is in violation of your regulations and demands immediate corrective action.

In addition, it has been observed that Negro staff people employed by the agency in Miami are all holding lower echelon positions which has made some people suspicious about an equal opportunity policy. Moreover, all of the investigators that are used by the agency there are drawn from the student body of the University of Miami Law School. The employment results are obvious, since there are no Negroes in the school. There are Negroes who can meet the requirements of these investigative positions.

I am therefore requesting a prompt review of these practices, a report of your findings and adjustments will be expected.



This is about the statement by Congressman Diggs, Charles C. Diggs, that a telephone call from him resulted in the President ordering in Federal troops Monday night.

About 9:30 p.m. in a conference call the President asked me to call all the Wayne County Congressmen. I had the operators go to work on all of them. Diggs was not reached until shortly after 11: p.m.

When the operators located Diggs it was after you had told me that the troops were going to be ordered in about 11:30 p.m. I did not tell Diggs this, of course. My message to him was that that the 9:30 decision not to send troops was based on the advice and recommendations of many people, that it was constantly being reviewed and was open to change.

Diggs raised hell over the phone for about ten minutes about the failure to bring in the troops. He said that the blood was on the Administration's hands, that the Administration was playing politics with the situation, and so on. I got a little hot at him about some of this and I think that helped tone him down.

When you called me at 11:30 p.m. to say that it was okay to say that the troops had been ordered in, I replaced calls to call the Wayne County Congressmen. I reached Diggs and all the others fairly rapidly before the President's telecast. I told him that the constant review which I had mentioned to him in my earlier conversation had resulted in orders for the Federal troops to move in.

Thank you for your letter of November 20th, 1967, inquiring if any of the low-rent housing projects under review by the \$1 billion insurance consortium are in the Detroit area.

I have checked with the Federal Housing Administration, which is handling detailed negotiations with the insurance companies and their local outlets. No multi-family rent-supplement housing projects that meet the criteria of the insurance consortium are in the Detroit area. I am advised, however, that FHA will soon be discussing individual family mortgages in blighted, inner-city areas with the insurance industry. Of a total of approximately 4,000 such mortgages now insured by FHA, 1,096 are in the innercity, blighted parts of the metropolitan Detroit area. We do not now know whether the insurance consortium will finance individual family homes, but the insurance people have shown a willingness to review FHA's holdings in this category.





Dear Congressman:

This is in reply to your note of May 7, regarding Mr. Simon G. Hakim.

I received a similar request on behalf of Mr. Hakim from Congressman Nedzi a few days ago. My investigations at that time showed:

First, that we do not have here at the White House any record of correspondence between Mr. Hakim and President Kennedy.

Second, Mr. Hakim did write to President Johnson on the subject of a goodwill mission in 1964--and received a reply from Larry O'Brien, thanking him for his interest and stating that his offer would be borne in mind. There was no letter--or promise of a goodwill mission assignment--from the President. (filed Name file)

Third, the government has no plans for such a mission at this time.

In view of these facts, I would suggest a reply to Mr. Hakim along the following lines:

"Our government welcomes the efforts of any private American to develop goodwill for the United States in the Middle East. It does not, however, contemplate any official goodwill mission at this time. It appreciates Mr. Hakim's interest."




