





I received a telephone call from Congressman *Jones* Roosevelt with reference to President Johnson's trip to meet President Mateos in Palm Springs, California, the third week of February.

Congressman Roosevelt thought that perhaps the Mexican-U.S. Narcotic Commission question might come up during that time and also, there might be inquiries from the press at that meeting regarding the narcotic and drug problem in California and the recommendations of the President's Commission on Narcotic and Drug Abuse. Roosevelt pointed out that if Stanley Mosk is going to be included in any way in those discussions, he himself (Roosevelt) would like also to be included or present.

Mosk's office called yesterday and said that they wanted to know if this was going to come up and also said they would be sending letters to Assistant Secretary Thomas Mann and others at the White House, recommending that this be included in the topics for discussion.







Dear Stanley:

M. MOSK
Your son, Richard, has been of considerable service to the Warren Commission, his supervisor tells me, and I am glad he could arrange to delay temporarily his training as a member of the California Air National Guard and as a Reserve of the Air Force in order that he might accept this employment.

I recognize that to make up the training he has missed, and to continue with the required Air National Guard training might seem confining. This has been discussed with the Department of the Air Force and I am informed that an exceptionally high percentage of nonprior servicemen who enlist in the Air National Guard are practicing attorneys or other professional men who have chosen to fulfill their military service obligation in this way. It is only fair that all be expected to complete the training required on an equal basis, and to anticipate that some sacrifice will be required of them.

I have been advised that, based on his request, supported by his supervisor in the Warren Commission, your son will be allowed to delay his training until August 1, 1964, when it is understood his work for the Commission will be completed. He should arrange immediately with his Air National Guard unit commander to make up the training which he was scheduled to complete during the months of March through July 1964. His future service as a member of the California Air National Guard is a matter he must resolve with the State in view of the commitments he made when he enlisted in September 1963.





MEMORANDUM

TO: The President

FROM: The Vice President H.H.

In the event that you have not had this brought to your attention, I wanted you to know of the interest of California Supreme Court Justice Stanley Mosk in the forthcoming appointment to the Supreme Court.

Here is a paragraph from a confidential memorandum which he sent to me indicating his position:

"President Johnson's last appointment was Abe Fortas, directly from private practice to the highest court in the land. His next appointment should come from the Supreme Court of one of the states. And, as indicated in my report, California desperately needs this recognition. In addition, the Supreme Court, to be properly balanced, needs one with experience in and concern for the problems of crime and law enforcement. This I have had in six years as Attorney General of California before going on the state high court. My opinions on the state court do, I believe, indicate respect for our individual constitutional guarantees, but a belief that they can be adapted to a society in which crime is a genuine problem. My attitudes in that regard are somewhat comparable to those of retiring Justice Tom Clark, for whom I have the highest regard."

I am not presuming to urge Mosk's appointment, but I did want you to know of his interest.


