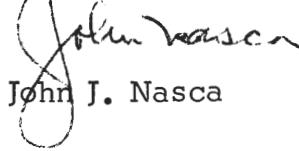

Mr. President:

X's are those we had FBI checks done on.

The 4 *'s on the ten o'clock list mark the late arriving DNC names which sadly and mistakenly were never run through the Usual FBI check. This is my fault.

As you probably know, Cliff took steps to see that Fago would not appear last night. His name was removed from the Police gate list. The policeman double checks the guest's admit card with the gate list. Since Fago arrived with admit card, but without his name appearing on the gate list, the usual procedure would be to ask him to wait while the officer checked with me or someone on the Social Staff. He could not locate me right away, and as Fago's card was in order, and in an effort not to embarrass a guest, the officer admitted them.

They came about 10:10, went upstairs, were met by another ten o'clock guest, Harper Sibley of Rochester, who, being aware of the situation, talked with him a very few minutes, walked downstairs, stayed with Fago while he got his coat and ushered him out.
