The subject "Health" is used for material pertaining to health, including the prevention and control of disease; hospital operation; research in biology and medicine; conduct of medical and hospital programs; sanitation; nutrition; Federal health programs; national and international health problems; blood donations; and vital statistics.

Correspondence, memoranda, reports, news articles, lists, and many cross references. The classification includes many topics pertaining to health, particularly health legislation; national and international health problems; national and international health programs; physical fitness; health organizations and committees, such as the White House Conference on Health and the National Commission on Community Health Services; health manpower needs; bill signings; blood donations; and professional medical and dental groups and associations. There are many cross references to other file classifications, especially to "Messages," "Speeches," and "Legislation." In addition to the items mentioned above, the general file contains a small amount of correspondence from the public about personal health problems.

HE 1 DISEASES.

Processed. Boxes 6-10

Correspondence, memoranda, publications, reports, and many cross references to statements and to correspondence with groups associated with a particular disease. Subjects include immunization; cigarette labeling; hiring the physically handicapped; research; and a variety of health problems and diseases, including heart disease, stroke, cancer, polio, alcoholism, handicaps, and deafness. In addition, the general file also contains correspondence from the general public about personal health problems and public opinion mail on drugs banned for interstate shipment.

HE 1-1 MENTAL DISORDERS.

Processed. Boxes 10-13

Correspondence, memoranda, publications, reports, minutes, and press releases pertaining to mental retardation and mental illness. The papers contain many memoranda titled "Mental Retardation Progress Report." These detail the Department of Health Education and Welfare's activities in the field of mental retardation and include many publications as attachments. The progress reports are addressed to Mrs. Sargent Shriver, Consultant to the President's Panel on Mental Retardation, or the Secretary of HEW. Many of the documents pertain to associations, committees, commissions, and panels on mental retardation and mental illness.

The file also contains cross references and a few documents relating to the Child Nutrition Act, Food for Peace, and Food Stamps.

HE 3 HEALTH SERVICES

The few original letters and memoranda in the executive file pertain to health care facilities, services for the poor, and school health problems. "Executive HE 3" is almost entirely made up of cross references to "Legislation" and other categories of "Health." The correspondence and memoranda in the general file pertain to public welfare agencies, physicians involved in volunteer health services, and health care proposals.

HE 4-1 NARCOTICS

Correspondence, memoranda, clippings, statements, and reports pertaining to narcotic traffic, drug addiction, treatment of addicts, discussions with the Mexican government about drug traffic, the Bureau of Narcotics, the Advisory Committee on Narcotics and Drug Abuse, and the Bureau of Drug Abuse Control.

HE 5 HOSPITALS – MEDICAL CARE

Correspondence, memoranda, publications, and reports pertaining to hospitals, clinics, nursing homes, and health units. Subjects covered under the classification include Public Health Service hospitals, hospitals in the Washington, D.C. area, regional medical programs, and modernization and enlargement of medical facilities.

HE 6 RADIOLOGICAL HEALTH

Correspondence, memoranda, and reports pertaining to hazardous radiation legislation, protection from radiation and from fallout, radioactivity in food, research, and radiation safety and health standards for Federal supply contracts.
