HIGHWAYS - BRIDGES

(HI)

The material in this category focuses on Federal involvement in programs, problems and proposals for this country's highways and bridges primarily and, to a lesser degree, streets, parkways, tunnels, over and underpasses, sidewalks, routes and markers. It reflects Administration position and official and public reaction to programs including Interstate Highways, Inter-American Highways, Highway Beautification, Scenic Roads and Parkways, Federal Aid to Highways and covers many related and additional issues.

This classification is not all-inclusive. Other material of possible interest on these subjects may be found in Federal Aid to Highways (FA 3), Military Highways (ND 11), Safety (SA 2) and Transportation (TN).

Memoranda, letters, publications, press releases, maps and articles pertaining to Interstate Highways throughout the United States and to some Inter-American Highway programs, such as the Pan American Highway. Material touches on highway construction, deferral and funding, the National System of Trails and the Appalachian Highway System and includes some Presidential correspondence with several Governors of involved states. Cross referenced material covers broad categories as well as invitations to highway dedications and special Presidential messages.

HI 1 Bridges - Overpasses - Tunnels - Underpasses

Material reflecting Administration involvement and official and public interest in plans, programs and problems relating mainly to bridges. Memoranda, letters, resolutions, map and brochures relating to bridges throughout the country with emphasis on reaction to the Silver Bridge Tragedy and the Three Sisters and Potomac Bridge Proposals. Considerable cross referenced material, including response to bridge dedication invitations and related special Presidential messages.

HI 2 Highways - Parkways - Turnpikes - Expressways - Freeways - Streets

Letters, memoranda, publications and much cross referenced material covering the routing and rerouting, safety, costs and cutbacks, and improvement of highways, the Federal Interstate Highway System, Congressional pro and con on the Highway Bill, Federal Aid Highways Act, National Program for Scenic Roads and Parkways, bill signing ceremony guest lists and special messages, and references to the Safe Streets Act.

Washington, D. C. freeway and related projects and problems reflected through letters, memoranda, resolutions, publications and cross referenced material including the D. C. Freeway, the Arthur D. Little Report, the D. C. Subway, the balanced transportation system, the construction of L'Enfant Plaza, street lights and conditions, D. C. Rapid Transit Bill, the Red Cross-E Street Expressway, Rock Creek Unit #3, the North Central Freeway and the National Capital Transportation Act and Agency.

The highway beautification programs, its support, opposition, features, passage and bill signing detailed through letters, articles, resolutions and publications. Related press releases and plans for meetings and reaction to proposed regulations of the Department of Transportation on highway procedures, to Appalachian Trail Plans and the Federal Aid Highways Act. Cross referenced material includes invitations, letter copies and memoranda to President from his aides and many on individual Congressional support of the beautification bill.
