Among these functions are the use of military aircraft; civil defense; communications; mobilization of manpower and resources; military medical facilities; intelligence and subversive activities control; personnel, including casualties, conscription, courts martial, pay promotions and demotions; preparedness; installations; reserves and National Guard; security; service schools; wars; warfare; and weapons. 159 feet, 4-1/2 inches.

NATIONAL SECURITY - DEFENSE

This subject contains documents pertaining to presidential candidate briefings; military policy making; Congressional report on the "Administration of National Security: The Secretary of State"; A Goldwater to Zuckert letter on Army aviation (Howze Report); the Multilateral Force (MLF); the MLF and Congress; Cong. Hollifield correspondence on the MLF; Senators Clark, McGovern, et al., on the MLF; Senator Humphrey on the film Fail Safe; William Scrantom briefing; background for actions relating to Korea; William S. NON-MILITARY USE OF AIRCRAFT

Contains materials concerning controversies over control of stockpile disposal between the Office of Emergency Planning and GSA; the sale of copper stockpile excesses on the market; utilization of surplus titanium sponge; reports on strategic and critical material stockpiles; NSC review of strategic stockpile objectives and post-nuclear attack planning; report on steps OEP taking to develop stockpile objectives for nuclear war and reconstruction; Comptroller General report to Congress on the unnecessary cost incurred by Government in not using surplus stockpiled materials to satisfy defense contract needs. Also, documents

HEALTH - MEDICAL

This subject has material concerned with a unified Armed Services Department of Medicine; the Bergstrom AFB hospital; the Corpus Christi Naval Air Station Hospital; the Brooke Army Medical Facility; a "Listing of Uniformed Services Medical Facilities in the United States"; President Johnson's suite at Bethesda Naval Hospital; plans for additions to Bethesda; and a comparison of Bethesda and Walter Reed to civilian hospital staffing. The General file consists primarily of correspondence dealing with such subjects as malaria in Vietnam; the hospital in Seoul; unification of military health services; and

miscellaneous patients and their families. Other subjects include televisions at Walter Reed; other conditions at Walter Reed; Chiropractors in the military; Senator Hayden on medical records; and nurses. 2" (10 items restricted).

ND 7

INTELLIGENCE

This category has many cross referenced materials related to the USS Pueblo incident. There are also records of CIA monthly reports to the President on Congressional briefings; Cuban flights; the "War Safety Control Report"; Yuri Nosenko; and a cross reference to Stokely Carmichael. 3/8" (1 item restricted).

ND 7-1

SABOTAGE - ESPIONAGE

Contains material on laws and statutes concerning espionage and sabotage; requests that action be taken against espionage and sabotage; and material on a Mr. Goleniewski. -1/4" (1 item restricted).

ND 7-2

SUBVERSIVE ACTIVITIES CONTROL

Consists of documents related to the International Nickel Company; an article on coffeehouses at military installations; the "Subversive Activities Control Act" (1964, 1965, 1966, 1967); the Subversive Activities Control Board; and correspondence with Norman Thomas. 1" (3 items restricted).

MILITARY GOVERNMENT

There is no material in this category.

MILITARY PERSONNEL

This subject contains material concerning military personnel at the White House; the repatriation of Korean War prisoners; procedures relative to a "General Order"; chaplains; Mormon chaplains; Navy stewards for Mrs. John F. Kennedy; military manpower waste and misuse; the role of Vietnam veterans as speechmakers; meningitis outbreaks; a James U. Cross memo on manpower savings in the military at the White House; Secretary McNamara on lower acceptance standards and the STEP Program; a Leatherneck article "Ambassadors in Green"; and the moment of silence at the 1966 World Series. Also, correspondence and memoranda on families with five sons in the armed services; Executive Orders 11284, 11333, and 11436 on retirement of Brig. Generals and Rear Admirals; material on returning veterans and retired veterans; "Project Thank You"; discussion of Thailand

as a combat zone for income tax purposes; Col. Haywood R. Smith thank you letters to commanding officers of military groups for assistance to the White House (e.g. Andrews AFB, Camp David); thank you letters from the President; Central Texas State College transition program; cross references to the daily Military Task Force Strength Reports (HU 2/FG 216). The General file of this category consists primarily of correspondence from the public. Topics of special interest include the post exchange system and sales to military clubs; complaints about pay scales; Texas absentee voting for the military (1966). 15" (11 items restricted).

ND 9/A-Z

MILITARY PERSONNEL

This category is an alphabetical file concerned with personnel matters on an individual basis. Noteworthy persons include Admiral Rickover and General Westmoreland. 12" (3" restricted).

(Note: Description and amounts of material above refer only to the Executive file. The General portion of ND 9/A-Z (11 feet, 3 inches) has not been reviewed. It is highly personal in nature and would have a high restricted rate and low relevance to historical scholarship.)

CASUALTIES

Material dealing with the fire aboard the U.S.S. Enterprise; Operation Thank You; the wounded; prisoners of war; the President visiting the wounded; Hugh O'Brian photos of wounded at hospitals in Vietnam; correspondence and memoranda concerning procedures for notification of next of kin; correspondence concerning individual casualties, especially from friends and relatives of casualties; inquiries concerning sole surviving son regulations; material discussing the lowering of the flag to half-mast in honor of the servicemen killed in Vietnam. 3-3/4" (6 items restricted).

CASUALTIES

Alphabetical file of correspondence concerning individual casualties and deaths. There is some material on General MacArthur's death. The General file contains noteworthy correspondence from families of casualties, much of it critical of the war and/or the notification of next of kin process. File includes documents dealing with procedural arrangements for notification of next of kin and identifying next of kin for Presidential letter; casualty incidence reports; Presidential Memorial Certificates; and material concerning the Forrestal fire. The General file is primarily responses to Presidential condolence letters and thank you letters for Presidential Memorial Certificates. 1½".

CONDUCT - DEPORTMENT - BEHAVIOR

Documents in this file deal with questions and complaints concerning military conduct, in general and specific individuals. 9 items (2 items restricted).

ND 9-4

CONSCRIPTION - INDUCTION - DRAFT - UNIVERSAL MILITARY TRAINING

This subject consists of documents concerned with "One Third of a Nation", a Department of Labor report on men unqualified for the draft; Executive Order 11188, "Amending the Selective Service Regulations"; E.O. 11241, pertaining to married men; E.O. 11266, pertaining to fathers; the Selective Service Rejectee Program; selective service policy; the Task Force on Manpower Conservation; the deferment problem; the drafting of doctors and dentists; lowering qualifying standards; the Special Training and Enlistment Program (STEP); a Lewis B. Hershey to Horace Busby memo with a complete update of Selective Service plans and procedures (9/24/65); the controversy over the reclassification to I-A of the Michigan draft board sit-ins; the President's Commission to Study the Draft (The National Advisory Commission on the Selective Service); E.O. 11325, permitting those imprisoned for draft violations to serve; E.O. 11350 and E.O. 11360 and the Selective Service Act Extension. Also, material on the FAIR Plan; Lewis B. Hershey correspondence and memoranda including Hershey letter on the drafting of disrupters; correspondence from university presidents; Hershey-McNamara-Schultze Task

Force; junior college deferments; Hershey-Ramsey Clark controversy over protesters and illegal activities; National Security Council recommendations on occupational deferments; E.O. 11391; the Hershey-Rep. Moss correspondence; Project 100,000 (1968); the Selective Service Semi-Annual Report; and material on the graduate student problem. The Executive file also contains considerable correspondence expressing pro/con reactions to the draft, aspects of the draft, or specific cases, such as Mickey Mantle and George Hamilton. The General file is primarily correspondence. Subjects include the drafting of married men, students, graduate students, and junior college students. There is also material on individual cases; the reclassification of protesters; draft card burning; training for rejectees; the National Advisory Commission on Selective Service; and on Joe Namath. 2'3/4" (1/2" restricted).

DEFERMENT AND EXEMPTION

File includes the 1968 National Security Council directive on occupational deferments. General material is primarily correspondence regarding individual cases, mostly referrals. 6-3/4" (9 items restricted).

Alphabetical file of individual cases and appeals. Category consists primarily of General file material with many referrals. 7" (9 items restricted).
