RA 1 ACQUISITION – REQUIREMENTS

Material concerned with the acquisition and disposal of land owned by the federal government; establishment of uniform compensation and assistance provisions for displacement in Federal programs; implementation of PL 89-249 which established concession policies for the National Park Service; Executive Orders #11178 and 11237. [Filed EX RA 1 11/25/67 is a report to the President entitled "Concessions on Federal Lands Ivail able for Public Recreation], 10-1/2"

RA 2 BUILDINGS – PLAN MANAGEMENT

Processed. Boxes 4-8

Material pertaining to the construction and destruction of Federal buildings and post offices including requests for use, re-location, maintenance, and restoration of Federal buildings, as well as suggestions for buildings to be taken over by the government (such as a residence for the Vice President).
