Biographical sketch:

Ben S. Stephansky was an economist and Foreign Service officer who served as labor advisor to the Bureau of Economic affairs in the State Department, labor attaché to Mexico, ambassador to Bolivia, Deputy Secretary of State for Inter-American Affairs, Executive Secretary of the United States – Puerto Rico Commission on the Status of Puerto Rico, and United States Representative to the Organization of American States.

Scope and content note:

This collection consists of correspondence, reports, speeches, and publications collected by Ben Stephansky that are related to his service as a Foreign Service officer and Executive Director of the U.S.-Puerto Rico Commission on the Status of Puerto Rico. The papers contain materials on issues related to Puerto Rico including political status, economy, education, healthcare, employment, finances, and strategic importance. The papers also contain materials on international relations with Latin America and between Latin American nations, human rights, foreign aid, and economic development.
