Creator: Warnke, Paul C. (Paul Culliton), 1920-2001

Biographical sketch:

Paul Culliton Warnke was a lawyer who served as general counsel at the Department of Defense, Assistant Secretary of Defense for International Security Affairs, director of the U.S. Arms Control and Disarmament Agency, and was chief U.S. arms control negotiator. He was a member of the Presidential Advisory Board on Arms Proliferation Policy, as well as the Arms Control and Nonproliferation Advisory Board at the State Department.

Scope and content note:

This collection consists of reports, correspondence, notes, and speeches collected by Assistant Secretary of Defense for International Security Affairs Paul C Warnke, much of which originally belonged to his predecessor John T. McNaughton. The papers cover issues related to the Vietnam War including objectives, operations, planning, strategy, bombing programs, negotiations, rules of engagement, troop dispositions, consequences of various actions, and the political situations in North and South Vietnam.
